ONLINE ENROLLMENT

Indiana 4-H enrollment is now open through January 15, 2015. 4-H is a premier source of enjoyable, educational programs to

help young people reach their full potential. Plus, new for 2015, enrollment is easier than ever with the 4-H Online system, <https://in.4honline.com>.

Indiana 4-H is the state's largest youth development program for grades 3-12, reaching over 200,000 youth in all 92 counties. 4-H Youth Development Educators in each Purdue Extension county office coordinate local activities.

In Grant County, approved adult volunteers teach young people specific skills related to a wide variety of subjects through hands-on, experiential learning. Subjects include: science, technology, engineering, and math (STEM); agriculture; citizenship; healthy living; art; consumer and family sciences; and more. In 2013, a Tufts University study showed that 4-H members also excel in positive youth development areas compared to peers, including:

- * Four times more likely to contribute to their communities (grades 7-12)

- * Two times more likely to make healthier choices (grade 7)

- * Two times more likely to be civically active (grades 8-12)

- * Two times more likely to participate in extracurricular STEM programs (grades 10-12)

Now the new 4-H Online system makes it even more convenient to offer enrollment, event registration, calendars, and secure payment online.

Youth may be enrolled in 4-H by January 15, 2015 online at <https://in.4honline.com> or by visiting their County Purdue Extension Office. The \$20 fee per child includes all Indiana 4-H program fees.

SAFEPLACE THANKS

November is National Runaway Prevention Awareness Month. Each year, hundreds of youth are find themselves as runaways or throw-aways.

In Huntington County, our young people have access to immediate assistance and support if they are a runaway and/or throw-away through the Safe Place/ Host Home program offered by the agency.

However, we would not be able to offer this program without the fantastic Host Home families and Safe Place sites. The agency utilizes 47 businesses throughout Huntington County as Safe Place sites. They serve as the point on entry into services for youth in crisis. These sites provide youth with a safe place to be until trained staff can arrive to provide more comprehensive support. When the young person cannot return to their home, they are provided services through the Host Home portion of the program. Huntington is blessed to have six families that open their homes to young people during difficult times.

The Youth Services Bureau's Safe Place/Host Home program provides a comprehensive community outreach to youth. The primary goal to provide young people with the support and tools needed to help reduce the likelihood of becoming a runaway, finding themselves homeless, reduce acts of delinquency and to help provide immediate support to youth if they are contemplating suicide.

The number of youth utilizing this program continues to increase each year. The increase in the number of youth seeking assistance through this program shows the youth are aware of the program which is a positive factor. However, the complexity of need these young people are experiences is often time, overwhelming for the youth. Due to the increased number of youth being served, the need to increase the number of trained Host Homes has also increased.

Without the caring Host Home families and Safe Place sites, Huntington County's young people would find themselves without needed resources as they maneuver through adolescence. When you visit a business that displays the Safe Place sign, take a minute to thank them for being there for Huntington's young people. If you know a family that serves as a Host Home, thank them for opening their homes to youth in crisis.

I know the statement, "It takes a village to raise a child," is often used, however, when youth find themselves overwhelmed with life and running away or even suicide appears to be the only answer, it

RUNAWAY PREVENTION

National and local groups have teamed up together to raise awareness and educate the public about teen homelessness and runaways.

The National Runaway Switchboard, the National Network for Youth, the National Safe Place and many other youth serving organizations, including the Youth Services Bureau of Huntington County, work collaboratively to raise awareness about runaway and homeless youth and educate the public about solutions and ways to prevent the growing problem.

"Young people today are facing so many issues without the life experiences or the support to deal with them," said Jan Williams, executive director of YSB. "So the natural response is to flee from the situation that is causing the stress, not realizing that by doing so it can make the situation worse."

According to the National Runaway Switchboard:

- Between 1.6 and 2.8 million youth run away in a year.
- Over the past three years, there has been a 56 percent increase in crisis calls identifying economic problems as a reason for the call.
- One in five youth will run away before reaching the age of 18 and half run away two or more times.
- Indiana has a higher percentage of runaways than the national average at 57 percent.
- 32 percent of runaway and

homeless youth have attempted suicide at some point in their lives.

- 50 percent of runaway youth age 16 or older reported having dropped out of school, having been expelled or having been suspended at least once.
- 80 percent of runaway or homeless girls reported being sexually or physically abused.

According to national and state data the number of youth who are "throwaways" have also shown an increase. "Huntington County's data is consistent with the national and state data," said Ryan Beeching, Safe Place/Host Home coordinator. A "throw away" youth is a youth who are denied housing or are prevented from returning to their home by his/her parents and/or care givers.

In Huntington County, the Safe Place/Host Home program offered by the Youth Services Bureau provides the community outreach, education and crisis intervention for youth who may be thinking about running away, who may find themselves homeless due to being a "throwaway" or in need of support as they deal with other conflicts.

In 2013, 94 youth utilized the Safe Place program in Huntington County. Of those youth, 75 percent utilized the program due to family conflict.

Added Williams: "People often think that they are not affected by a runaway or homeless youth, but this not the case. The economic impact this growing trend

has on our community is eye opening." Based on national statistics, a youth who has had a history of runaway is:

- 2.4 times more likely to become a smoker
- 67 percent more likely to use marijuana
- 53 percent more likely to report an STD
- To earn on average income of \$8,823
- 76 percent more likely to be a recipient of public assistance

President Glessner called the meeting to order at 5:30 pm.

Quotes for demolition of three houses – 417 N Grover, 303 Third Street, 714 Railroad Street – were opened and reviewed and were as follows: Martin Enterprises, Inc at a total of \$27,296.00 and DIRT, Inc at a total of \$19,490.00. Marla Stambazze of the Department of Community Development outlined the action to be taken in that the Town would cover expenses of the demolition by awarding the contract but that the owners of the properties would be billed the cost. If the costs are not paid by the owner, a real estate lien would be placed on the property with additional administrative fees added. Stambazze said that her department would be handling the notifications and work with attorney. Following the discussion, Stivers moved, seconded by Trosper, to accept the quote of DIRT, Inc. 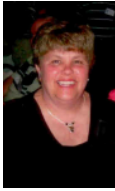

Council continued discussion on the employee benefit package for 2015. Stivers moved, seconded by Glessner that employees be given a .63 per hour pay increase. The motion was approved unanimously. Following additional discussion of the package, by consensus, members determined that a formal retirement plan be researched to replace the plan currently in place.

Trosper moved, seconded by Brown, annual dues for continued membership in the Huntington County Chamber of Commerce in the amount of \$90 be approved. The motion was approved unanimously.
