Samuel L. Good was born in Perry County, Ohio October 4, 1834. With his parents, Benjamin and Nancy Good and other family members, he came to Indiana in September 1847

and located in Warren. He worked on the farm until age 17 when he became a clerk in the general store of J.F. Good and


In 1860, with George H. Thompson Sr., he commenced the general merchandise business until 1865. He, also, shipped grain and live stock until 1884. In 1883, with George Thompson Jr. as proprietor partners, they opened the Exchange Bank. The bank was then located in the north half of its present location. Samuel's son, George S. Good, became manager of the bank. In 1887 the bank was moved one door south in a newly built building. By 1895 the interest of George H. Thompson was acquired by George and his father, Samuel. On the death of Samuel, in 1899, the bank's ownership was changed to a partnership of George S. Good and his brotherin-laws, Lloyd S. Jones and John L. Priddy. In 1908, the banking room was extended and a badly needed new vault was added.

The three partners did a good job of building up the solid foundation established by the founder of the bank. By 1932, the institution had grown to be one of the most substantial in Indiana and was able to pass through the late strenuous days with unimpaired prestige. George S. Good was president until his death in 1931. Lloyd S. Jones took over for a short time until his death in 1932. In September 1932, Samuel P. Good succeeded as president of the Exchange Bank.

Trapping Course

A free trapper education course for all ages, youth through adult, will be offered by Salamonie Reservoir and the Indiana State Trappers Association (ISTA), Oct. 10-11, at the Upper Wabash Interpretive Center.

The program starts at 9 a.m. on Saturday, Oct.10, with education on trapping issues, ethics and regulations. Lunch will be provided. After lunch, participants will set traps for furbearers on the trap line under the close supervision of the instructor. Traps will be left overnight and checked the next day.



Participants have the option of leaving late Saturday afternoon or camping Saturday night at the Lost Bridge West youth campground, near the Interpretive Center.

On Sunday at 9 a.m., participants will accompany trapping instructors to check traps and handle the fur of animals caught. After the traps are checked, furbearers caught will be used in skinning and fleshing demonstrations by ISTA instructors. Sunday's lunch also will be provided.

Attendees do not need a trapping license for this program. Entrance fees to the property will be waived for participants. The course is free but advance registration by Oct. 1 is required. To register, call (260) 468-2127.

Participants may want to bring waterproof boots or hip waders and will need to dress for the weather. Overnight camping at the youth campground is optional; however, participants must attend both day sessions to earn the DNR Trapper **Education Certification.**

The Interpretive Center is located in Lost Bridge West Recreation Area, west of Highway 105 in western **Huntington County.**

Money Problems Aren't NEW

my ancestors bartered everything from bullets to bread to animal skins to tobacco. It was called "country money." Since paper money wasn't worth a Continental they probably traded on the cow market as well. I'll give you my three pigs for your one cow. Barter works. The problem, of course, was that it was difficult to carry around a cow in your back pocket.

Whether the currency of exchange is bovine or an electronic Wall Street recessions have taken place and will continue to do so. Whether it is cash or crops most people are poor mathematicians and eventually too few bucks bring

about bankruptcy.

It is doubtful there was a mortgage loan crisis in 3100 BC in Mesopotamia but since this was the beginning of writing and the keeping of accounts most likely some financial decisions were short on wisdom.

It was interesting to visit a bank in Babylon. Their first banks Babylon looked like temple and palaces because that is exactly what they were. The name of the first real recorded Banker was Pythius who operated in Greece and Asia Minor. The first banker who never made a banking error has yet to be found.

When another five hundred years had passed the Code of Hammurabi began to take charge. It was obvious that without some kind of laws governing banking operations a natural inclination toward greed would take over and whoever had deposited would soon find nothing left of their deposits. By 2550 BC Cappadocian rulers were starting to guarantee the weight and purity of silver ingots but still the equivalent of a dollar might vary. Despite the best attentions money has a built in variable.

A large portion of the population wasn't affected one way or the other because they had nothing to bank or barter with. They were slaves and when their compensation was doubled or even tripled they

never noticed.

Money is whatever you say it is. By the year twelve hundred the larger the Cowrie shell collection the richer the collector. Indeed, the Chinese character for money originally represented a Cowrie shell. Money is whatever you say it is until one day "It isn't worth a continental."

By 687 BC the first crude coins were minted in Lydia, Asia Minor. This allowed the first retail shops to open. Commerce as we know it was on its way.

The history of war and money cannot be separated. Even the word "to pay" comes from the Latin word meaning "to pacify." Wars cost money and national war debts are ageless. An eighteenth century writer once wrote, "Nowadays that prince who can best find money to pay his army is surest of success." Out of such a truth arose the fact that if there isn't enough money to fight a war practice deficit spending and let future generations pick up the check.

In our own brief national history the Colonies in America were traditionally short of real coins. Indeed, our enthusiastic acceptance of paper money and its suppression by the British was a factor in provoking the American revolution. By 1740 England was giving a great big "No" to the colonies and their printing of paper money. In 1775 as the Revolutionary war

began hyperinflation took over. Among the reasons; in North Carolina there were seventeen different forms of money declared as legal tender. Who said that reason is really even in complete control.

When the war finally came to an end a new era began; a war between debtors and creditors. In 1812, over twenty years after our beginnings we still didn't have a National Bank to exert a restraining hand on commercial banks. It was eighty years before we finally started to get our act together. Better late than never.

Now it is the 21st century and certain questions arise as they have always arisen. Are we in a recession or a depression? What investments are good or invitations to disaster? What is the next economic problem laying just around the corner? For years by barter and banter, by banks and Savings and loans or by money hidden under the mattress Americans have sought the better ways to manage money rather than be managed by it.

And the dollar? What is it worth? What could be bought in 1913 for \$1.00 would today cost \$21.78.

prey to the slick advertising and sales pitches that guarantee to keep them in their homes," said Jan Baumgartner, Director of Community Connections, the Housing division of Pathfinder Services, Inc., a local NeighborWorks organization with its main office in Huntington.

"Some challenges borrowers are facing in the communities we serve includes job loss due to the current economic situation. Additionally, we are receiving many referrals daily of families who have no where else to turn, and are still seeing some families who have fallen victim to paying for foreclosure counseling," Baumgartner added.

Foreclosure rescue scam artists frequently demand upfront payment for their services and "guarantee" to modify, refinance, or reinstate a borrower's mortgage. The payment demanded can be anywhere from \$1,000-\$5,000, as was the case for one homeowner in Indiana. A local homeowner paid a California agency \$1,500 to stop a foreclosure sale. They believed the promise that this agency was helping, when they were not.

By the time the homeowner contacted Community Connections it was too late and the home was lost. That does not mean all homeowners who have fallen into this trap cannot be saved, but homeowners should contact Community Connections now to be sure they are receiving quality assistance.

said "Homeowners receive foreclosure counseling. Nonprofit organizations are a homeowner's best defense against foreclosure."

Community Connections urges home owners not to pay a person or company for foreclosure help, and offers borrowers the following tips to avoid foreclosure rescue scams:

- * Never use any ad, person, or company that approaches you and claims to be able to "stop
- * Never release your financial information online or over the phone to a company you know nothing about. Do a back ground check first to verify they are legitimate first call the Better Business Bureau or search for

If you prefer to speak to a counselor over the phone, call the Homeowner's HOPE Hotline at 888-995-HOPE (4673) for free foreclosure prevention counseling by expert counselors at HUD-approved nonprofit counseling agencies. The hotline is open 24 hours a day, seven days a week, in English and in Spanish. Counseling is also available in 20 additional languages by request.

Contact your mortgage lender. Contrary to what a foreclosure scammer will tell you, you should contact your lender the minute you have trouble making your monthly payment.

If you suspect a scammer has approached you or victimized you, contact your local Better Business Bureau or state attorney general's office. In addition to reporting a scam locally, you can file a complaint with the Federal Trade Commission (FTC). To file a complaint in English or Spanish, visit the FTC's online Complaint Assistant: https:// www.ftccomplaintassistant.gov/ or call 877-FTC-HELP (877-382-4357).
