### PULSE NEWS

Pulse director Cynthia Smyth-Wartzok was re-elected President of the Indiana Community Theatre League (ICTL) at the recent annual meeting on March 19. The ICTL board oversees the annual statewide theatre festival, coordinates theatre workshops throughout the year and gives out an annual scholarship. The Indiana Community Theatre League is a part of Region Three of the American Association of Community Theatre. Her term begins in June, 2005 and is a two year term. Cynthia has been involved with ICTL since 1998 where she has served as Treasurer for four years.

Cynthia was also recently appointed by the President of Arts United of Greater Fort Wayne for a two year term on the Region 3 Advisory Council (RAC) representing Huntington County. Arts United is a regional partner for the Indiana Arts Commission and the RAC is comprised of 10 counties in Northeast Indiana. The Council will serve in an advisory capacity on matters that affect planning, delivery and evaluation of the four core regional services: grant making, technical assistance, information and referral and cultural planning.

President of the Board of Directors Randy Neuman was elected ICTL Secretary. Randy has appeared in many Pulse productions as well as being webmaster, photographer, props master and board member. He is the Director of the United Brethren Historical Center at Huntington College.

Over 600 Huntington County 6th-8th graders are scheduled to see "Great Shakes Alive!" at the Pulse Opera House. School Tours are scheduled for April 28 & 29 with groups from Salamonie, Riverview, Crestview and Edgewood Middle School (from Warsaw). Public performances of the show are April 22-May 7.

### 90TH ANNIVERSARY/HOMECOMING/DEDICATION

On April 17, 2005 the Warren Church of Christ, 302 N. Wayne St., Warren, IN will celebrate it's 90th year in the building located at the corner of 3rd and Wayne Streets in Warren. A big day of activity is planned with the public invited to attend any or all of the 3 services billed for that day. Much work has been done to the facility in recent months and the church would like to share that project with everyone.

A 9:30 A.M. worship service, with former minister Bill Weaver, will focus on the past history and honoring the only member who was present at the dedication of the sanctuary in 1915, Bertha Turner. There will be special music and many people will be coming "back home" to celebrate God's blessings of years gone by. This will be followed by big carry in meal at 11:30 so everyone can visit and share past memories. Old pictures and memorabilia will be on display to help remember great times shared. A special commemorative ribbon will be given to all who attend as well as a pen. Copies of the history of the church and the original brochure of the "new church building" proposal back in 1914 will be available to keep. A slide program and power point presentation will be given to show past and present memories as well. A Group Picture will take place in front of the building following the morning worship service.

Tours will be given of the newly remodeled basement and upper level renovation project that has been taking place in the past six months. Elmer Miller construction has been the main contractors with local businesses participating in the project. Bolingers Heating and Plumbing, Accent Interiors and Larry Poulson have done a great job in helping to complete the project. A special dedication will take place Sunday evening for these areas.

A 2:00 P.M. service will take place with former minister Jim Lloyd speaking and sharing about the present blessings God has given the church. We hope to have former Bible Bowl members present for pictures and memories. We anticipate many from the area will be able to attend this service. Gerald Moreland, minister, has challenged the congregation to have 300 present at any of the three services and if so, he will tithe on that attendance and do Hike/Bike Journey by walking from the Church House in Warren to the Court House in Huntington and riding his bike back to Warren on Monday, April 18, 2005 (rain or shine), which is the actual dedication date back in 1915. This will be a 30 mile hike/bike trip. He did a similar trip back on Oct. 31, 2004 when the church went over the challenge of 200 with 221 present and made him walk home from church on that day, a 12.7 mile journey.

The final service will take place at 6:00 P.M. with former minister Marvin Keane speaking and sharing about the future of the church. A special dedication of the building will be celebrated and a time of praise will be enjoyed by all. We hope many of you will come to help us give this day to the glory of the Lord for the good things He has done for us at WCC. Some other former ministers will be on hand to help us celebrate the day.

### APRIL IS CANCER CONTROL MONTH

These three steps can reduce cancer risk.

The goal of Cancer Control Month is to remind us of the various cancer risks we can control. These are three things you can do.

1. See your doctor for a health review and summary of preventive tests that are recommended for your age group and sex. A colonoscopy, mammogram, or a PSA test could be recommended. Make an appointment to have tests. Be sure to keep it. Get serious and follow the doctor's advice about general health issues such as weight control and diet.

2. Create a plan for exercise. If you don't exercise now, you only need 10 or 15 minutes a day to start. Make a point of putting activity into your life: walk up stairs; park farther away from work and the store; work in your yard. Get back to your favorite sport. Tennis and swimming are good choices.

3. Put cancer-fighting foods into your diet. Nutritionists at Ochsner Clinic in New Orleans recommend:

Apples. Eat one the usual way or put chunks in salads or slices in sandwiches.

Berries. Add them to smoothies or top your breakfast cereal with berries. Blueberries are highest in antioxidants.

Artichokes. They have more antioxidants than other vegetables. Chop an artichoke heart into tomato sauce or a green salad.

Potatoes. Russets have the highest antioxidant count, but it's mostly in the skins. Eat them baked or into soups.

Oregano, cinnamon, and cloves. Spices that are high in antioxidants.

Nuts. Pecans have the highest antioxidant count. Crush and add them to chicken or fish before baking.

Beans: Small red beans are best, but all dried beans fight free radicals.

 First in war and first in peace and first in the hearts of his community and fellow soldiers, Master Sergeant Michael Thomas Hiester, 33, of 417 South Main St., Bluffton, will be accorded full military honors and the full salute of his community for dedicated service up to the moment of his death at 5 a.m. (Bluffton time) last Saturday, March 26, 2005, in Afghanistan.

M/Sgt. Hiester and three other Indiana National Guardsman

were killed in the line of duty when their military vehicle struck and detonated a land mine south of Kabul, Afghanistan.
