If you missed me last week sorry I just didn't have it in me to think of anything interesting. Today we are blessed with cooler weather and hope it stays around (maybe till Christmas)? I prefer 70 degrees and low humidity weather.

I have been trying to keep what little garden I have this year watering a couple times a week will be able to pick green beans this week. Sure is going to taste good. Tomato plants have survived well and really grown and a few tomatoes setting on. Our peach tree is crying for help and have been spraying it couple times a week looks like it might make it. It is loaded with fruit but some looks as if they are baked onto the tree.

I am sure will be doing very little canning and preserving this year and in my old age I probably will not miss it. Just hope my Mom is not looking down and thinking that girl is sure slacking off.

I felt really bad for the festival committee for all the hard work they put into organizing this years festival and to think it was hampered by the weather. Anyway good job and good intentions for this year. Also hats off to everyone who had any part of restoring our town so quickly after the storm.

My sister in law brought me some zucchini this past week and made me realize this time to get out the cookbooks with all those recipes you use only once a year. One of my favorite recipes is the zucchini pie, it is versatile to change the flavor and freezes well. For 1 pie it takes 1 cup of peeled shredded zucchini, 1 cup sugar, 1 cup milk not canned milk, 1 egg, 1 1/2 tablespoon melted butter, 2 tablespoon flour. Cook zucchini in a small amount of water till tender, drain well add all the ingredients into a blender mix till smooth. Pour into an unbaked pie shell sprinkle with cinnamon or nutmeg, bake 400 degrees for 10 minutes then at 350 for 30 minutes. I have used coconut flavoring in place of vanilla and sprinkle coconut on top or any favorite flavoring, just experiment. I have several baked and freeze them just warm them up in the oven, something nice to have on hand.

Lets all hope for rain and a nice rest of the summer.

drive their trailers over the ends of boat ramps, especially in muddy rivers where ramps can be difficult to see underwater.

The trailers could become stuck or damaged, according to Jamie Smyth, fisheries staff specialist with the DNR Division of Fish & Wildlife.

"Use common sense," Smyth said. "Don't push it too far. If you decide to launch a trailered boat, go nice and slow."

DNR boat ramps are administered through the DNR divisions of Fish & Wildlife and State Parks & Reservoirs.

The Division of Fish & Wildlife maintains hundreds of boat ramps across Indiana through its public access program and does not monitor water levels at each one. DFW does not plan on closing any ramps and is instead urging people to use their own discretion.

Some ramps are currently only suitable for launching canoes, kayaks and small, hand-carried boats, Smyth said.

"Once you safely launch your boat, use extra caution to avoid shallow water, rocks and other obstacles," Smyth said.

The DNR Division of State Parks & Reservoirs has closed the Portland Mills boat ramp at Raccoon Lake, although the main boat ramp remains open.

At Mississinewa Lake, the Pearson Mill boat ramp is open for small boats only and the Frances Slocum boat ramp is open for bass-type boats, but not large speed boats. The Red Bridge and Miami boat ramps at Mississinewa remain open with no restrictions.

Water levels are abnormally low at all DNR reservoirs, and boaters are urged to use caution.





- Electric or Hand crank freezers may be used. Electricity for electric machines will be furnished. You may want to bring an extension cord. Ice and salt will be provided by the 4-H Association.

- Contest will be held at the Food Pavilion (Cook House) next to the Grandstand.

- Participants must provide all ingredient and supplies

- Raw eggs must be heated to 160°F (verified by a calibrated thermometer) before using in an ice cream recipe. The previous practice of heating until they 'coat a spoon' is no longer acceptable. It is

recommended that powdered pasteurized eggs be used in place of raw eggs. Indiana State law prohibits the sale of ice cream that is prepared from a mix that is not pasteurized just prior to freezing.

- Recipe MUST be submitted with sample to judges

- Contestant must come prepared to start cranking at 3:00PM. No time will be given for mixing of recipes

- Contestants must be ready for judging at 4:00PM.

- Sample for judges will be put in a quart plastic container, marked with contestant number.

- Awards will be presented at 6:30PM. Prizes will be given in both divisions. Samples may be given to public if contestant so desire.

- Judging will be based on:

- Flavor
- Body and Texture
- Technique
- Eye Appeal

SOLVING FISH KILL

In the summertime weather and environmental events can trigger a fish kill in a pond. It can be a great surprise to see large catfish and bass swimming to the surface and gasping for air. There are also unfortunate instances when nearly all the fish have died in a pond.

Fred Whitford, Coordinator of Purdue Pesticide Programs, has spoken to groups about this topic. Whitford feels is necessary to note as much information as possible when the fish kill is found to help solve the mystery. He suggests making notes about the weather prior to the event and the condition of the pond. Other items to write down include the size and type of dead fish as well as any other biological information (ie. presence of turtles, frogs, tadpoles, etc.).

The most common cause of a pond fish kill is a low dissolved oxygen level (less than 2 parts per million) in the pond water. The reason for low oxygen levels can be caused by one or more factors during the summer months. A large die-off of aquatic plants or algae as well as a rise in the water temperature can cause a drop in the oxygen level of the pond water. The drought and hot weather that we are currently experiencing means that pond vegetation may need to be managed differently. For example, a chemical such as copper sulfate to control algae may need to be applied on only 1/3 of the pond every two weeks rather than spraying the entire pond at once.

Wind or heavy rain may also cause a "pond turnover" after a summer storm. This means that dense water on the bottom of the pond containing low dissolved oxygen circulates with surface water. The result is low dissolved oxygen levels throughout the pond. If a pond turnover situation occurs, the unusual fish behavior mentioned earlier can be seen.

A publication from Purdue Extension (PPP-79), "What Killed the Fish?" provides more information about the possible reasons for a fish kill. A copy of this publication can be accessed at the following website: <http://www.btny.purdue.edu/Pubs/PPP/PPP-79.pdf>, or it is possible to stop by the Extension office for a copy.

As discussed in the aforementioned publication, a fish kill that is found in waters of the state, or in an area that

might drain into these waters should be reported as soon as possible. Notify the Indiana Department of Natural Resources at 800-TIP-IDNR. Also contact the Indiana Department of Environmental Management at 888-233-7745.

It is also recommended by specialists to manage vegetation in ponds by preventing nutrient-laden water containing nitrogen and phosphorus fertilizers from entering ponds. Algae blooms that appear from fertilizer runoff can die off causing a fish kill. A publication written by Carole Lembi from the Purdue Dept. of Botany and Plant Pathology provides more information about managing pond vegetation (http://www.ces.purdue.edu/extmedia/APM/APM_3_W.pdf).
