

SWNS REGISTRATION

Small World Nursery School in Warren is a non-profit pre-school, which has been serving the families of Warren and the surrounding area for thirty years. Small World is currently registering students for the 2010-2011 school year.

Classes begin in September and end in early May. The 3-4 year old class attends on Tuesdays and Thursdays from 9 - 11:30 am. The 4-5 year old class attends on Monday, Wednesday and Friday from 9-11:30 am or 12:00 - 2:30 pm, if

the morning class fills up and there are at least 6 children interested in the afternoon class. Children must be 3 or 4 years old by August 1st. The cost is \$525.00 for the 3 year old class and \$625.00 for the 4-5 year old class, with a \$40 registration fee. The registration fee increases to \$50 after June 30th.

REMEMBER

When the Civil War had come to an end in 1865, a druggist in the little village of Waterloo, NY was concerned that all those who had died in that great struggle would soon be forgotten. It did not seem right, so he spoke quite firmly to the need for a day of remembrance. His concern became a committee, and by the spring of 1866 the townspeople had adopted the idea of making wreaths, bouquets and crosses for each veteran's grave. Flags flew at half mast. There were black streamers and evergreen boughs.

A year later it was all repeated again with speeches and services by a local clergy commemorating the almost 700,000 lives lost on both sides. They were determined that those who had died would not be forgotten.

In memory of those fallen soldiers, Henry Wadsworth Longfellow wrote a poem simply titled Decoration Day:

Your silent tents of green
 We deck with fragrant flowers
 Yours has the suffering been
 The memory shall be ours.

Decoration Day, before it was officially recognized as Memorial Day; continued as a series of impromptu celebrations honoring the brave men who had died in that war. Over two dozen claimed they were the birthplace of this Day, but Waterloo was officially given the credit by President Lyndon Johnson in 1966. During this transition it survived for the obvious reason that remembrance of our brave soldiers good not be allowed to pass to oblivion. What they done and what they had given was too much to even think of letting that happen.

After World War I, all who have died fighting in any war were included, and in 1971, Congress made the last Monday in May the official Memorial Day. And in so doing gave permanent meaning to some words written by the late Rev. Robert Zoerheid, "Death is what happens between where we are and where the universe is..." Which is to give the celebration of all the battles we have fought for freedom a new and deeper meaning.

All members of our armed forces know theirs is an occupation not without risk. They only ask that those in roles of leadership think long and hard before a conflict is begun and that when the time comes to end it all, it be done with honor.

In 1954, President Dwight D. Eisenhower put it well when he said, "...let us reconstruct ourselves to the task of promoting an enduring



In early 1933, there were many businesses in the town of Warren. In the next several articles I will attempt to list them. Starting on the corner of First and Wayne Street was the Brown-Keplinger filling station. Next door was the Kriegbaum Bros. Hardware, then Doversburger Barber Shop and on the alley was Stucky's Hi-Quality Hatchery with Hobalt McDaniel starting to sell Philco radios and Maytag washers.

Across the alley was the drug store of Albert Coles, then Turners Sanitary Market and the Warren Post Office next door. At that time Valance Slater was the postmaster. Next to the post office was the IGA City Market, then the Kroger Store where Napa is now. On the end of the block, where Kenneth Cook served as town clerk, town hall stands.

Of these buildings, the filling station has been remodeled into Warren Service and Supplies' office. The barber shop and front part of the hatchery have

been torn down. Where the Sanitary and Post Office was those two buildings have been made into one. Next week we will try the next block.

COUNCIL NOTES

A number of citizens were in attendance at the May 19 meeting of the Van Buren Town Council.

President Tony Many conducted the meeting which opened at 7 pm with all repeating the Pledge to the American Flag.

Most of the citizens in attendance live outside city limits. Understandably all are concerned about their safety since the homicide of George Akers.

The citizens questioned if there is a possibility that another police officer could be hired to check outer areas. There has also been a number of break-ins and robberies throughout Grant County.

Council said they did not have the funds to hire another officer.


