IYI WORKSHOPS

A nationally renowned trainer will present two workshops in Fort Wayne to help youth workers better engage parents and to provide youth program managers ways to enhance the professionalism of their employees.

The Indiana Youth Institute (IYI) is offering two half-day trainings on March 6 featuring Lisa Jones of Lisa Jones Consulting. Jones will teach one morning and one afternoon session, each focusing on a different topic and aimed at different audiences.

"Engaging Parents and Non-traditional Families" will run for 9:00 a.m. – 12:00 p.m. and is designed for youth workers, teachers, youth ministers, family service providers and others who work directly with children, youth and families. Participants will discover how to use the environments in which they serve children, organizational attitudes and specific activities to encourage more successful relationship building with parents and non-traditional caregivers.

The afternoon session, "The Pursuit of Peak Professionalism," runs from 1:00 – 4:00 p.m. and targets executive directors, managers, principals and other senior

staff members responsible for leading and directing employees. The presentation will explore and evaluate ways to help staff pursue excellence in professionalism.

The trainings will be presented at the Matthew 25 Health and Dental Clinic, 413 E. Jefferson Blvd., Fort Wayne, 46802. The cost of each session is \$20 and individuals can register online with a credit card at www.iyi.org/training_registration. Onsite check-in begins 30 minutes in advance of each session. Individuals are welcome to attend both sessions for \$40.

Jones has more than 20 years of experience providing leadership in both preschool and school age programs, including as program monitor for more than 200 Southern California school-age programs. Jones has been a consultant and workshop facilitator and trainer for 10 years, providing workshop sessions at nationally acclaimed conferences such as the National AfterSchool Association, and BOOST (Best of Out of School Time). NEW SCAMS

With headlines touting bank foreclosure settlement and independent foreclosure review in the news some consumers might find a new twist to loan or foreclosure rescue scams. Pathfinder Community Connections and other government partners want to remind consumers to be cautious of potential scams.

"It's getting much harder to identify the good guys from the bad guys these days," says Jan Baumgartner, Director of Pathfinder Community Connections. "We have often told consumers to be wary of any offers not directly initiated by the consumer but in the case of the independent foreclosure review this is not the situation. Eligible consumers were mailed directly."

Consumers should take advantage of free counseling and be wary of any firm that asks for an up-front fee. Warning sings of a loan modification scam are:

John W. Surran was born in 1849 and was a native of Carroll County, Indiana. When he was seven, his family moved to Michigan where he acquired a good education. In 1868, he entered Western College of Iowa and graduated in 1873. In 1874 he took a law course and remained in that college until the spring of 1875, when he was selected as a teacher in the "Roanoke Seminary" of Roanoke, Indiana. After the close of the school year, he entered the law office of Saylor and Kenner, of Huntington, and remained with them until April, 1877. During the last year he served as local editor of the

Huntington Democrat.

In the fall of 1877, he began to read law under Judge Everette of Elkhart, Indiana. While in Elkhart, he and Edward Curtis established the "Elkhart Dailey News", but soon disposed of his interest. On September, 1879 he came to Warren and established "The Warren Weekly News", a neat four page seven column folio independent paper. The first issue was December 5, 1879. The circulation increased rapidly and compared favorably with any weekly paper published in Huntington County.

On December 19, 1880 the news office was destroyed by fire, causing what might be termed a total loss, but in six weeks the subscribers were again receiving the news. In 1900 the name was changed to the "Republican" and the paper became a partisan though broad-minded sheet. In 1902, Monroe Wiley bought the paper and later merged with A.W. McCulloch who ran "The Warren Tribune". Four Years later Mr. McCulloch sold his interest to Mr. Wiley. Mr. Wiley ran "The Warren Tribune" for many years after.

Ask SHIP

Q: I recently had a hospital stay that lasted several days. I've received the bill, and I see charges for tests that I don't believe I had. These tests have nothing to do with my current health problem. What should I do?

A: Reading any lengthy bill can be confusing, but a medical bill can be especially confusing with the codes and technical information that is often used.

You can always ask your hospital or doctors' office to clarify charges you don't understand. They may be able to clarify the charge. They may find that there was an error in the billing and correct the charge.

Any time you feel there are charges on your bill that might not have been necessary, whether you had to pay for them or not, you should question them.

If speaking with the provider does not clarify the charge to you, there are other resources to help.

Medicare fraud and abuse costs billions of dollars each year. There are many kinds of fraud.

Medicare fraud is purposely billing Medicare for services that were never provided or received. One example is having your Medicare number used to bill Medicare for supplies or services you don't need or want or that your doctor did not order.

Identity theft is another form of fraud. It is important to always keep your Medicare and Social Security numbers safe.

You can help protect yourself and Medicare by looking out for the following:

- Charges for products or services you didn't receive
- Companies that offer you free equipment
- Suppliers who want you to use their doctors
- Anyone you don't know asking for your Medicare or Social Security number
- Calls from companies you didn't give your phone number to

If you've contacted the supplier and you suspect that Medicare is being charged for an item or supply you didn't get, or you don't know the supplier on the claim, call 1-800-MEDICARE (1-800-633-4227). TTY users should call 1-877-486-2048.

If you suspect identity theft, or think you gave your personal information to someone you shouldn't have, call the Federal Trade Commission's ID Theft Hotline at 1-877-438 4338. TTY users should call 1-866-653-4261.

Another option is to call your local Senior Medicare Patrol (SMP) office. The SMP Program educates and empowers people with Medicare to take an active role in detecting and preventing health care fraud and abuse. VALUE OF AN AG DEGREE

There's no denying that agriculture is important to our local economy. Many people are employed in farm or farm-related jobs, including production agriculture, farm inputs, processing and marketing and wholesale and retail sales.

The most recent Indiana Ag Statistics publication compiled by the United States Department of Agriculture (USDA) shows that total income from farming was \$148,926,000 for Huntington County in 2009.

So, should anyone question the decision of a young person to pursue a degree in agriculture?

The National Association of Colleges and Employers (NACE) released a 2012 Job Outlook study. This is a survey of 1000 employers about future job hiring plans. As a result, an article appeared on-line stating that the surveyed employers were not likely to hire individuals with degrees in five areas (http://education.yahoo.net/articles/most_useless_degrees.htm). Three of these areas were animal science, horticulture and agriculture. The author of the article claimed that degrees in these areas were useless based on the report. Needless to say an article claiming that agricultural degrees are "useless" generated feedback from the ag community.

It is important to note that details about the NACE study are only released to individuals who are members of the organization (<http://www.nacweb.org/>). Thus the general public is unable to see any information regarding how the 2012 NACE study was actually set up.

In response to the on-line article which shed a negative light on ag degrees, deans from four agriculture institutions submitted an article called, "No limits to the value of an agriculture degree" (<http://www.ag.purdue.edu/Connections/NOW/Pages/AgValue.aspx>). The article co-authors included deans from Purdue University, University of Illinois, Ohio State

University, and Iowa State University.

One study mentioned by the deans in their article involves the shortage of college graduates to fill need. They refer to the USDA "Employment Opportunities for College Graduates in Food, Renewable Energy, and the Environment, 2010-2015" report that projected 53,500 qualified graduates will be available for about 54,400 jobs annually the agricultural and food systems, renewable energy and the environment.

Another important area to consider is the current trend of increasing placement rate for recent college graduates. Eighty-six percent of May 2011 Purdue University College of Agriculture graduates, found employment, enrolled in graduate or professional schools or accepted an employed internship as of Feb. 1, according to a College of Agriculture survey. That placement rate compares with 85 percent in 2010 and 83 percent in 2009. (See the complete online article: <http://www.purdue.edu/newsroom/general/2012/120214FernandezPlacement.html>.)

Most importantly college degrees in agriculture cover many majors. Food Science, Agricultural and Biological Engineering and Agricultural Economics are just a few options. Any young person who is interested in pursuing one of these degree options should do their homework and discuss careers with folks who are working in these fields. Young people can then decide for themselves whether or not a science-based agricultural degree has value in today's economy.
