## PRESCHOOL DEADLINES

Small World Preschool in Warren is a non-profit pre-school, which has been serving the families of Warren and the surrounding area for over thirty years. Small World is still registering students for the 2013-2014 school year.

Classes begin in early September and end in early May. The 3-4 year old class attends on Tuesday and Thursday from 9-11:30 and the 4-5 year old class attends on Monday, Wednesday and Friday from 9-11:30 am or 12:30-3:00 pm, if the morning class fills up and there are at least 8 children signed up for the afternoon class. ## Hoosiers Get Direct Access to Physical Therapists

Physical therapy is an occupation that deals with the promotion of health and treatment of injuries caused by physical means. Physical therapists have to complete doctoral level education focusing on the health science. They are trained in strengthening, balance, endurance, breathing techniques, wound healing, and surgical rehabilitation. Recently, Indiana has passed a bill, HB 1034, that gives patients direct access to physical therapy. The bill goes into effect July 1, 2013. The bill states:

Physical therapy services without a referral. Allows a physical therapist to evaluate and treat a patient without a referral for not more than 24 calendar days. Requires a physical therapist to obtain a referral from the patient's provider if further treatment by the physical therapist is needed. Provides that a physical therapist may not perform spinal manipulation of the spinal column or the vertebral column unless: (1) the physical therapist is acting on the order or referral of a physician, an osteopath, or a chiropractor; and (2) the referring physician, osteopath, or chiropractor has examined the patient before issuing the order or referral. Provides that a physical therapist may not perform sharp debridement unless a physical therapist has an order or referral of a licensed physician, osteopath, or podiatrist.

This means that you do not need to go to your primary care physician to get a referral to physical therapy. For example, if you have any muscle pain or injury that you don't this is appropriate for your physician, you can now call up your local physical therapist. The goal for this profession is that the general public will have a physical therapist just as they have a dentist, doctor, or optometrist. People can benefit from having direct access to a physical therapist in many ways. If an injury as occurred, one may have quicker time to treatment of that injury. It will also save money for individuals and insurance companies because it takes out the middle man. Finally, physical therapists typically have more time available to spend with a client to address any health needs.





## NUISANCE WILDLIFE

Nuisance wild animals are a common problem in the spring, and Hoosiers have several options for dealing with them.

People can always call alicensed wild animal control company. For the name of a licensed company, visit dnr.IN.gov/fishwild/2351.htm.

Hoosierlandowners or tenants also can trap and release or kill raccoons, skunks, opossums, squirrels, beavers, muskrats, minks, long-tailed weasels, and foxes on their own property

without a permit if these animals are damaging that property.

Live traps for capturing animals can be purchased from gardensupply or home improvement stores. Be careful when livetrapping wild animals in the spring because they may have young. If the animal is to be released after capture, it must be released in the county of capture and cannot be kept as a pet, sold, traded or given to another person. Releasing wild animals on a city, county or state property may be illegal or require written permission; contact proper officials before releasing wild animals on public property.

To keep wild animals from becoming a nuisance, DNR wildlife officials recommend the following:

- Pick up dog and cat food at night and keep birdfeeders out of the reach of wild animals or bring in birdfeeders at night.
- Install a commercial chimney cap made of sheet metal and heavy screen. Repair soffits to prevent access to attics, and install strong, metal vent covers.
- Prune tree limbs at least 10 feet away from the roof.
- Buy heavy metal garbage cans with lockable lids; otherwise, keep garbage cans indoors as much as possible.
- Install metal skirting around the bottoms of decks.
- Provide shelter structures for fish in ornamental ponds and water gardens; cover the pond during the night with metal screening.

Nuisance Canada geese also cancreate problems in the spring when nesting. You can oil the eggs of Canada geese or remove their nests after registering with the U.S. Fish & Wildlife Service. A link to the USFWS goose egg and nest destruction registration page is available at dnr.IN.gov/fishwild.

A list of licensed nuisance waterfowl control operators that are trained to remove adult geese is at dnr. IN.gov/fishwild/files/fw-NuisanceWaterfowl ControlOperators.pdf.

If you're buying from a dealer, you cancheck on their credibility with your local consumer affairs office.
- · Leasing: Ifyou are considering leasing a car, make sure you ask the dealer for all of the financial information up front, including details on wear and tear standards, if there is a limit on
