"Winter WarrenLand 2008 begins with announcement of the annual sale of memorial bows to decorate the Warren Community Memorial Christmas Tree is again being sponsored by the Warren Chamber of Commerce. Lighting of the Christmas Tree and Downtown Lights will be held on the Friday after Thanksgiving. Santa arrives at 6:00 pm at Town Hall at the corner of Second and Wayne Street (SR5), on a fire truck of course. Following Santa greeting the children, the downtown lights are turned on and the group proceeds up Second Street to

Knight Bergman Center for the Christmas Lighting ceremony there. Then Santa moves into the Christmas Village (Knight Bergman Center Auditorium) for the annual "Santa at the Center" which lasts until the last little one gives Santa their Christmas wish list. Warm drinks and cookies await everyone as Santa greets each child. "Santa at the Center" continues on Saturday from 9:00 – 11:00 am.

Today I see snow flakes coming down and glad I am inside to watch it, soon it will be Thanksgiving and the real winter setting in.

Our kids were home Sunday and had a quick supper of chili and hot dogs, and it tasted good on a cool evening. The girls and I finalized our plans for Thanksgiving which will be at Gayles home in Auburn. It is nice to not have to be concerned cooking this year, I only need to furnish pies which I will do the pumpkin and Bourbon Street pecan.

While they were here we got some ideas stirring about what to do different for our Christmas, since there is no small children to fill socks for and gifts we think we will do something special. Although I do remember only a few short years ago we had to fill stockings for the old at heart children and after the mantel fell off and had to be replaced we made different plans. That is one Christmas we will not forget, what a mess.

The recipe for the pumpkin pie I use I will share with you, it takes a little longer to make but it is quite good.

| 1 1/2 cup cooked or canned pumpkin | 2 eggs beaten |
| 1/4 cup white corn syrup | 2 tablespoon butter |
| 1/2 cup evaporated milk | 1/2 cup brown sugar |
| 1/2 cup hot milk | 1 1/2 teaspoon cinnamon |
| 1/2 teaspoon salt | 1/4 teaspoon ginger |
| 1/2 teaspoon nutmeg | 1 unbaked pie shell |
| 1/8 teaspoon cloves | |

Combine pumpkin, corn syrup, eggs, and evaporated milk. Stir in butter into hot milk combine brown sugar salt, and spices then combine all together mixing well pour into pie shell bake in oven at 425 for 15 minutes and reduce heat to 350 and bake for 35 minutes. When serving don't forget the good ole cows cream whipped.

Back home our Thanksgiving was always nice, mom would get the fattest hen from the chicken house and roast it with the oyster dressing (back then you could afford oysters at least once a year). She fixed all the usual dishes that went along with it even the pumpkin pie with real whipped cream. The best part of the holiday was my bachelor cousin and uncle would always come and spend the weekend with us and dad, Queenie dog and the guys would go rabbit hunting. My dog loved to hunt I think more than eat. She would get so excited when they came knowing they would take her hunting. And they always came back with a few rabbits and the day after we would feast on fried rabbit and Thanksgiving leftovers. After coming in from hunting and eating the feast my mom made they would sit around the coal stove and tell stories some of which us kids had to leave the room as we shouldn't hear and corrupt our small minds. We would go upstairs and sneak into the room that had a register over the stove and try to listen in. That worked till my mom caught us and made us go to the other part of the house. Those must have been real stories. Today they would be mild compared to what even the kids hear or tell.

With that I will wish all of you a wonderful holiday and have a great day with family and good food.



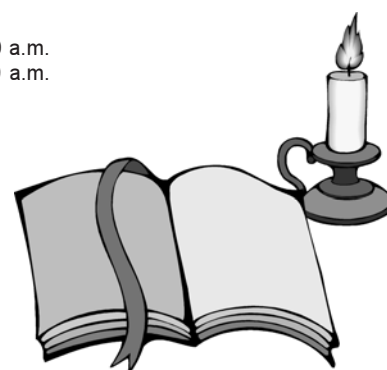

Anyone, even a member of your own family, could need blood. In fact, every two seconds someone in America will need blood. That is why your blood donation through the American Red Cross is important – especially during the winter months.

With the holidays, travel plans and inclement weather, blood donations typically drop in the Indiana-Ohio Blood Services Region.

COLD WEATHER SAFETY

The lawnmower is put away and most if not all the leaves have fallen off the trees and it is time to turn our thoughts to spending more time indoors and the holiday season. It's also time to start thinking about safety indoors. Here are a few tips and reminders to jumpstart the season.

Do a self home energy audit- A few items to look for are: Check for holes or cracks around windows, doors, ceilings, walls, light and plumbing fixtures. If you have an attic, check the R factor of the insulation. Check the temperature on the hot water heater, a good temperature is around 120 F. Insulate pipes and clean gutters. Ask your local electric company for an energy audit, they may have calculator on line.

Test all smoke and CO2 detectors to make sure they are in working order and replace batteries if needed.

Have your air ducts and furnace professionally cleaned and make sure the filters are changed according to the manufacture's operating guide through out the season. Keep warm air registers clean and free of obstructions, such as furniture, carpets and drapes.

If you are planning to use or are using supplemental heat such as an electric heater, make sure it is in good working order, never leave unattended and keep away from children, pets, flammables, and clothing. Read the owners manual and follow the manufacture's instructions/warnings.

Keep dryer vents free from lint and debris to help avoid a dryer fire. Annually, 12,700 clothes dryer fires occur in residential buildings resulting in 15 deaths and 300 injuries. "Failure to clean" is the leading factor contributing to clothes dryer fires in residential buildings.

Don't forget your vehicles need some attention too. Along with the winterizing of your vehicle, it would be a good idea to update your first aid kit and emergency roadside kit. If you don't have either, now would be the time to get them. A heavy blanket, extra heavy duty clothes, flashlights, candles and waterproof matches, kitty litter or sand and a shovel would be ideal for the winter months.

TURKEY DAY PATROLS

Indiana Criminal Justice Institute (ICJI) Executive Director, T. Neil Moore today announced that more than 250 state and local law enforcement agencies will step up seat belt patrols, impaired driving patrols, and speed enforcement in order to prevent senseless tragedies from occurring on Indiana's roadways this Thanksgiving holiday season. The Thanksgiving holiday period runs from November 21st at 6 p.m. through November 26th at 6 a.m.

The statewide Safe Family Travel Operation Pull Over enforcement blitz will begin on Friday, November 14, and will conclude on Sunday, November 30. This effort will consist of Indiana law enforcement officers working thousands of overtime hours day and night to ensure that motorists travel safely on the state's roadways.

"Traditionally, Thanksgiving is one of the most heavily traveled times of year and this year will be no exception," said Moore. "Many Hoosiers will travel long distances in passenger vehicles

to visit with family and friends during this time and Indiana law enforcement officers are committed to making sure these families reach their destinations safely."

Last year in Indiana, 20 percent of all fatal collisions were speed related. Ten people were killed in traffic crashes during the 2007 Thanksgiving holiday period alone; 20 percent of those deaths were alcohol related. In nearly one-half of the fatal collisions that occurred around Thanksgiving in 2007, the person killed was not wearing their safety belt.

Nighttime is a more dangerous time on the road because seat belt use is shown to be lower. Of the 266 nighttime passenger vehicle occupant deaths that occurred nationally during the 2006 Thanksgiving holiday period, more than one-half (138) died with their seat belts unfastened (where seat belt use was known). Daytime seat belt use is slightly higher, still nearly half of those killed during the daytime hours were unrestrained. Studies from the National Highway Traffic Safety Administration (NHTSA) consistently show that wearing a seat belt increases one's chances of surviving a crash by more than 60 percent.

"In addition to being mindful of nighttime hazards, we also want to encourage motorists to stay alert and to be aware of unforeseen road and weather conditions that can literally change overnight during this time of year," Moore added. "With each enforcement effort we must take a proactive approach towards improving traffic safety, as the goal is never to write tickets, but to save lives by deterring impaired and dangerous driving behaviors through high-visibility enforcement."

"Safe Family Travel" is a statewide enforcement effort that is funded with federal dollars awarded to Indiana from the

National Highway Traffic Safety Administration (NHTSA). The effort encompasses seat belt and impaired driving initiatives. To further publicize this effort, ICJI will launch a paid statewide television and radio media flight promoting "Click It or Ticket" and "Over the Limit Under Arrest" from November 12-25.

The Governor's Council on Impaired & Dangerous Driving serves as the public opinion catalyst and the implementing body for statewide action to reduce death and injury on Indiana roadways. The Council provides ongoing support to state and local traffic safety advocates.
