Minutes of the previous meeting were approved as submitted. A citizen in attendance on behalf of area residents was informed there is no change planned at this time for Hill Street. A house on 400 which had recently been moved in is expected to be placed on a foundation.

MAIL CALL FOR CHRISTMAS GIFTS

The day after Thanksgiving is the official start of the Christmas shopping season, but people who must ship their gifts may be finished. Shopping early is important if you are mailing your gifts or sending them by UPS or another carrier.

The Postal Service, Federal Express, and United Parcel Service increase their work forces and hours for the holidays, but it's up to people sending the packages to get them ready and off on time. Here's

Check with your carrier about how long it will take to deliver various classes of boxes to a certain destination, and ask what the size

Choose a box that is large enough to accommodate cushioning material for fragile gifts or strong enough to hold heavy items.

- Ship electronics in original packaging and inside another box. Take batteries out of toys and wrap separately.
- Write the label clearly or type it. Use complete addresses, including the words street, boulevard, drive, or lane.

And use correct directionals such as NW or SE.

- Use tape that is designed for shipping, or reinforced tape.
- Be prepared to wait. Counter people are doing their best to get everyone's packages shipped as soon as possible. Give them a smile and wish them a happy holiday season.

NOVEMBER IN THE GARDEN

This is your last chance to plant spring-blooming bulbs. November is a good time to do it, because the bulbs won't begin to produce greenery until spring. Tulips and daffodils will greet you next year and for many years to come.

Here are a few tips from Purdue University on how to protect roses: Continue watering until the ground freezes. Remove leaves and other debris from around the plants.

- Begin protecting after the first frost.
- For Tea, Grandiflora, and Floribundas, loosely staple a 12- to 14inch sleeve made of newspaper around the base of the plants and fill it with leaves.
- Roses can be protected by mounding 12 to 15 inches of soil or shredded bark, by cones, or by wooden baskets, but be sure there is adequate ventilation.
- Roses with long canes should be cut back to about 36 inches.


