#### **COUNCIL MINUTES**

The Town Council of the Town of Warren met Monday, October 12, 2015 at Assembly Hall, Council Meeting Room, 131 N. Wayne Street, in accordance with rules of Council and applicable law.

Those present were: Town Council, Ethan Stivers, Julia Glessner, Steve Buzzard; Clerk-Treasurer, Marilyn Morrison; Employees, Lee Poulson, Dennis Spitler, and others. President Glessner called the meeting to order at 5:00 pm.

Minutes of the September 14, were approved as submitted.

President Glessner introduced Robert Nuenswander, Warren Public Library Director, and David Scheib, President of the Library Board. Submitted was a request Council for consideration of a CEDIT Fund grant to supplement Library Funds available for scheduled roof repair at the estimated cost of \$21,760. Following discussion Glessner moved, seconded by Buzzard, that a grant award in the amount of \$7,000 be made as that amount would match the maximum awarded could be Warren's through Historic façade/structural grant program currently underway.

unanimously. Submitted for Council Action was Ordinance 2015-5, 2016 Municipal Budget. Following discussion, Buzzard moved.

seconded by Stivers, to adopt

The motion was approved

was approved unanimously.

Submitted for Council action Ordinances 2015-6-8, ordinances setting wages and benefits for 2016. Following discussion, Stivers moved, seconded by Buzzard to adopt Ordinances 2015- 6,7,8. The motion approved was unanimously.

Submitted for Council Action was Ordinance 2015-9, an ordinance allowing additional weekly compensation for the Deputy Clerk Treasurer in the prolonged absence of the Clerk-Treasurer. Following discussion Stivers moved, seconded by Glessner, to adopt Ordinance 2015-9. motion was approved unanimously.

Following discussion, Stivers moved, seconded by Buzzard, that due to a planned medical leave by the Clerk-Treasurer, the current Deputy's pay be increased by twenty five percent of the Deputy's current weekly salary. The motion was approved unanimously.

Morrison reported that IDEM had notified that the current sewer use ordinance would have to be updated. Commonwealth Engineering will be preparing the revision over the next few months and it will then be submitted IDEM to preliminary approval before Council approval. Most revisions center on testing procedures for industrial users.

Trick or Treat hours were set for Saturday, October 31st from 6:-8:00 pm.

Council, by consensus, set leaf pickup to officially start on Monday, October 19th. Utility Manager Poulson stated that

Your attendance would be Ordinance 2015-5. The motion past practice had been to schedule pickup days of Monday and Friday with addition days as necessary through the season. Council concurred.

> Morrison reported that the Board of Accounts State scheduled audit should ending within the week. reported was that the Computer Hardware upgrade has been scheduled for Tuesday, Morrison October 20th. submitted that as she had withdrawn from the Town provided insurance program as she is now covered by Medicare and supplemental insurance. The current Town provider does not have a supplemental policy available. Morrison requested that consideration be given to Town payment of medicare/supplemental costs which would provide substantial savings to the Town. After review of the submitted fact sheet and discussion, Glessner moved, seconded by Buzzard to approve the request.

There are many factors to consider when assessing the trees and landscaping on a property, but many homeowners overlook these unless there is a serious, visible problem. Some of these concerns include: poor past care or previous topping; improper planting of the trees; too much mulch on the root system; damage during construction; wrong tree in the wrong place; insect or disease damage; overwatering from the lawn's irrigation system; or limbs rubbing on the siding or roof.

All of these things can be dealt with after the purchase of a home, but it can be expensive. According to Lew Bloch, a registered consulting arborist in Potomac, Maryland, "Large trees are usually an asset and a valuable amenity to the property, but weak, damaged or diseased trees are actually liabilities."

"If a large tree has a serious defect, removal may be the best advises Andersen. option," "Quite often these defects are hidden from view. They may be underground in the roots, or they could be hidden in the tree trunk. Depending on the location of the tree and other factors, treating or removing the tree can cost thousands of dollars."

This situation becomes dangerous when the hidden defects are so serious that the tree falls over without any warning. This can happen during a severe weather event or even on a calm day. It can cause



heavy property damage or personal injury or fatalities. If your tree falls on a neighboring home, there may even be a negligence lawsuit.

Therefore, before purchasing a home with large trees, always have the trees inspected by a qualified arborist. Most homeinspection companies do not even look at the trees or have the expertise to analyze them. An experienced arborist can often detect the hidden problems mentioned above and outline remedies.

"Obviously dead or declining trees are easy to spot - at least when leaves are out," says Bloch. "Healthy-looking trees structural defects, however, require a professional diagnosis.'

A professional arborist can also advise the new home purchaser about future maintenance the trees will need and how to care for them.

## **TESTING HELP**

New guidelines released in July by the Indiana Breast and Cervical Cancer Program (BCCP) mean more Indiana women are eligible for financial assistance with the costs of diagnosing breast and cervical cancer, state health officials announced today.

The BCCP guidelines allow women who meet age and income requirements to receive breast and cervical cancer  ${\it diagnostic}$ screening and

Please contact Keith or Nancy services. To qualify, women must have a gross income at or below 200 percent of federal poverty level and be between the ages of 30 and 64. Women with or without insurance may qualify for BCCP. To see the federal poverty guidelines, go http://www.in.gov/isdh/19859.

> Breast cancer is the secondleading cause of cancer death in Indiana, with 4,703 cases diagnosed during 2013 alone. Regular medical care can lead to early detection. When breast cancer is detected early, before a lump can be felt, the five-year survival rate is 99 percent.

> Although many women now have access to cancer screening services through health insurance, there still may be financial barriers associated with obtaining diagnostic services following an abnormal cancer screening. These barriers often are associated with highdeductible health plans.Out-ofpocket costs vary among insurance plans, so should talk with their healthcare and insurance providers about the costs associated diagnostic tests.

> "Even with increased access to health insurance, many Hoosier families can't afford the out-ofpocket costs associated with the tests that diagnose cancer," said State Health Commissioner Jerome Adams, M.D., M.P.H. "By expanding the guidelines for the BCCP, we are able to help relieve some of the financial pressure that families face during an already stressful time."

The United States Preventive Services Task Force recommends that women get screening mammograms every two years beginning at age 50. Women with a family history of breast cancer, or who are at increased risk, should talk to their healthcare provider about whether screening at an earlier age is appropriate.

Indiana women ages 18 to 64 have already diagnosed with breast or cervical cancer outside the BCCP may be eligible for financial assistance through the Indiana MA-12 program. Those who in the enrolled Medicaid program receive coverage throughout the duration of their cancer treatment.
