## LICENSE DECREASE

R. Scott Waddell, Commissioner of the Indiana Bureau of Motor Vehicles (BMV), issued the following statement addressing the BMV's alleged overcharges for a standard operator's license:

"We became aware of the possibility that the BMV could be overcharging Indiana drivers for an operator's license, and reviewed existing law to determine the exact breakdown of fees that make up the cost of an operator's license. We discovered a miscalculation resulting in a \$3.50 discrepancy for the six, five and four year standard operator's licenses.

As a result, the charge for a standard six-year operator's license should be \$17.50 instead of \$21.00, a standard five-year license should be \$16.00 instead of \$19.50 and a four-year license should be \$14.50 instead of \$18.00. Effective immediately, we are reducing the fees for all operator's licenses accordingly."



### FSSA INFORMATION

#### BREACH

The Indiana Family and Social Services Administration (FSSA) is in the process of notifying some FSSA clients that some of their personal information may have been accidentally disclosed to other clients. The accidental disclosures may have occurred when RCR Technology Corporation (RCR), a contractor for FSSA, made a computer programming error to a document management system the company supports on behalf of FSSA. This error caused an undetermined number of documents being sent to clients to be duplicated and also inserted with documents sent to other clients. This means some of the clients may have received documents belonging to other clients along with their own documents.

The programming error was made on April 6, 2013, and affected correspondence sent between April 6, 2013, and May 21, 2013. The error was discovered on May 10, 2013. RCR determined the root cause of the programming error and it was corrected on May 21, 2013.

In compliance with federal and state privacy law, FSSA has sent written notices to the 187,533 potentially impacted FSSA clients informing them that some of their personal information may have been disclosed.

The type of information that may have been disclosed includes name, address, case number, date of birth, gender, race, telephone number, email address, types of benefits received, monthly benefit amount, employer information, some financial information such as monthly income and expenses, bank balances and other assets, and certain medical information such as provider name, whether the client receives disability benefits and medical status or condition, and certain information about the client's household members like name, gender and date of birth. Of the 187,533 clients, 3,926 may have had their social security numbers disclosed. This is being noted in the specific letters being sent to this smaller group.

Due to the way the correspondence is printed and mailed, it was not possible to determine specifically which clients had personal information disclosed. Therefore, all of the clients potentially impacted are being notified. It is important to note that just because a client of FSSA received correspondence between April 6, 2013, and May 21, 2013, this does not mean their personal information was, in fact, disclosed in error to someone else; it just means the potential exists.

FSSA clients who receive notifications are being advised of steps they can take to protect themselves against identity theft. This includes placing a fraud alert on their credit report by calling the toll-free number of any of the three credit bureaus. A fraud alert places a note on a credit report for 90 days requiring creditors to verify identity before granting credit. There is no charge for a 90 day alert.

For those clients who may have had their social security

information disclosed, additional advice is being given to them that they could place a security freeze on their credit reports. This can block an identity thief from opening a new account or obtaining credit in the client's name. Any Indiana resident can request a security freeze at no charge by contacting all three credit agencies below either online or by sending a letter:

or want more information.

Any client of FSSA who has received another client's information in error should return this material immediately to their local Division of Family Resources Office. If this is not feasible, the material should be securely shredded.

RCR is in the process of ensuring that none of the affected clients' electronic case files contain information about other clients as a result of this error. The company also is taking steps to improve their computer programming and testing processes to prevent similar errors from occurring in the future.

### DRIVE SAFE

Motorists travelling during the Independence Day holiday and weekend should practice safe driving habits—especially through highway construction zones. Indiana State Police (ISP) will be utilizing special unmarked pickup trucks provided by the Indiana Department of Transportation (INDOT) in a visible construction zone enforcement blitz intended to maximize safety and mobility.

INDOT has directed contractors to pull back barrels and barricades to the safest extent

possible during the heavily-travelled holiday, but Indiana State Police will continue to enforce construction zone safety utilizing all available tools, including pickups in construction zones (PICZ).

The pickup trucks resemble typical vehicles normally seen being used by contractors and INDOT inspectors. Motorists are urged to comply with reduced speed limits, keep a safe distance from other vehicles and avoid driving aggressively. Motorists that fail to do so may meet one of the troopers driving the special pickup truck police vehicles.

Indiana now has nine trucks patrolling various construction zones throughout the state. INDOT and ISP launched the PICZ program in 2011 with converted pickups for traffic enforcement in and near construction zones. INDOT provides the trucks to Indiana State Police as part of their efforts toward reducing crashes and injuries and enhancing safety and mobility.

The trucks are equipped with LIDAR, which is similar to radar but uses laser light to measure the distance between vehicles, allowing police to accurately and consistently determine if vehicles are following too closely. Statistical analysis shows the top cause of work zone crashes to be following too closely.

During the holiday enforcement blitz, Indiana State Police will be specifically looking for drivers who follow too closely, exceed posted speed limits, make unsafe lane changes, drive aggressively and fail to buckle up or to properly restrain children. Troopers will also be aggressively looking for impaired drivers.

To help ensure motorists reach their holiday travel destinations safely, please remember these safe driving tips:

- Make sure you are well rested before traveling.
- Avoid tailgating. Remember the two-second rule.
- Obey posted speed limits, and always use turn signals when turning and making lane changes.
- Make sure everyone is properly buckled up.
- Never drink and drive. If you are going to consume alcohol, make sure you have a designated driver.


