IMPORTANT MESSAGE TO WARREN CABLE TV CUSTOMERS

The co-op that Warren Cable uses is in contract discussions with Viacom, the parent company of MTV, VH1, Comedy Central, CMT, SPIKE, Nickelodeon and TV Land. Our existing agreement with them expires on March 31, 2014. Although we are working to negotiate a fair price for these networks, after March 31, Viacom may turn off their networks or require us to remove all their channels until a new agreement is secured. At this point the two parties are very far apart on price so losing the channels for a period of time is a very real possibility. HTGN Co AG DAY

Huntington County Ag Day will be held at Hier's Park on Thursday March 27. Third grade students from public, private, and home schools in Huntington County will participate in this event.

The Huntington County Extension Office has coordinated an Ag Day event each spring for many years to educate third grade students about agriculture. Individuals who work in agriculture-related fields have volunteered their time and talents to make this program a suc-

There are a total of thirteen learning stations at this event. These stations include topics involving animal agriculture, crops, machinery and food safety. Teachers are provided a question for each topic in advance to help prepare the students. Every child attending the program receives an activity book and other educational items donated by


area businesses and state-wide agricultural commodity organi-

The material presented incorporates academic standards to allow this educational program to be taught outside the traditional classroom. Approximately 40 volunteers will be assisting Purdue Extension Staff with teaching the students.

Many people in Huntington County are employed in farm or farm-related jobs, including production agriculture, farm inputs, processing and marketing and wholesale and retail sales. According to the most recent Indiana Ag Statistics Report (2010), Huntington County farms generated \$145,938,000 in annual crop and livestock income. Huntington County ranks 27th out of 92 Indiana counties for cash farm receipts.

Looks as if winter is going to hang around for a few more days, one thing for sure March is nearly over so surely it has got to get better. March for me is the longest and most tiresome time of the year.

Just this week I received an order of plants and I thought sure with the ground froze who in their right mind would try to plant anything now. I many times have planted peas on ST Patrick day but not this year with a few inches of remaining snow where I could have put them.

Tonite as I set here trying to get inspired to write I can see a beautiful sunset and that is something I really enjoy having a good view of it each evening. Will be glad when I can sit on the patio and with a cup of coffee and really enjoy it.

This week I am having our 4 year great gran here one day and we are going to start flower seeds in pots and hopefully get them growing to plant outside when time is right. This is a 4 year old going on 21 so this may be an experience, but I have all confidence that I will make a gardener out of her. I am certain I might be the one who really get an education, but I will make it a fun day for both of us. In all this snow and cold weather I do have spring bulbs coming up and some of the hyacinth I can see the blooms forming and for sure they will get nipped from the cold or frost a few times but they are strong little guys that can stand the cold.

This week it has been a real struggle to think of something to write and hopefully next time I will do better for my faithful readers which I appreciate very much. It has been 6 years that I started this column and as I have told a few I have dug up all "printable" memories of my family so bear with me till next time.

Soon we hope the fresh veggies will be coming off the early garden and I especially like on my salad of fresh greens the dressing I make. It is like French Dressing . It takes 4 teaspoon of grated onion, 2 teaspoon paprika, 1 teaspoon salt, 2 cup sugar, 1/4 cup lemon juice, 1 cup catsup, 2 cups oil, 1 cup vinegar, 1 tablespoon celery seed, put all in blender except for the oil, Blend for about 1 minute or bit longer making sure it is all mixed in well. Last slowly add oil while blender is running on slow speed. This will make about 2 pints and I generally make half recipe each time. This is good on salads and also tasty on fried potatoes. This sometimes turns out rather thick if so add a bit more oil to make it a good consistency for pouring.



Being Prepared

As part of Severe Weather Preparedness Week, the Indiana Department of Homeland Security advises Hoosiers to locate important documents before disaster strikes. Having access to these documents can expedite the recovery process.

According to a 2013 survey of Hoosiers, more than half of Indiana households who responded did not have important and hard-to-replace documents safely stored and had not included copies of them as part of a preparedness kit in the event of a disaster or emergency. It is helpful to have these documents organized and safely stored regardless, and now can be a good time to set a goal of gathering these documents as part of tax preparation.

"Having important financial and other documents organized in a safe place can be very helpful in the event of an emergency," said IDHS Senior Public Information Officer John Erickson. "We also encourage Hoosiers to have copies of important and hard-to-replace documents in a 'grab-andgo' box or folder should it become necessary to quickly evacuate their home. The November tornadoes are an example of the importance of having vital documents stored properly."

Below is a list of important and often hard-to replace documents to consider making copies of so they can be taken along in the event of an evacuation. Erickson says a binder, expandable file or box is fine, as long as it's portable and to remember that most of these documents will be copies. He adds to always be sure to store originals in a secure, dry place like a fire safe or lockbox. Having important information in one place is invaluable, whether or not there is an emergency. IDHS suggests gathering and copying:

- Vital records: birth certificates; marriage licenses; passports; adoption records; property and auto records (deeds, titles, leases); insurance policies (auto, home, renter's, umbrella policies)
- · Document locator: tells others where originals are stored
- Financial information: list of all bank account numbers; copies of the front and back of each credit card; list of all retirement, pension, investment account numbers; mortgage and loan information; payroll and benefit information
- · Medical information: copies of health, life and disability insurance cards and policies; medical history of each family member; list of medications and prescriptions, including dose and pharmacy; details about any ongoing treatments or conditions
- Contacts: contact information for friends and extended family members; neighbors who have access to your home; physicians and specialists; financial


