

FLU SHOTS

Seasonal Influenza Vaccine Clinic at the Cove of Heritage Pointe

The Huntington County Health Department will have a Flu Shot Clinic at the Cove of Heritage Pointe, on the first floor, under Applegate Chapel. on Thursday, November 7th from NOON to 2:30 P.M.

This event is open to the PUBLIC.

The NEW 2019 Fluzone Quadrivalent Flu shots will be only \$32 (for age 6 months & older), CASH or CHECK. The Health Department can bill many Privately Insured patients, or you may send your bill in to your Insurance Plan for reimbursement.

Please bring ALL of your current Insurance, Medicaid and Medicare cards. For uninsured patients there is a fund to subsidize them for only an \$8 copay.

Residents of neighboring counties are welcome! You do not need to be a Huntington County resident.

If you have questions about vaccinations, or insurance coverage, you may call the Health Department at 260-358-4831 ext.#1.

This service is provided by the Huntington County Health Department.

BMV SCHEDULE

The Indiana Bureau of Motor Vehicles (BMV) announced today most branches will extend hours of operation on Monday, November 4 and Tuesday, November 5. Branches in counties holding elections in the November general election will be open to issue ID cards and driver's licenses to be used for identification at a polling place. Branches hours on Monday, November 4, will be from 8:30 a.m. to 8 p.m. and on Tuesday, November 5, from 6 a.m. to 6 p.m.

The following branches do not have scheduled elections in their counties and will be closed on Monday and Tuesday of election week: Fowler, LaGrange, Rockville, and Loogootee.

Branches in Morocco and Williamsport will be open for

normal hours and operations on Monday, November 4, but will be closed for the Election Day holiday on Tuesday, November 5.

As required by state law, branches with extended hours will only process new, amended, or replacement ID cards, and renewed, amended, or replacement driver's licenses and learner permits. New driver's licenses and learner permits will only be processed provided the customer has previously completed all required testing. Customers who are required to take a knowledge or driving skills exam to obtain or renew a license may choose to apply for a free ID card to use for voting purposes.

Individuals who hold a driver's license or ID card that expired after the last general election may use the expired card as proof of identification for voting purposes. The paper interim credential issued at the license branch at the time of the transaction or after a customer has completed an internet credential transaction is also acceptable proof of identification for voting purposes.

The Indiana BMV provides free, state-issued ID cards for voting purposes to any unlicensed Hoosier who is a U.S. citizen, who can provide proper documentation, and

who will be at least 18 years of age on or before the next general or municipal election. The following documents are required to obtain a new state ID card or driver's license.

Proof of Identity document, such as a birth certificate or passport.

Proof of Social Security document, such as a Social Security card, pay stub, or W-2.

Proof of lawful status, such as a birth certificate or passport.

Proof of residency, two documents such as a voter registration card, utility bill or bank statement.

If your name has been legally changed and now differs from your identity document(s) (i.e., birth certificate or passport), proof of name change must be provided in order to obtain a state ID or driver's license

A complete list of documents required to obtain a new state ID card or driver's license can also be found at IN.gov/BMV. All branches will resume regular business hours on Wednesday, November 6.

horrible time and risked everything. And somehow, in the middle of all that, people found love. That's incredible!" THE ICE CREAM MYSTERY TRIP

Day #2 - by Larry Ryan
We left Syracuse at 8am, wearing sunglasses for the first time. The bus headed north on I-81 towards Watertown, NY, a city that is only 30 miles from Canada. The driver skirted around this community, passed through a section of Fort Drum where soldiers were active in military maneuvers. We turned east onto Highway #3A and soon onto #3 northeast. My mind jumped to the possibility of landing in Burlington, Vermont and the home of Ben & Jerry's Ice Cream business. Also, I have never been to Vermont.

To digress from the travelogue, we witnessed a medium-sized, propeller airplane planted in someone's backyard. No airport access! Of course there were weeds growing all around it as if attempting to camouflage it. Near the Mexico, NY exit, a road sign read, "Tinker Tavern Road." It sounded inviting after riding on a bus for two days.

The bus did not stop however. Also saw a vital bumper sticker that read, "No Farms, No Food!" So true!
Much of this area resembled Upper Michigan. Snow fences appeared on the north side of the highway. We entered the huge Adirondack Park. A guide reported that this park is larger than Yellowstone and Yosemite combined. Passed "Wild Fever Café" at Star Lake village, the "Thirsty Moose Tavern, and the "Irish Pub" at the town of Tupper Lake. However, I was on "Moose Alert." The first person to

site a live moose was rewarded with a left-over chocolate cookie. It never happened. The mountain streams were now shallow and consisted of clear, running water with an assortment of imbedded rocks in the way of the onrushing water. Many roadsides contained numerous yellow-blossomed wild flowers. Much of this area in NY State was marsh land. But on higher ground, a hilly golf course appeared.

While passing through the large village of Saranac Lake, NY, the bus turned east on Highway #86. In short order we were in the Olympic town of Lake Placid, NY. The Adirondack Mountains surrounded us. The main street bordered Mirror Lake. Our tour director allowed us to depart the sequestered quarters to investigate and shop in this historic tourist community until our hotel rooms were ready. One store stocked Amish Popcorn from Berne, IN. We discovered Emma's Ice Cream Parlor to satisfy the Mystery Trip advertisement. We were also saddened to learn that the Ben & Jerry's parlor was closed! All 1000 flavors were missing.

Our group of travelers met our three local tour guides who, in turn, led a group through the Lake Placid Ice Arena. Ice in the 1980 rink was very cold and white in color. Youthful, hopefuls were skating in full hockey gear. One young show-off

fell right in front of us at the wall. His heavy, protective clothing prohibited him from getting back on his feet easily. This rink was special! It is where the younger USA hockey team won the 1980 Olympic Gold Medal! They surprisingly beat the USSR and Finland. The movie, "Miracle On Ice" revisits that time in history. The Russian network news did not disclose the loss to their population for weeks.

The 1932 ice rink in the same building was the first dedicated indoor skating rink in the world. Its ice content was slightly softer and had a grayish hue to it which allowed the figure skaters a better view of contact with the surface of the ice.

Our bus picked us up in midtown and delivered us to the Mirror Lake Inn. After a buffet dinner, everyone went down the hotel steps, across the street for a photograph. We were surprised by a torch-bearing young, Olympic luge-training girl from Auckland, New Zealand also descended the steps, crossed the street and handed the burning torch to one of our group members. Each person, in turn, handed it to another until it finally reached our tour director. He climbed ten steps and lit a propane-fired caldron. We had our own official Olympic Opening Ceremony at Lake Placid!! My wife obtained the foreign girl's autograph. I scouted out two lakeside

chairs where we spent an hour admiring our view of the calm lake and on-coming lights of the businesses that were established around the curving shoreline. More next week.
