Local businesses allow the monthly Menu to be placed in their establishments and that really helps. We are also helping the Food Banks in Warren, Markle and Van Buren as well as help families in need with extra boxes we order.

In November, in addition to being able to buy the Regular Units, Senior Boxes and Specials, Angel Food Headquarters is announcing a special Thanksgiving Box that can be purchased for \$30. This will be a complete box of food to feed 4-7 people. The Box will contain: 7 lb. Roasting Hen, 2 lb. Cream Corn Seasoned (heat & serve), 2 lb. Green Beans (heat & serve), 2 lb. Mashed Potatoes (heat & serve), 17 oz. Corn Bread Dressing (cook & serve), 8 Dinner

Rolls, Gravy Mix, 15 oz. Cranberry Sauce (frozen) and Holiday Pie. You may want to consider buying one of these for a family in need who could use this special meal. All this food for just \$30!! What a blessing!

Rapidly changing technology, inexpensive electronics and planned obsolescence all contribute to a growing problem: hazardous junk electronics are being dumped into our landfills.

Electronic waste has become a real problem and it's getting worse. While electronic waste represents 2 percent of our trash, it contains 70 percent of the toxic waste in America's landfills. These toxins include up to 38 separate chemicals including lead, mercury, cadmium and PCB's.

Some states have already banned specified electronics from landfills due to the fear that heavy metals will eventually leach into groundwater. We expect this trend to continue with violators being prosecuted. We may even see the day when the offending electronics are traced to the dumper and costly cleanup penalties levied.

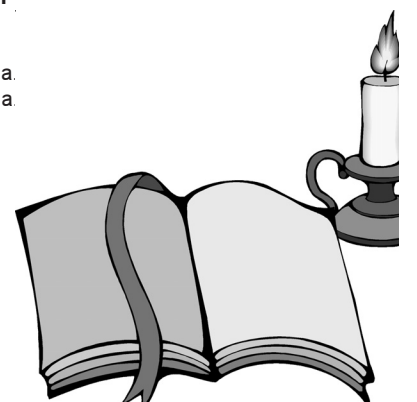


