KUDOS, KICKS & KARATS

DEAR EDITOR.

What does a youth have to go through to reach a point of thinking running away is the only answer? How alone and desperate they must feel if living on the streets would be better than remaining in their current environment. What if you are a parent whose child has reached that point and has run away? What goes through their minds? Do they too feel alone and desperate?

Many people feel that these are issues that only big cities face. Is it because we don't have young people living in alleys or under bridges? Or is it because we don't have youth panhandling on every corner? Sadly, Huntington County DOES have young people running away and Irving on the streets. They are living in cars, bouncing from friends and family members' homes, living intents at the camp grounds, wherever they can find to keep warm and dry. They are surviving by whatever means they can find to make it through another day.

The Youth Services Bureau of Huntington County offers the Safe Place and Host Homes programs. These programs provide immediate crisis intervention for youth who are thinking about running away or in need of assistance during family or peer conflicts. Throughout the county there are 49 businesses who proudly display the large yellow Safe Place signs. These businesses are able to provide a safe, supportive environment for youth until a Safe Place volunteer can arrive at the business. At that time, the volunteer assesses the situation mid provides whatever is needed to ensure the youth remains safe and obtain the services needed. If the youth is in need of a safe place to stay while their situation is being addressed, the youth may be placed in a Host Home. Host Homes are families who open those homes voluntarily on a short-term basis for youth in crisis.


The Youth Services Bureau is also working collaboratively with the National Runaway Switchboard. This allows a youth to contact a toll-free number (1-800-621-4000) anywhere in the United States and be directed to a local agency that can assist them.

November is National Runaway Prevention Month. This important initiative is designed to increase the awareness of the issues facing runaways and to educate the public on the services available and the community's role in preventing youth from running away.

Huntington County is known for helping their own, for providing support and encouragement to others. This is one area that can not be ignored. The youth of Huntington County need to know they are a vital part of this community. They need to know that churches, businesses, civic groups, departments, schools, local government and the community as a whole are there to provide them with support and guidance. Families need to know they too have the support of the community.

OUR HISTORY

MAILING DEADLINES

The Warren Postmaster reminds families and friends sending holiday packages and letters to servicemen and women overseas that the first mailing deadline is less than two weeks away.

Monday, Nov. 13, is the deadline for sending holiday packages to troops stationed overseas using Parcel Post to all Air/Army Post Office (APO) or Fleet Post Office (FPO) ZIP Codes.

"The U.S. Postal Service is encouraging early deadlines," said Warren Postmaster Stephanie Bauman, "to make sure packages reach their destination in time for the holidays."

One way Warren residents can confirm delivery is by using Delivery Confirmation. For the first time the Postal Service has made Delivery Confirmation available for almost all military destinations outside the United States. Delivery Confirmation provides customers with the date, ZIP Code and time the package was delivered. This information can

be accessed online at www.usps.com.

"Mail is one of the greatest morale boosters we can give our troops during the holidays," said Postmaster General John E. Potter. "When they see packages or letters waiting for them it brings them that much closer to family and the comforts of home."

The U.S. Postal Service has also introduced a Military Care Kit, or "Mill-kit" in 2004 to make it easier for military families and friends to send care packages to their loved ones stationed overseas. Since the inception of the Military Care Kit, the U.S. Postal Service has shipped more than 150,000 kits. Each kit contains four Priority Mail boxes, six Priority Mail Flat Rate boxes, 10 Priority Mail labels, one roll of Priority Mail tape and 10 customs forms with envelopes.

This kit may be ordered by calling the USPS Expedited Package Supply Center at 1-800-610-8734. There is no charge for the kit.

The Priority Mail Flat Rate boxes included in the kit can be shipped to any APO/FPO in the world, regardless of weight, for \$8.10.

All packages and mail must be addressed to individual service members, as required by U.S. Department of Defense regulations.

The Postal Service places APO/FPO mail on special charter flights, commercial airlines and military service aircraft to reach armed services members overseas as quickly as possible.

The military mailing deadlines include: November 13 – all Parcel Post packages. November 27 for Space Available Mail (SAM); December 4 for all Parcel Airlift Mail (PAL) and First Class Mail Letters/Cards and Priority Mail to APO/FPE AE Zip 093. December 11 is the deadline for all other First Class Mail Letters/Cards and Priority Mail. December 19 is the deadline for Express Mail Military Service (EMMS) to all APO/FPO Zips except 093.

Express Mail Military Service (EMMS) is available to selected military post offices. Local Post Offices can determine if this service is available to an APO/FPO address. The information also is available by calling 1-800-ASK-USPS.

Parcel Air Lift (PAL) is a special service that provides air transportation for parcels on a space-available basis. It is available for Parcel Post items not exceeding 30 pounds in weight or 60 inches in length and girth combined. The applicable PAL fee must be paid in addition to the regular surface rate of postage for each addressed piece sent by PAL service.

Space Available Mail (SAM) are parcels paid at Parcel Post rates that are first transported domestically by surface and then to overseas destinations by air on a space-available basis. The maximum weight and size limits are 15 pounds and 60 inches in length and girth combined.

MY TOWN and Yours

BY DENNIS STROUD

After Albert Border sold the Mystic Theater there was several owners until January of 1937. Clair and Jesse Stucky bought the theater and changed the name to the Savory Theater. They, also, owned the Palace Theater in Montpelier, Indiana. In 1939 they tore down the last of the framed two story wood buildings on Wayne Street, next to the bank, and started clearing the land for a new moving picture theater. The old wood building for years belonged to Joseph Coles, father of Albert Coles. Joseph Coles was postmaster in Warren from 1862 to 1864 and kept the post office in that building. Joseph Coles, by trade, was a shoemaker and the building was used as a shop.

While the site for the theater was being prepared it was mentioned in the paper that the dirt being taken out was part of the fill that was made many years before when the site was part of a ravine which extended from the corner of Third and Main, where the Library now stands, to the river. That ravine crossed Wayne Street in a diagonal direction, about where the Pharmacy is now, and ran back of the old Exchange Bank lot.

That is why Main Street is over a block and after the ravine was filled the main city block was moved to Wayne Street.

Work on the new Savory Theater took about a year. The new building had a Wayne Street frontage of about forty feet and was one hundred and thirty-two feet deep. The front had two small business rooms with the theater lobby in the center. The auditorium was one hundred feet in depth and forty feet wide with a seating capacity of about five hundred people.
