## TAXES NOT DUE IN MAY

Huntington County Auditor, Kathy Juillerat, and County Treasurer, Cindy Yeiter, presented information to Huntington County Council that property tax bills would not have a May 10th deadline this year at the Council meeting held Monday, March 24th in the GAR room of the Courthouse.

State Legislators voted in the last session to remove some of the school rate and welfare rates from the local tax rate which will in turn, reduce 2008 property taxes across the State by about 30%. This was voted on March 14, 2008, now it is up to the DLGF to rebuild local tax rates and distribute. Huntington County was able to get the assessed valuations down to the State the middle of March. Normally it would take the DLGF four months

to issue tax rates, but they are going to try to get them out two months after they receive a counties AV's.

We can not set a deadline at this time, but are hopeful it will be sometime this summer.

In the meantime, if people would like to make an advance payment towards their taxes, it would benefit their personal budget, as well as allowing the County to make Advance payments to schools and other local entities who will need a draw. Anyone wishing to make an Advance payment, please have into the Treasurer's Office by Monday, May 12, 2008. How much to pay? If your bill last year was say \$300 a half and there could be a 30% reduction this year, you might want to only pay \$200.

Any advance payments made will be reflected on the regular tax bills sent out as a payment under the paid column. If there is a balance owed, it will be in the lower right hand corner of the bill.

Starting this year, and every year thereafter, a Property Tax Statement Comparison will be mailed with every tax bill. Also, all homeowner's who have escrowed accounts with their mortgage company, will also be receiving tax bills and comparison statements beginning this year.

We have 11 area churches and 9 local businesses that have "Information Racks" that hold Menus, Brochures, Rules and Order Blanks for your taking. You can also call Janice Jordan, Director of Warren Angel Food Ministry at 375-2293 or Gerald Moreland at 224-4844 to help answer questions about the Warren Angel Food Ministry.

3. WILL THIS HURT THE BREAD OF LIFE FOOD PANTRY? No, no, no! In fact we are working with them to supply information about this food ministry and they have said they may be able to use some of their cash donations to purchase food from WAFM in the future or folks may buy a unit and give to the food bank as a donation of food. They have an AFM information rack at their site. We are all working together to help feed folks. They also have a freezer to store the frozen items in the AFM menu.

4. WHAT PROFIT DO YOU MAKE ON THIS MINISTRY? Someone asked what the churches are making on this and the question is NOTHING! AFM headquarters gives us \$1 per unit ordered to use to recycle into helping families who are in real tight financial needs. We intend to do just that. We'll buy extra units with the dollar return and seek out families we can help. 30 Units would allow us to buy a \$30 unit for someone in need. The Food Bank will help us and the churches will do the same. If you know of a family really needing some help with food, let us know and we'll try to help.

5. HOW CAN WE HELP? A ministry like this will take lots of volunteers to help unload the semi when it arrives on Saturday mornings, set up the tables, greet and guide people, fill the food box orders, carry out orders for those needing assistance, clean up afterwards and many other little jobs. Let Janice Jordan know if you want to get in on some great fellowship time with town and church folks on Warren Angel Food Ministry Distribution & Pick Up Day.

### COUNCIL NOTES

On Wednesday evening, March 19, the Van Buren Town Council met in the Council Room at Town Hall. At 7 p.m. president Tony Manry called the meeting to order and all in attendance repeated the Pledge to the American Flag. Minutes of the previous meeting were approved as submitted.

A citizen in attendance told Council that June 21 is skateboard day. They asked if they could block off East Vine Street between First and Washington Streets. Council granted permission.

Officer Pat Collins, in his police report, said that an additional \$569 was needed over and above the \$3,995 grant for a radio. Council approved the amount.

Van Buren Town Clean-up days will be May 17 and 18.

The next Council meeting is set for April 2.

### QUILTED WEARABLES

The Purdue Extension Service of Blackford County is sponsoring a program on Quilted Wearables. ### TREE ID WORKSHOP

Purdue Extension will be holding a tree identification workshop at the Northeast Purdue Ag Center near Columbia City. Woodland owners, landscape enthusiasts, students and others interested in trees are encouraged to attend. The workshop will feature identification tools and tips using live plants and digital photos. Participants will be given an overview of diagnostic terms and work through identification keys. The emphasis of the program will be on native trees of Indiana.

Participants will also be able to review the new "Trees of Indiana"

video CD produced by the Purdue Forestry Department. The CD features over 1000 images that illustrate leaves, buds, twigs, flowers, fruit and habitat of Indiana's native trees. Field guides and other reference material will also be on display. The instructor for the workshop is Tom Eickholtz with Purdue Extension Steuben County. Eickholtz is an ISA certified arborist.

The program is free to attend and open to the public. It will be held on Thursday evening, April 3rd from 7:00 to 9:00 PM. The NEPAC facility is located at 4821 E 400 S, Columbia City. Participants are encouraged to pre-register and can request a map to the site by calling the Steuben Office at 260-668-1000, ext 1400. 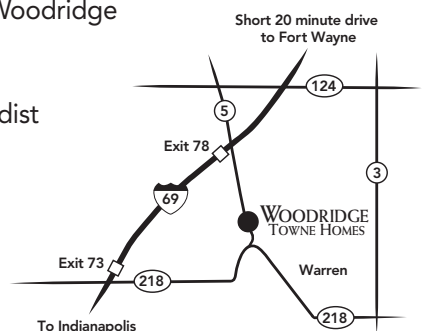

### VOLUNTEERS NEEDED

Imagine you are three years old. You are left at home alone for days to fend for yourself. What would you do?

Imagine being eight years old. You can hardly walk because your arms, legs, and back hurt from being beaten the night before. What would you do?

Imagine being 10 years old. You were sexually molested the night before by a family friend who was babysitting. You tell your mom the next morning that you aren't feeling well and don't want to go to school. Your mom asks what's wrong. What do you say to her?

As unreal as these scenarios may seem, they are very real to some children in Grant County. In 2007, CASA of Grant County, Inc. had 217 children who can speak to how real child abuse and neglect is. Actually, not all of them are old enough to speak but the abuse and neglect is unfortunately evident. There are many more cases that were handled informally that did not go through the court system. There are even more cases that have never been reported.

CASA of Grant County, Inc. is a local not-for-profit organization that utilizes volunteers to provide advocacy on behalf of children who are involved in the court system due to abuse and/or neglect. Currently, we have 100 children waiting for an advocate.

Being an advocate requires no special knowledge or background- we provide the training and support you will need. To be an advocate is a tremendous responsibility. Once

assigned a case, the role of the advocate is to investigate the case, speaking to neighbors, teachers, family, social services, doctors, etc. and developing a relationship with the child.

Investigating the case is not determining whether or not the abuse or neglect happened- we already know it did. Investigating the case is a fact-gathering process that enables the Court Appointed Special Advocate to make a recommendation to the court concerning what is in the child's best interest regarding permanency, safety, and stability.

Being a CASA volunteer is by no means an easy job. It is however, something that can make a lifelong difference to a child.

CASA is currently accepting applicants for our April and

### BOAT PERMITS

As prime boating season approaches, those who plan to boat in Indiana should take note that if they plan to use state park, reservoir or forestry lakes, they must purchase a DNR Lake Permit.

As of January 2006, the DNR no longer issues daily or annual boat launch fees for lakes at state parks, reservoirs and forests. These launch fees have been replaced by a DNR Lake Permit, which costs \$20 per year for each motorized

watercraft lake permit and \$5 per year for each non-motorized watercraft lake permit. Boaters only need to buy a permit one time per year; not each time they visit one of these lakes. This allows boaters to launch and get on the water with no delays to pay attendants—and no waiting for others to pay attendants.

All private watercraft using state park, reservoir or forestry lakes must have this permit. This includes personal watercraft, motorboats, canoes, paddleboats, rowboats and all watercraft moored at marinas, private docks, group docks or bank ties. State-owned watercraft and state-managed boat rental concessions are exempt.

The permit should be placed on any boat that will be on the water at Indiana state parks, state-managed reservoirs or state forests. This includes the main bodies of water and all fishing ponds/lakes at these lakes: Patoka, Brookville, Hardy, Monroe, Salamonie, Mississinewa, Roush (Huntington), Cagles Mill (Lieber) and Cecil M. Harden (Raccoon).

It also includes Worster Lake at Potato Creek State Park; Kunkel Lake at Ouabache State Park; Summit Lake at Summit Lake State Park; Versailles Lake at Versailles State Park; Ogle and Strahl Lakes at Brown County State Park; Lakes Shakamak, Lenape and Kickapoo at Shakamak State Park; all lakes at Chain O'Lakes State Park; Spring Mill Lake at Spring Mill State Park; Whitewater Lake at Whitewater State Park; and Lake Lincoln and Weber Lake at Lincoln State Park.

All lakes at state forest properties are also included: Deam Lake SRA, Ferdinand State Forest, Starve Hollow SRA, Harrison-Crawford State Forest, Clark State Forest, Greene-Sullivan State Forest, Jackson-Washington State Forest, Martin State Forest, Morgan-Monroe State Forest, Owen-Putnam State Forest, Pike State Forest and Yellowwood State Forest.

A number of locations around the state with public access sites that are maintained by the Division of Fish and Wildlife (DFW) don't require this permit. Those planning to boat only in these locations and not in any of the locations listed above don't need a lake permit. The permit is not required for boating on Indiana streams and rivers. It is not required for boating on the Ohio River. Natural lakes such as Lake James, Lake Wawasee and Lake Michigan do not require this lake permit. Lakes located in state Fish and Wildlife Areas that are operated by the DFW don't require this permit, nor do lakes at National Forests and U.S. Fish and Wildlife Refuges.

All boaters must still register their watercraft as the law requires through the Indiana Department of Motor Vehicles. The Lake Permit does not replace that registration process; it replaces the daily and annual launch permits for state park and reservoirs properties that were sold prior to 2006.

It is best to purchase the permit in advance of visiting a lake, if

possible, to ensure that you are in compliance with the requirement. The Lake Permit is available for purchase at state park, reservoir and forests at property offices and entrance gates when staffed. It is also available at the Customer Service Center in the Indiana Government Center in Indianapolis and at [store.dnr.state.in.us](http://store.dnr.state.in.us). At the beginning of the recreation season, attendants will be at some launching ramps to sell these permits, but not at every ramp or every day. State forest property offices may not be open on weekends and on some weekdays.
