### BEQUEATH MORE THAN MONEY

### GIVE SPIRITUAL WEALTH IN AN ETHICAL WILL

Legal wills are usually cold documents that do little to comfort loved ones left behind. If you want to do more, consider preparing an ethical will. Both writers and recipients of ethical wills say they are an invaluable legacy.

Ethical wills go back to Biblical times. But today, there's heightened interest in leaving heirs a testament of values and beliefs. Barry Baines, medical director of a hospice in Minneapolis and author of Ethical Will: Putting Your Values on Paper (Perseus Publishing) says these are some of the topics they often express:

- · Values and beliefs, what you think is most important in life.
- · Lessons learned, what life has taught you.
- · Love for survivors, what family and friends have meant to you, and what you hope for them in the future.
- · Forgiveness, what you want to forgive and be forgiven for.
- · Explanations, why you made the choices you did.
- · Anecdotes, stories about times that shaped your life or humorous events you want preserved as family lore.

There's no single right way to write one. Just make sure it comes from the heart, says Baines. Don't criticize, cause guilt, or tell people how to behave.

You don't have to write, you can record it or make a videotape. Some people make one ethical will to be read by all. Others write them in the form of a letter to each child or beneficiary.

Ethical wills are not legally binding, but many attorneys encourage clients to write them as additions to their regular wills. They help with estate planning and incorporate statements that indicate motivation.

The ethical will is a way to leave something behind that lasts longer than any money you leave, and it may be much more valuable to the recipient.

### What part of 'no' don't you understand?

It's one of the simplest words in the English language, only two letters long, and with an obvious meaning.

At least you would think the meaning of no is obvious. But some people think the meaning of no is maybe. That's what John Gray, Ph.D., says in his book Mars and Venus in the Workplace (Harper). Men (from Mars) are likely to classify a no as a maybe or a not-yet. That could get dicey when it's the boss using the two-letter word. But men, says Gray, are more likely to push for what they want.

Women (from Venus) are more likely to hear no when the boss says it. At least they are more likely to take it literally than a man would, says

His advice: Whether you are a man or a woman, consider no to be a starting point. It could be possible to change bosses' minds if you listen to their objections and provide new facts or views.



### GROUND BEEF REMINDER

Although Indiana is one of the 21 states where the recalled ConAgra ground beef was distributed, Hoosiers can avoid becoming sick from E. coli bacteria if they handle all ground beef carefully and cook it thoroughly.

The recall of nearly 18 million pounds of ground beef came after an earlier recall by the company of 354,200 pounds of hamburgers from the same plant in Greeley, Colorado. ConAgra issued that voluntary recall June 30th after an outbreak of E. coli that sickened at least 18 people.

No cases of E. coli linked to ConAgra ground beef have been reported in Indiana.

E. coli bacteria is a potentially deadly bacteria that can cause bloody diarrhea and dehydration. The very young, seniors, and persons with compromised immune systems are the most susceptible to foodborne illness.

Scott Gilliam, manager of the State Department of Health's Food Protection Division, says people can avoid becoming infected by the E. coli bacteria if they follow these guidelines:

Use a separate cutting board to prepare raw meats.

Cook all ground meat thoroughly (particularly ground beef). Ground beef should be cooked to at least 160°F. The most accurate way to determine the doneness is to use an instantread thermometer

· If the temperature cannot be checked, cook ground beef until the juices run clear, and the inside is gray or brown throughout (not pink).

Use a clean plate for cooked meat. Never return cooked meat back to the same plate used for

raw meat.

If you are served an undercooked hamburger in a restaurant, send it back for further cooking

Marinade or BBQ sauce used on raw meat should not be used on cooked meat.

Gilliam says that consumers who think they may have any of the recalled ground beef should contact the store where it was purchased to arrange for a refund.




