The 37th Annual Van Buren Popcorn Festival will be held Aug 13-16.

The parade kickoff will begin at 6:30pm Thursday night. With the festival theme of "Remember when...reminiscing festivals past" our Parade Marshal will be Glenda Duckwall-Giggy. Glenda was the 1st Popcorn Festival Queen in 1973. Other events brought back from the past are the cake walk, the bed race, Scarecrow Contest and a Community Celebration Service Sunday morning.

The usual children's events are scheduled throughout the festival this year including Big Wheel Race and Pedal Tractor Pull. For old and young alike there is the Bike Parade, Baby Parade and Pet Parade. New interactive entertainment this year for children is Sweetwater's Interactive Magic Show and Rudi Toonz, a Kid's interactive concert. As always, all nightly entertainment is absolutely free. Harness Family Band will return on Thursday night after the parade. Friday night, first up is Upward Praise Band and then immediately after "Frankie and the Bananas" will be performing on stage.

Saturday night the entertainment begins at 6:30 pm with Rudi Toonz, then a new addition, T.R.S.S. Drum Corp. If you have not seen them, be prepared to be blown away with the magnificent, high energy talent of these young men and women from Ohio. Then back this year is a local favorite, Cook and Belle and rounding out Saturday evening is a Street Dance featuring Gary Monroe.

The ever popular Kid's Safety Festival and Farm Festival have been combined this year. Many great things are planned for both events which are held in the Town Hall and Lion's Club parking lots. There are always many things to do and see at both. One new attraction Saturday afternoon will be the Indianapolis "Colt's In Motion" Interactive Museum, 42' traveling Colts museum with interactive displays, memorabilia, NFL equipment, Colts factoids, and much more.

COUNCIL NOTES

On Wednesday evening, July 22, the Van Buren Town Council met in the Council Room at Town Hall. At 7 p.m. President Tony Manry called the meeting to order. All in attendance repeated the Pledge to the American Flag.

Stephanie Beck was in attendance and reported to Council that the State Board had completed their audit of the Library books. The Board reported no problems and could see no reason for the firing from the Library. It was reported they found no evidence of any misdoings.

Council is considering changes in the Animal Control

Ordinance. This would include raising the fee if animals are found in violation of the Ordinance.

A Skate Board Ordinance recently submitted by Officer Pat Collins was tabled until later.

Superintendent Jim Webb said all meters had been read in July.

Webb submitted three quotes for paving of West Main, Wayne and Depot Streets. Also quotes for new street signs. No action was taken at Wednesday's meeting.

Engineer John Huston was in attendance and submitted plans for a new storm drain project.

The Garfield statue on the Library lawn has been taken down for major repairs. The entire statue was believed to be made of fiberglass. It was learned that the damage was caused due to Styrofoam becoming wet, causing water damage to the statue.



THE UPTOWN GARDENER

Certainly was nice to have the needed showers this past week. Our green beans seemed to go dormant, they had blooms but no beans. I can see some setting on now and lots of blooms. Soon it will be back to canning which I like doing. I finally got to pick the first tomato and what a nice treat. Could hardly wait to have a nice juicy hamburger and a thick slice of tomato on it.

I now use the potatoes out of the garden and dig them as I need them. They are of nice size so far. We will probably plant them in straw again next year. I will remember to put more straw down as some of them are into the soil and need to dig them, but the straw kept the weeds down and that was a big plus.

When I checked the cabbage some of the heads had split so I have the freezer slaw made and put away. It always tastes good later into the year. I also shred some and freeze to have steamed cabbage later. Soon I will have the ingredients for the Governor Sauce that I make and is a big hit at the farmers market. I can see I have some busy days ahead of me.

When I do canning I can't think of how much easier it is from when it was in the younger years. I have a pressure canner now and at home we used the copper wash boiler, that way we could get more jars in it at one canning. Now it is a few minutes for most things compared to hours the old way.

We had a neighbor who lived across the creek from us, they lived in a two room log cabin and she had an outdoor oven/cook stove. It was made of cinder block with one end open to put the wood in and a huge flat piece of iron to cover the top. In spring thru fall she did most all of the cooking and

canning outside. Inside she had a wood fueled cook stove, but it would get very warm in the cabin even without the stove being used. The cabin had a tin roof and it got pretty warm. She also had a metal box of some kind she used on the outdoor oven. That dear sweet hard working lady could make the most delicious cakes, pies and bread in that oven. You could smell all that good stuff up the road to our house. We about always knew what they were having for dinner and supper if the wind was in the right direction. In the winter months the aroma of bread baking and food cooking inside the cabin was a warm and welcome feeling. Nothing was better than a slice of warm fresh bread and churned butter to ease the hunger feeling and get you headed back up the hill towards home.

Their water supply was from a spring that was down hill from the cabin. They had cut crudely made steps out of the hill to make it easier to carry up the water for use in the cabin. That water was always very cold and tasted good. I many times helped carry water up the hill for her and that was quite a chore for a little kid. Made me appreciate the pump we had at home just a few steps out the back door.



Don't think I will do any complaining at canning time now that I think back about the yesteryears how hard she and my mother worked putting food away.

Here is how I make my freezer slaw, we enjoy having it stashed away to help fill in a meal.

1 head of cabbage, 1 good size carrot, 1 green pepper, all shredded fine. Sprinkle a teaspoon salt over it and let set

for an hour. Make a syrup of 1 cup white vinegar, 2 cups sugar, 1 teaspoon celery seed, 1 teaspoon mustard seed, boil 5 minutes let cool and drain off all the liquid you can from the vegetables, add the syrup and freeze in the desired amount portions. It will also keep in the refrigerator for a short time best used that way in a couple days. I also use this same recipe only instead of cabbage I use pickles. It is good to drain it and add a bit of mayonnaise to have on sandwiches. You can freeze it but do not add the mayo until ready to use it.
