## COUNCIL NOTES

On Monday evening, April 10, the Warren Town Council met at 6:30 p.m. in Assembly Hall. The meeting opened with all in attendance repeating the Pledge to the American Flag. President David Scheib conducted the meeting.

Minutes of the regular meeting of March 27 were approved as submitted.

President Scheib thanked local crews for the quick response Monday afternoon to a power outage in one area of town.

The Park Board met prior to the Council meeting. Kim Coolman reported to Council that the Park Board had received a calendar of all Sportsman Club activities for the entire year. The Park Board plans to have a flyer available and anyone interested in projects at the Park are welcome to participate.

The next Park Board meeting will be May 8.

A final contract is expected soon from AEP negotiations.

Tax rate is being advertised. The local rate had not changed since the state approval in January.

Ordinance 2006-3 established written credit card policy.

Software Maintenance contract with Keystone is to be paid by May 27 in the amount of \$4650.

A WHARMM dinner meeting will be held April 17 at 6:30 p.m. in Roanoke.

It was unsure if the scheduled April 24 meeting will be held.

Town-Clerk Marilyn Morrison gave the March financial report.

Curtis Day reported from the Utility/Street Departments. Projects included new lights at the parking lot recently purchased from Eckman's.

Day presented three quotes to Council for the purchase of a dump truck. Council agreed to purchase one from Crain Ford.

Council also accepted a bid from Kessler for work on the watertower.

Council also approved the purchase special ordered doors for the rest rooms at Tower Park.

The Fire Department and Council agreed to the purchase of a tanker from HyLine in the amount of \$15,000.

Marcy Rosen presented her resignation from the local Fire Department.

Town Marshal Spitler gave his report to Council. He asked permission for Laser recertification. Council agreed.

Children must be pre-registered to participate in one of these free events. "Each participating child goes home with a prize. There are first, second and third grand prizes for the largest fish caught and first prizes for each of three age categories. Each child can win only one of these large prize packages and all will receive other prizes for participating," says Marvin McNew, Director of the Upper Wabash Interpretive Services.

Volunteers honored, more needed

In your busy life, you don't have much extra time, but consider this: If you have five minutes, you could place a friendly phone call to an elderly shut-in.

If you have one hour, you could give blood.

If you have a couple of hours a week, you could sort food at a food bank.

If you have five hours, you could help to clean up a city park.

If you have five days, you could build homes for Habitat for Humanity or other housing groups.

When considering where to volunteer a few hours of your time, decide what organizations interest you, what skills you have to offer, or whether you want to learn something new.

Start with a few hours before making a commitment. See if you like it.

Don't be surprised if you are asked to interview before starting or to fill out an application. Nonprofits have questions about you and whether you have the skills and commitment needed.

Consider volunteering as a family. It can introduce the family to new skills and experiences and give the family members great shared memories.

Could you be a virtual volunteer? If you have computer skills, you could give free legal advice, type a term paper for a blind student, or simply contact a lonely shut-in who has email.

Volunteer opportunities are many. Organizations that need help include schools, halfway houses, community theaters, museums, parks, bands, prisons, shelters, and youth organizations to name just a few areas.

### WHAT CAN YOU DO TO SAVE THE EARTH

#### EARTH DAY, SATURDAY, APRIL 22

Saving the Earth is a big project, but if each one of us does a few helpful things, it becomes a step toward the goal. Here is what you could do.

\*Recycle. Save your bottles, cans, tires, and paper so they can be used again. You could be surprised where they end up. When the Super Bowl was held on Ford Field in Detroit, it was played on FieldTurf, a multilayered system made from recycled tires and tennis shoes, along with sand, to create a cushioned playing field. It recycled 250,000 old tires.

\* Stop burning your trash. When the trash is burned, it releases toxins into the air. Items that produce poisons include bleached paper, some inks, and painted or treated wood. Plastics such as those found in wrapping tubing, piping, flooring, toys, and jugs contain poisonous polyvinyl chloride. The poisons form because the temperatures in burning barrels are too low to destroy them.

Smoke carries the toxins, which can cause breathing problems. When they settle on the soil, they can be carried off by rainwater and ultimately contaminate ground water.

\* Reduce paper trash. Use both sides of a sheet of paper. Save documents with your computer keyboard rather than printing them out. When you need a handout, count how many people will get it and print only that many.

\* Reuse computer disks, and recycle toner cartridges. Check your supplies before you order more. Organize pens, pencils, markers, paper, clips, notes, and tape refills so you know what you actually need.

\* Take toxics off your home shopping list. Choose biodegradable and non-toxic cleaning products. Use only latex paints.

\* Before you buy something that could end up in the trash, ask yourself if you really need it.
