Further discussion regarding local area. renewal of a lease of land in Warren Pharmacy, new lease was rejected by that group.

Ordinances 2021-28, 29, 30, Wages and Benefits for 2022, were submitted in introduction.

The ordinances reflect a .65 cents per hour increase in hourly wage for employees and establishment of a set wage of \$20 per hour for part time police officers with removal of automatic annual increases for part time officers. There were no amendments to the benefit sections of the ordinances.

The Accounts Payable Register in the amount of \$\$442,272.28 was approved by consensus.

Morrison reported that the newly amended disconnect policy was now in use. Morrison asked for preapproval payment for 2021 Firemen Compensation as that invoice not be available until December 1st and payment is needed at that time of submission. Approved by consensus.

Morrison recommended that due to disparity in bidding for tree/brush trimming affecting primary electric service lines that Council consider using an outside company to handle the project. Following discussion by consensus, Council approved moving forward with the recommendation.

Due to the age of the accepted quote on installation of a heating/air conditioning unit at Town Hall, the vendor is to notify the Town by January 1, 2022 with a schedule for the project and notice as to whether the bid will be honored.

DO YOU HAVE A STRATEGY FOR RMDs?

If you are 72 or older, you may have decisions to make about the money you take from retirement accounts, such as your IRA and 401(k) - and you may need to be particularly careful this year.

Here's some background: Once you turn 72, you generally must begin taking withdrawals minimum required called distributions, or RMDs - from your traditional IRA, 401(k) or employer-sponsored retirement plan. (Roth IRAs are not subject to RMDs during the account owner's lifetime.) Last year, as part of the pandemicrelated Coronavirus Aid, Relief and Economic Security (CARES) Act, the RMD rule was suspended, but RMDs resumed for the 2021 tax year.

Even so, determining when you must take your RMD is complicated by the fact that last year's suspension followed 2019 legislation that bumped the RMD starting at age from 701/2 to 72. So, if your birthdate is between July 1 and Dec. 31, 1949, you have until April 1, 2022, to take your first RMD. Anyone born before July 1, 1949, must take their RMD by Dec. 31,

IRA, you may also need to take an RMD by the end of 2021.) If you haven't begun taking RMDs, much can you afford to consult with your financial or tax advisor. If you don't take the RMDs when you should, and in the right amount, you will be subject to a 50% penalty tax questions by developing a from the IRS on the amount not suitable withdrawal rate for

Speaking of taxes, be aware that your RMDs will be added to your taxable income, but you may be able to do something to affect your tax situation if you don't need this money to meet your retirement needs. If you are 70½ or older, you may be able to move up to \$100,000 per year from a traditional (or Roth) IRA – including your RMDs directly to a qualified charitable organization. This move, called a qualified charitable distribution, generally allows you to exclude RMDs from your taxable income if the amount of the charitable contribution is at least as large as the amount of your RMD. Consult with your tax advisor before taking this step to ensure your distribution qualifies.

If you need the money to help support your retirement lifestyle, taxes will likely be less of a concern when you take RMDs. That leads to other questions:




