

# APPLEGATE APPOINTED TO TOP VETERAN POST

Governor Mitch Daniels announced yesterday in Indianapolis the appointment of Warren resident, Tom Applegate, as the next director of the Indiana Department of Veterans Affairs.

Applegate has been the Huntington County Veterans' Service Officer since his retirement from the Indiana Army National Guard in 1995.

During his tenure for Huntington County he redefined the observance of Veteran's Day and Memorial Day by focusing on individual veterans and their achievements while serving in the military. He also involved the families of veterans in these annual observances and made them events which the public looked forward to attending.

Applegate and his wife, Louise, who have lived in Warren since 1970, will eventually relocate to Indianapolis. "But we're keeping the house in Warren for when we're both ready to retire," Tom said in a statement. "We've always enjoyed Warren and always felt welcome here, and I know were going to miss the small town friendliness."

The new job starts on Monday, February 14th, and Tom says he is ready for the challenge. "I feel the experience I've gained in Huntington County over the past ten years has prepared me for the challenges that lie ahead." He says one of the main areas on which he'll focus is in the training of Indiana's 91 county Veterans' Service Officers, who are the front line contacts for veterans in their dealings with the Veterans Administration.

Governor Daniels told the overflow crowd in the MacArthur Room at the Indiana War Memorial on Monday, "This is one appointment that we took our time with. We wanted to make sure that we had the absolutely best possible, most qualified person to fill this job. I know we've found it in Tom Applegate."

#### HERE'S HOW TO PROTECT YOUR HEART

Now is the time to take stock of how you're treating the most important organ in your body. Check this information and see how you are applying it to your daily life.

Your heart is a muscle. The stronger it is, the better it will work for you. It needs to be exercised, which means regular activity like walking, running, or lifting weights.

Like any organ of your body, the heart won't serve you well if it's surrounded by fat. Working toward a satisfactory body weight will help your heart do its job.

Fill your refrigerator with fruits, vegetables, lean meats, and poultry. Keep whole grain products on hand as well as heartfriendly oils such as canola and olive oil.

Your heart won't work at all if it gets plugged up. A lump of cholesterol will do it, which means you'll be wise to skip the fatty foods. And a blood clot will do it. Check with your doctors to see if an aspirin a day can keep your blood flowing freely.

Hearts object to being excited all the time. Anger, stress, and the burden of carrying a grudge make it work harder. Do yourself a favor. Mend your fences, and channel your anger into productive action. Plan your work, and then work on your plan so you're not

Don't use tobacco. Talk to your doctor about the best ways to quit

High blood pressure can be a heart breaker. Limiting salt and drinking a glass of orange juice each day can keep blood pressure at normal levels.

If your doctor has prescribed medication for your hypertension, be sure to take it every day.

#### HOME HEART MACHINES CAN BE LIFESAVERS.

Proponents of automated external defibrillators (AEDs) say the units should be viewed like smoke detectors and air bags. Most people won't need them, but they can be lifesavers if they do.

Of people who die from sudden cardiac arrest, half of men and 64 percent of women had no symptoms of heart disease. About 80 percent of cardiac arrests occur at home.

People who live in rural communities where emergency response times are slow should think about a home AED.

One idea may be for neighborhood groups to purchase a few devices and notify residents how to get them and use them.

The devices are simple to use even by children. The Philips HeartStart AED is about the size of a hardcover book. Pull a handle to activate the machine and a calm voice gives step-bystep instructions. The cost is \$2,000, but some Websites offer it for as little as \$1,600.

Experts say anyone over 50 who can afford it should buy an AED.



#### **BOOSTER SEAT LAW**

INDIANAPOLIS - A statewide advertising campaign sponsored by the Governor's Council on Impaired & Dangerous Driving begins this weekend to highlight the new booster seat law that will take effect July 1.

The law requires all children under eight to be properly secured in child safety seats or booster seats. It also requires all kids up to age 16 to be properly restrained in a child restraint system or a seat belt in all seating positions in all vehicles. Those over age 16 must be restrained when riding in the front seat of passenger vehicles.

"This law is going to protect our most vulnerable Hoosiers by requiring parents to make sure their children are properly restrained," said Charlotte Ashburn, director of the Traffic Safety Division of the Indiana

Criminal Justice Institute, which houses the Governor's Council.

"Additionally, the law makes it clear that everyone under 16 must be buckled up, no matter what kind of vehicle they're in or where they're sitting in it," Ashburn said. Currently, those riding in pickup trucks or sportutility vehicles with truck license plates are not required to abide by Indiana's seat belt law.

The new media campaign, which emphasizes the need for booster seats and the effective date of the new law, is aimed at parents of young children and grandparents who might be transporting young children in their vehicles. The campaign will be seen on television, radio and outdoor media across the state, and the image for the outdoor campaign is attached to this release as a PDF file.


In the United States, an average of six children 0-14 years old were killed and 694 were injured every day in motor vehicle crashes during 2003.

Children, as they grow, should progress through three types of child safety seats before using the seat belt alone: (1) rearfacing seats to (2) forward facing seats to (3) booster seats.

Booster seats raise children up so that seat belts fit properly. Eighty-three percent of children between the ages of four and eight are inappropriately placed in adult seat belts.

"We're educating about this law now because we wanted to

give parents enough time to prepare before it takes effect, although we want to encourage them to get their kids properly secured as soon as possible," Ashburn said.

Those who violate the new law will commit a Class D infraction, which carries a \$25 fine. However, offenders can avoid the fine if they prove that they have obtained an adequate restraint system for their children. Fines collected under the law will be deposited into a state fund that will be used to make grants to public and private organizations for the purchase and distribution of child restraint systems to those who are otherwise unable to afford them.
