## MY INDIANA HOME

The Indiana Attorney General's office has announced the creation of "My Indiana Home" an interactive CD-ROM with important information about predatory lending.

"My Indiana Home" has been distributed to all Indiana libraries. The CD-ROM is designed to inform viewers (especially senior citizens) of potential predatory lending situations and to provide tips on how to avoid being a victim of this fraudulent activity.

The CD-ROM requires no special knowledge of computers to use. When inserted in a CD drive, it will start automatically and guide the user through five predatory lending scenarios. After each scenario an audio review is provided. The text of the review can be printed from the CD for later use. In addition, a number of helpful documents are found at the conclusion of the CD ROM that can also be printed off.

- \* a list of warning signs of predatory lending
- \* a list of important questions to ask when getting a loan
- \* a glossary of lending terms
- \* a home improvement contract checklist
- \* instructions on what to do if someone believes they have been a victim of predatory lending.

### DC TRIPS CANCELLED

Following is the text of a letter received at the Warren Weekly regarding the annual Washington DC trip for Salamonie 8<sup>th</sup> Graders. The letter was written to Middle School Parents for Charles R. Grable, Salamonie Principal.

"A decision was made last week by the school corporation administration to cancel two pending trips to our nation's capital. Neither Salamonie School nor Crestview Middle School will be sending students to Washington DC during the week of March 18 – 22. Due to the unsettled and ever-changing nature of the United States foreign policy, the risk of additional terrorist attacks on our country, and the distinct possibility of our country's involvement in an armed conflict, the school corporation is not willing to risk your child's safety and security.

The safety of our students must be paramount in the corporation's mind and we accept the fact that you, as parent, entrust your child to us each day to attend school settings that provide safe and secure environments. Although our students will most likely be disappointed, and we regret once again not being able to provide an educationally sound travel experience, the corporation feels that the most prudent decision is to cancel the pending trips.

Ms. Brown, Mr. Buzzard and Mr DeHaven are currently working with their Washington DC contacts to determine what deposits we will get back, and what deposits are lost. Please be patient as they work through this process. We are hopeful that you will receive a full refund, but we cannot guarantee it at this time. Mr. DeHaven will mail you your refund check as soon as possible.

We held a parent meeting on Friday, February 28<sup>th</sup>, to share this information with parents and answer questions. If you were not able to attend this meeting and have questions, please do not hesitate to call the office at 375-3434 or 356-8995. We appreciate your understanding in this matter and we hope that we have your support."



### ORGANIZE YOUR RECORDS

Now is a good time to organize your household records. It is easily done at the same time you are gathering information for tax purposes. Your spouse, or adult children will need the information if something happens to the head of the household. It is easier if this information is up-to-date, and kept in one location.

Other records to locate include tax returns, and supporting documents, investment contracts, list of debts, the will and funeral wishes, so the estate can be settled according to the deceased wishes.

Beverly Morgan, Extension Educator, recommends using a workbook style publication titled "Keeping your Important Papers." (HE-46S). It provides a list of important items and you fill in where each is stored.

The publication also includes real estate records. You fill in the property purchase date and purchase price, amount of the original mortgage, amounts and time of payments, and list of major property improvements. This is useful when the property is sold and for tax purposes.

Household inventory, outstanding debts, and income sources are included in the booklet. There is also space for the family investments, retirement savings, etc. There is a section to include credit card numbers, the 800 number for the credit company and amount for the line of credit. This is helpful in case a credit card is lost or stolen.

Once the booklet is filled out, keep it in a safe place. A family member outside your home should know of its location. It should be accessible enough to update as records change, or updated at least yearly.

A duplicate copy is a good idea and could be kept in a bank safe deposit

box, or with a trusted friend. This booklet is a simple method to keep your household business organized and up-to-date.

### PROTECT YOURSELF

The U. S. Postal Service delivers everywhere, every day - and delivers almost anything. But what about mail that is sexually oriented - mail neither requested nor wanted by the recipient?

There are two federal laws that protect people from unsolicited sexually oriented advertisements.

Title 39, United States Code, Section 3008 authorizes the Postal Service to issue a prohibitory order against a mailer who sends adver-

tisements offering to sell any matter that in the recipient's opinion is "erotically arousing or sexually provocative." The order can be requested by picking up and completing the relevant portion of PS Form 1500, Application for Listing and/or Prohibitory Order, and submitting it to any Post Office. You can obtain the application online at [www.usps.com/forms](http://www.usps.com/forms) or at your local Post Office. Thirty days after receiving the order, the mailer is prohibited from sending the individual any more mail. Violating this prohibition makes the mailer subject to court enforcement action by the United States Government. Any children in the residence under 19 years old also can be protected by the prohibitory order.

Title 39, United States Code, Section 3010 authorizes the Postal Service to keep a list of persons who

inform it that they do not wish to receive sexually oriented advertisements through the mail. You can add your name and address to this list by filling out Form 1500 and submitting it to any Post Office. When your name and address have been on the list more than 30 days, it is unlawful for anyone to mail you a sexually oriented advertisement. Mailers who violate your protected status make themselves subject to court enforcement action by the United States Government.

A person who gets mail that's in violation of the prohibitory order should open it and write clearly on the envelope and all its contents the date of receipt. For example, an addressee receiving such mail on April 5, 2003, would write, "I received this mailpiece on April 5, 2003."

The signed statement should be mailed with a copy of the prohibitory order or a notation of the order number to:

## GET CHECKED OUT, SAYS NKF

More than 20 million Americans have chronic kidney disease, and another 20 million more are at risk, according to Dr. Tim Taber, MD, President of the National Kidney Foundation of Indiana. Most are not even aware of this potential health threat. During March, National Kidney Month, the NKF urges all Americans, especially those at risk, to get tested for kidney disease.

"Chronic kidney disease usually causes no symptoms until it reaches an advanced stage, but simple tests can be done to detect kidney disease early," says Dr. Taber, MD. "If caught early enough, chronic kidney disease can be treated to prolong or even prevent associated complicating factors, such as cardiovascular disease," Taber concluded.

According to Taber, it's important that people visit their doctor or a clinic to find out if they could be at increased risk for chronic kidney disease. Anyone can get chronic kidney disease, but some people are more likely than others to develop it. People in high-risk groups include:

\* Diabetics or those with a family history of diabetes

\* Those with high blood pressure or family history of hypertension

\* Those with a family history of

chronic kidney disease

\* African-Americans, Hispanics, Pacific Islanders and Native Americans

Dr. Taber recommends three simple tests for anyone who is at increased risk: blood pressure, urinalysis to check for protein and a blood test to test for the level of serum creatinine, a waste build-up that would indicate that the kidneys are not doing their job of filtering the blood well enough.

Most physicians will refer patients who test positive for chronic kidney disease to a kidney specialist to develop a treatment plan and lifestyle adjustment.

For patients at increased risk for chronic kidney disease, but whose test results turn out normal, their doctors will want to re-check them at least once a year. They should also advise their patients how to reduce the risk of developing kidney disease, by making lifestyle changes such as increased exercise and diet adjustments.

## WINDOWS TIPS AND TRICKS 8 USE NARRATOR TO NAVIGATE THE INTERNET

Narrator is a text-to-speech utility in Windows XP for people who are blind or have low vision.

Narrator can read Web pages and the browser commands in Internet Explorer. However, in some cases, Narrator cannot recognize Web page layout and design elements that guide readers. Instead, Narrator reads the words on the page from left to right, and top to bottom in the order they appear.

To overcome this, you can copy the text of a Web page into Notepad and Narrator will read the page in a more logical order.

1. Open Narrator by pressing the Windows logo key+U.

2. Start Internet Explorer and browse to a Web page that you want Narrator to read. Click the window you want read, and then press CTRL + Shift + Spacebar. If possible, Narrator will then read the contents of the window.

3. If the page layout is an obstacle, then right-click the Web page, click Select All, and then click Copy.

4. Open Notepad, right-click within the empty Notepad document, and then click Paste.

5. Press CTRL + Shift + Spacebar, and Narrator will read the page.

Narrator reads only the first 72 words in Notepad. After that you must use the arrow keys to read each line separately, or you can press CTRL + Shift + Enter to read the entire text (.txt) file.

You can save the Notepad file and Narrator will start reading it the next time you open it.

More Navigation Tips for Narrator:

§ To read an entire window, click the window and then press Ctrl + Shift + Spacebar.

# TOOTH TIPS

## YOUR CHILD'S TEETH

February was Children's Dental Health month. The ADA (American Dental Association) and Crest were promoting dental education for kids and in conjunction with the "Give Kids a Smile!" program, free care, on February 21st, for children in need.

It is very important that parents and their children are educated about good oral health. Your child's first visit to the dentist should occur before the age of three, just for an exam. Seeing the dentist at a young age will help prevent or detect problems such as decay, congenital defects, nursing bottle caries, and thumb sucking, which can cause misalignment. Also, bringing children to the office at an early age helps reduce anxiety and fear. Many adults do not seek treatment, for themselves, due to fearful dental visits as a child.

The primary (baby) teeth, twenty in all, are very important to help develop speech patterns and for maintaining the spaces where permanent teeth will erupt. Also, they are good primers for teaching your child proper oral care habits. The primary (baby) teeth will erupt between the ages of 6 months and 3 years. The primary front teeth, upper and lower, will be lost between the ages of 5 to 7. The last of the primary molars should be gone around ages 11 to 13. There can be some level of discomfort during both of these phases. Consult your dentist if you have questions concerning your child's situation.

Remember, primary teeth are very important for the foundation of good oral health and overall well being. Beginning proper oral care habits early, including dental visits, will lead to a beautiful, healthy smile in the future.
