

in blue collection boxes will also be at noon on that day. All collection points that have a regularly scheduled collection time prior the noon on Friday July 3<sup>rd</sup> will be collected as scheduled. Regular mail delivery for July 3<sup>rd</sup> will be unaffected by the change. P.O. Box mail access will only be available until 12:00 PM (noon) in those Post Offices where retail counters and access to Post Office Boxes are co-located and are affected by early retail closing.

"As many businesses close early on July 3<sup>rd</sup>," said Stephanie Bauman, Warren Postmaster, "the number of customers visiting our lobbies greatly diminishes. We view this as an opportunity to afford retail employees more time with their families by closing retail operations in most of our locations early on July 3<sup>rd</sup>."

Commercial customers are asked to check with their Bulk Mail Acceptance Unit for July 3<sup>rd</sup> hours of operation. To obtain the phone number of a specific Post Office, customers may call 1-800-ASK-USPS.

Post Office retail counters will be closed on Saturday, July 4,

2009 (Independence Day- a federal holiday) and there will be no mail delivery.

Post office retail counters will resume regularly scheduled hours of operation on Monday July 6.



## AREA NEWS CONTINUED

### GRADUATES BASIC

The course is designed to train airmen to employ a diverse combination of communications equipment, which included fixed and mobile, low and ultra high frequency, amplitude and frequency modulation, and different modes of sideband transmission. Students learned to install, maintain, and repair high-powered ground communications equipment, including transmitters, single and multichannel receivers, and transceivers used for voice and data communications with aircraft and worldwide ground stations.

The airman is a 2008 graduate of Southern Wells High School, Poneto, Ind.

### CELEBRATE INDEPENDENCE

July is a time to bring family and friends together to celebrate America's independence; it is also a time to commend the national spirit of America's blood donors.

"Blood donors symbolize our nation's generosity," said Sharyn Whitman, CEO for the Indiana-Ohio Blood Services Region of the American Red Cross. "Every day, people from coast-to-coast independently step forward to help others in need by donating blood."

Giving blood around the Fourth of July also helps strengthen America's blood supply during the heart of summer. Red Cross officials say that blood donations typically slump in July and around major holidays as some donors focus on summer activities and may overlook donating blood.

"Regardless of the season, hospital patients need blood," said Whitman. "Blood is always needed in the summer as seasonal travel and activities contribute to serious accidents

and injury that require blood for emergency care. Plus, cancer patients need blood products year round."

All blood types are needed, but Type O-negative is in especially high demand since it can be transfused to patients with any other blood type and is often used especially in emergency situations. Currently the Indiana-Ohio Region has less than a 12-hour supply of Type O-negative.

The American Red Cross considers a three-day supply safe and adequate for meeting the ongoing needs of hospital patients, and five to seven days optimal for emergency preparedness.

"Your donation this summer will help shore up America's blood supply," said Whitman. "What greater sense of American spirit can you have than knowing that blood will be there if and when you need it?"

From June 29 to Sept. 7 donors who give blood through the Indiana-Ohio Blood Services Region of the American Red Cross will be entered to win a weekly drawing for a \$500 Meijer gift card.

### REDUCE BUI

Indiana is participating in Operation Dry Water, a coordinated national weekend of Boating Under the Influence (BUI) detection and enforcement aimed at reducing BUI, June 26-28.

Curbing the number of alcohol-related accidents and fatalities is a key to achieving safer and more enjoyable recreational boating.

In 2007, U.S. Coast Guard statistics indicated that 21 percent of all boating fatalities were a result of alcohol use, which continued an upward trend in the percentage of fatalities where alcohol was the primary cause of the accident. In 2008 there were 55 boating accidents reported within Indiana. As a result of those accidents eight victims drowned while boating Hoosier waterways. Alcohol was believed to have been a major factor in a number of the

accidents.

Indiana will increase BUI enforcement during the weekend by offering overtime to off-duty officers increasing patrols in several locations. The overtime would be paid through a grant from the Coast Guard.

The National Association of State Boating Law Administrators (NASBLA) works with the states, the Coast Guard and other partner agencies to coordinate the event.
