## KIDS FIRE SAFETY

The Warren Volunteer Fire Department of Salamonie Township is offering local students the opportunity to participate in an educational fire safety program designed to prevent fire-related injuries and fatalities.

Produced by Gateway Community Safety Net, Fire Safety for Kids is a 116 page book that features information on how to avoid fire, plan an escape route from your home and what to do if fire breaks out. It also offers health and first aid information, along with important safety tips for parents, teachers, and babysitters. ## Home Escape Planning and Practice

If a fire broke out in your home, do you know how much time you would have to get out? Unfortunately, no one knows for sure. While most people feel safe in their homes, the reality is that home fires are much more common than you might think. There were nearly 4,300 home fires reported in 2007 in Indiana, resulting in approximately 100 Hoosier deaths.

In a perfect world, we would be able to prevent all home fires. In reality, we can be vigilant, but there are no guarantees. Any emergency can affect one's ability to think clearly, but during a fire, smoke and other physical factors can literally inhibit your ability to

The theme for Fire Prevention Week (October 5-11, 2008) this year is "Prevent Home Fires," and focuses on preventing the leading causes of home fires - cooking, heating and electrical equipment, and smoking materials.

While the statistics are daunting, most home fires are easily preventable when we narrow our focus and take personal steps to increase our safety. Working smoke alarms and fire escape planning and practice are integral to keeping your family safe, but another element that you may want to add to your safety system is home fire sprinklers. Because they react so quickly, fire sprinkler systems can dramatically reduce the heat, flames and smoke produced in a fire. When sprinklers are present, the chances of dying are reduced by more than one-half and the average property loss per fire is cut by one-third to two-thirds, compared to fires where sprinklers are not present.

There are also a number of simple steps that you can put into action to keep your home safe from fire:

Cooking: Stay in the kitchen when you are frying, grilling, or broiling food. If you leave the kitchen for even a short period of time, turn off

Heating: Keep all things that can burn, such as paper, bedding or furniture, at least 3 feet away from heating equipment.

Electrical: Replace cracked and damaged electrical cords; use extension cords from temporary wiring only. Consider having additional circuits or receptacles added by a qualified electrician.

Smoking: if you smoke, smoke outside; wherever you smoke, use deep, sturdy ashtrays.

Preparing for the unexpected is difficult, but when it comes to home fires, minutes, even seconds, can mean the difference between life and death. That's why having a well-practiced fire escape plan is vital to the safety of your family.

To get you and your family started in planning a home fire escape, follow these tips:

Install a smoke alarm on every level of your home and have one inside each bedroom and outside of each sleeping area. For the best protection, interconnect alarms so that when one sounds, they all

Test smoke alarms at least once a month.

Replace batteries in smoke alarms at least twice a year. Plan on replacing the batteries when you change your clocks for daylight

Develop a fire escape plan that identifies two ways out of each room and a family meeting place outside. Once outside, never return inside the house.

Make sure your plan allows for any specific needs in your household. If everyone knows what to do, everyone can get out quickly.







Gumboils are painful and non-painful pimples. Like swellings that can erupt on your gums, usually as a result of decay or abscess (infection). The gumboil is full of pus that has worked its way to the surface of the gum. You can rinse with warm salt water to relieve and release its contents. A gumboil is usually a symptom of a serious infection or gum disease, the appearance of one should be reason to call your dentist promptly for an appointment. Decay generally begins with a small spot of demineralized enamel on the too surface, usually hidden from sight in an individual tooth fissure or between teeth. This is why brushing and flossing is so important to reduce the build up of plaque. Seeing your dentist for regular checkups and x-rays will also help prevent decay. An abscess is an infection around the root of a tooth in the gum or jaw bone. Pus begins to collect as a result of the infection and the "gumboil" develops. If you develop a gumboil, see your dentist right away.



Practice using the plan at least twice a year.

Some children and adults may not awaken to the sound of the smoke alarm. Designate someone to wake up each person in the household.

Remove any items that may block doors or windows in your home. Make sure when arranging furniture and other items that you're not blocking doors or windows. They could keep you from escaping in the event of a home fire.

Be sure to remove a pile of toys or other items in front of a doorway that can block your escape route and be a threat to the safety of you and your family.

We want to encourage all Hoosiers to be prepared. Currently, only 35% of U.S. households have a well-practiced plan in place for escaping home fires. The Indiana Department of Homeland Security and the State Fire Marshal encourage families to make a fire escape plan and practice it. Fire is unpredictable, but preparation in the form of a well-practiced escape plan can help keep you and your family safe, and potentially save lives. Sincerely,

The garden is history for another year and I am glad. I look forward to the garden each year but ready for it to end. The potatoes did very

well and the Early Girl tomatoes finally produced well after being a month late ripening. Some of the potatoes were damaged when I dug them so I experimented with making some potato soup to use the damaged ones, which I froze. We will see later if it is worth the

effort.

I canned and froze quite a bit from our small garden and I'm sure it will taste good this winter. Something I made this year was like V-8 vegetable juice. We have sampled it and turned out well. Also made tomato soup which I have made before.

Our peach tree really produced again this year and canned several canners full and made pies for the freezer along with peach jam. I also made green tomato pie to freeze.

As usual soon as the garden is done I think about what I could do for next year, however, I think our garden will be much smaller, just too much to keep up any more.

The flower beds are looking sad so have started cleaning them out and preparing them for winter. Mum plants are blooming nicely and always enjoy them in the fall. Heave them till spring to cut back in the winter with snow on the ground it gives a little texture to the winterscape.

This time of year our kids start requesting a chili cook out. We bring out the old iron pot that is a family heirloom and build a fire in the back yard and fire up a good ole pot of chili. For dessert we have S'mores (graham crackers, melted marshmallows and Hershey bars). Then of course we have a pot of coffee. It is always a fun family time.

At home we always had a wiener roast when the garden was cleaned off, dad would bring up some tree trimmings to add to the fire. Mom would make cookies or a special cake for dessert and also had marshmallows, but s'mores were hardly heard of. It too was a fun evening sitting around the fire telling all kinds of tales, some being scary especially when the old bobcat down by the creek was screaming. It was enough to send chills up your spine knowing he wasn't to far away. Dad always told us that the fire would scare him away, but us kids wasn't to

I also add a couple large potatoes diced or a cup of macaroni and cook till they are done. I have a jar of chili powder near by for those who like it really hot. It sure tastes good on a crisp fall evening.
