## 4-H GUN SAFETY TO BEGIN

Firearm safety instruction, handling procedures and hands-on experience will once again be included in this year's Wells County 4-H BB Gun, .22 Caliber Rifle, and Pellet Pistol Safety Program.

Meetings will begin Tuesday, January 28th with sign up from 6:30 - 8 PM. Meetings will continue each Tuesday, February 4, 11, 25, March 4, March 11, March 18 and 25. Awards Night will be held April 1.

All meetings (except January 28) will begin at 6:30 PM and end at 8:30 PM. The Wells County Community Center at the 4-H Park will be the location for all meetings.

New this year is the opportunity for youth to participate in the Pellet Pistol Program. A minimum of 8 youth and maximum 20 may participate in Pistol.

Enrollment will be limited to 28 youth in BB Gun and 32 youth in Rifle. Sign up will be on a first come, first serve basis. The limited club size is to assure adequate instruction and safety.

Youth in grades 3, 4, and 5 can participate in BB Gun. Youth in grade 6 and above can participate in Rifle or Pistol.

First time members who are old enough for Rifle or Pistol will be required to pass a BB Gun shooting skills proficiency test which reviews the positions and range safety procedures.

Youth may become 4-H members when they enter third grade or become ten years of age sometime during the calendar year (January 1 - December 31) and may continue their membership for a maximum often (10) years or through the calendar year they become nineteen (19), whichever comes first.

A membership fee of \$18 for BB Gun and \$23 for .22 Caliber Rifle and Pellet Pistol should be paid at the first meeting. The fee covers the cost of equipment, materials, ammunition, insurance, and awards. Checks should be made payable to Wells County 4-H Rifle Club.

Members are not allowed to bring their own equipment. Advanced registration is not required. Sign up will be at the first meeting. All participants must have a completed and signed health form

before participating in the hands-on activity.

## PRESCRIPTION DRUG HELP FOR SENIORS

Do you know an older Hoosier who could use help paying for prescription drugs? Parent? Grandparent? Relative? You? If so, signing up for the HoosierRx program is a great way to start the new year.

Indiana's tobacco settlement specifically set aside money to help Indiana seniors with their prescription drug needs, naming it the HoosierRx program. Your legislators supported this program and continue to support it. Older Hoosiers can support the program by enrolling and participating in it. Too many seniors are missing the opportunity to receive help with prescription costs. HoosierRx program savings can put an extra \$500 - \$1000 in a senior's pocket. Enrollment is open to Indiana residents over the age of 65, with monthly incomes of \$997 or less for single persons or \$1,344 or less for married couples. Persons who are covered by insurance plan prescription drug coverage or Medicaid are not eligible.

Why should older Hoosiers enroll in HoosierRx?

\* The Medicare premium has gone up, and the social security increase will be less than in other years.

\* Medicare does not presently offer a prescription drug benefit, nor does the current proposal from the White House.

\* HoosierRx offers assistance now to eligible seniors.

What are the benefits of the program?

\* HoosierRx participants receive a card that applies an immediate benefit of 50% off the price, up to your annual limit, at the time your prescription is filled.

\* Almost all pharmacies in the state participate, so your card is good anywhere in Indiana. (This

includes the Warren Pharmacy.)

\* You continue to receive a discount on your prescription costs even after you've met your annual benefit.

It is easy to enroll. Contact Aging and In-Home Services of Northeast Indiana, Inc. at (260) 745-1200 or 800-552-3662 to get connected. Forms are also available at the township trustee office and local pharmacies.

### LETTERS TO THE EDITOR:

Indiana parents and politicians should not have been lulled or misled by recent national news stories like "Study: Teen Substance Abuse on Decline," A more accurate reflection of our state's situation might have been "Study: Teen Substance Abuse Worse Here Than Nationwide."

A quick view of recent wire stories carried across Indiana might have led newspaper readers, radio and television audiences to believe things are in-check concerning cigarette, alcohol and marijuana abuse among youth, including here in Indiana. However, a closer look at the quoted University of Michigan survey results shows significant abuse, especially across our state.

Research among eighth-graders showed cigarette use reached 10.7 percent nationwide, but 14.7 percent across Indiana. Alcohol consumption stood at 19.6 percent nationwide, but a staggering 24.9 percent statewide. Marijuana abuse among America's eighth-graders reached 8.3 percent, but was 11.1 percent for Indiana.

Its "high time" for Indiana parents and policymakers to start holding each other accountable.

### GED ON TV

GED Connection is a multi-media television series designed for adults who want to study from home as they prepare to take the GED and earn a State of Indiana GED High School Diploma. The television programs will be broadcast on Indiana PBS stations beginning the week of February 2nd. There are 39 half-hour television programs that cover the reading, writing, social studies, science, and math that are on the GED test. Three workbooks go along with the series.

New to this GED ON TV series, learners who have access to the Internet can get extra practice with corresponding online lessons at <http://www.pbs.org/iiteracy>.

Many people have expressed fear that the 2002, test will be harder to pass. The adults who have taken the new test, claim that it does not seem more difficult, and the Indiana passing rate is exactly the same as it was for the 1988 version of the GED. The GED Testing Service says that the new tests are based more on real life situations. This may make it easier for some people. There are more graphics to interpret in all of the sections. Fewer long passages to read may also make it easier. The math section is offered in two parts. The first part will allow the use of a calculator. The 2002 test still requires students to write an essay.

Learn at Home will take enrollments for the spring semester beginning January 6, 2003. To enroll, adults may call 1.877.433.6688. The \$35 enrollment fee includes a pretest, three

workbooks, the official GED calculator to practice with at home, a post test, access to the toll-free GED ON TV Helpline and a voucher to pay for the student's GED test at any testing site in Indiana.

Adults who couldn't complete high school should call, toll-free, 1.877.433.6688 to enroll soon so that they will have time to com-

plete the pretest and receive their workbooks before the television programs begin.

The Indiana GED ONTV partners are Indiana Public Broadcasting Stations, Inc.; the Indiana Department of Education, Division of Adult Education; Muncie Community Schools and Learn at Home.

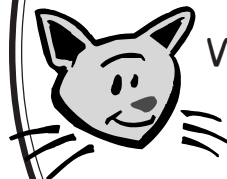

## TOOTH TIPS

SHOULD WOMEN BE MORE CONCERNED  
ABOUT GUM DISEASE???

As a woman goes through different phases of her life there is the potential for a greater risk of periodontal (gum) disease. From the onset, through teenage years, pregnancy and menopause, a woman's hormone changes can affect her oral health. The reason is that hormones alter the bacteria (plaque) that make their home in the mouth. Irritants or changes in the bacteria can make the gums swell and bleed (ex. pregnancy gingivitis). As the disease progresses, this can lead to further breakdown, pocket formation and the starting place for periodontal disease. This can lead to bone loss, which can severely loosen teeth, cause pain, and eventually tooth loss. Other contributions to gum disease are smoking and diabetes. Gum disease is preventable. However, the old "wives for every tale" of losing a tooth for every pregnancy or the baby took all the calcium out of my teeth is simply not true. Regular brushing, flossing and trips to the dentist can reduce your chances of getting gum disease. Another concern is crash dieting. Crash diets can affect the production of saliva in your mouth. Saliva is vital to your mouth's ability to cleanse itself. If you are on a diet or thinking about it, see your doctor and dentist to make sure that your physical well being or oral health are not being compromised.

### PATHFINDER RECOGNITIONS

Pathfinder Services, Inc., Huntington, honored individuals and organizations at a community recognition dinner this evening. The not-for-profit human service organization presented awards for support of the organization and the people it serves.

The Pathfinder Services Board of Directors bestowed the prestigious Herbert D. LaMont award on a special education teacher who started her career as one of the first employees of Pathfinder Services. She provided education for older school-age children who had developmental disabilities. When the school corporation took responsibility for providing services to the children, Peters joined its staff and eventually retired from Huntington North High School. As one of Huntington County's first special education teachers, Peters had to develop her own curriculum. She created a wide variety of educational and social opportunities to help her students reach their greatest potential. Peters is traveling out of state with her husband and was unable to attend the dinner. A former student, Melissa Ruckman, accepted the award in her honor.

The Pathfinder Services Board of Directors gives the LaMont award annually in honor of the late Herbert D. LaMont, who was a major force in the development of services for persons with disabilities in Huntington County.

At the dinner, Pathfinder Services also gave "Community Partner Awards" to individuals and organizations that supported Pathfinder and its customers during the past fiscal year. Recipients included:

\* Ralph Biggs, Ideal Suburban Homes, Decatur, for partnering with Community Connections, the home ownership division of Pathfinder Services, to build affordable new homes for families who

have disabilities.

\* Regina Patora, Indiana Housing Finance Authority, Indianapolis, for making it possible for Community Connections to participate in the Authority's "First Home/PLUS" program. The program provides mortgages at below-market interest rates plus assistance making a down payment.

\* Four Seasons Golf and Tan, Huntington, for helping people with disabilities find and keep employment. The business has hired more than one customer of Resource Connection, the specialized employment division of Pathfinder Services.

\* Employees of Parkview Huntington Hospital, for "adopting" five Kids KampusSM families for Christmas. Kids Kampus is the children's service center of Pathfinder Services. The employees obtained extensive lists of needed items, wrapped them individually and delivered them to Kids Kampus for the families.

\* Student volunteers of Huntington College's Joe Mertz Center, for regularly spending time with residents of a group home for adults who have developmental disabilities. Students visit the group home at least monthly and regularly host residents for a meal at the College dining facility.

Pathfinder Services also honored those volunteer workers who gave at least 50 hours of service during fiscal year 2002 (July 1, 2001 to June 30, 2002). They include: Greta Schenkel, 1,342 hours; Sue Fisher, 131 hours; Lauren Christman, 108.5 hours; Sarah Prescott, 56 hours; Cheryl Stanley, 56 hours and Julia Simpson, 50 hours.

Pathfinder Services, Inc., is a not-for-profit human services agency based in Huntington, where it was founded in 1966. It provides Community Group Living services for adults who have developmental disabilities, Supported Independent Living services for people who have disabilities and live on their own, Community Integration services to help people who have disabilities become more involved in their communities, Transitional Hous-

ing services for families who are homeless, as well as employment services, children's services, home ownership assistance and other services to enhance the quality of life in the communities it serves. In addition to Huntington County, Pathfinder serves people in 10 other counties in northern Indiana.
