

their choice in return for a sample of that team's barbecue. Each team participating in Barbecue Row will provide a small sampling on a cocktail plate or in a small bowl.

At 4:00 p.m., teams may then turn in any tickets they have collected for reimbursement from the festival committee. Tickets will be sold for \$2 each, and each team will receive the entire amount for each ticket redeemed.

Patrons who participate in Taster's Choice sampling will be allowed to vote for their favorite entry. A trophy will be awarded to the top three teams with the most votes during

an awards ceremony at 4:30p.m. In addition to sales occurring from Taster's Choice sampling, barbecue teams are also encouraged to sell barbecue and sides ala-carte. Each group may use conventional or specialty barbecue sauce with their entree, but teams are encouraged to have their own sauce available to patrons, as many visitors will expect this based on their own definition of "barbecue." Barbecue may include pulled pork, but the rules specify that all meat must be raw at the start of the festival and cooked on-site. Teams are not permitted to roast a hog off-site and then bring in prepared pulled pork,

Registration and a \$50 entry fee for Barbecue Row are due by March

Aside from Barbecue Row, the festival will also feature an Artist Market, where original hand-made arts and crafts vendors will be selling their work. In addition, there will be an art show and sale featuring local artists, a children's theater, three stages of vocal, instrumental, and dance performances, and a children's art expo. Our Town, Warren's downtown revitalization group, sponsors the festival.

Lewis, Clark, and political correctness

Don't Fall for Sucker Line

"There's a sucker born every minute," is the way P. T. Barnum put it. The premier showman of the last century, Barnum saw equal parts of ignorance and curiosity in those who responded to his posters and billboards by parting with the price of admission.

Today, with TV sets as common as toasters, it's doubtful that the Barnum sideshows of yesterday would draw a crowd.

Still, the trust Barnum banked on lives on in all of us, especially if we are tempted to believe, even for a second, that the fountain of youth can be found in a jar, or that we can take a 'free' trip to an island paradise just by dialing a phone number on a random advertisement. An appropriate saying to keep in mind these days is "if it seems too good to be true, it probably is."

When a 'sweepstakes' representative promises you a once-in-alifetime chance to win thousands of dollars - for a small monthly fee just say no. A legitimate offer usually requires no entry fee. The same holds true for offers of 'prizes' or 'gifts' that come attached to a purchase or entry fee. Unless you want to make someone else richer, just say no.

And above all, know who you are doing business with - who they are and where they are. If there is no actual city, street address and phone number for the company making the offer, think twice about the offer.

Another bit of advice: if you're considering an offer and want to check out a company's credentials, check with the Better Business Bureau. And, of course, if you've become the victim of a scheme that involves the mail, or if you think you have, contact the Postal Inspection Service at 1-800-ASK-USPS (1-800-275-8777).

Meanwhile, watch out for those 'too good to be true' offers. The 'students' of P.T, Barnum are banking on you.



WINDOWS TIPS & TRICK

Renew and Release IP Addresses Submitted by Bob Cerelli, Bellevue, Washington

You can use the command-line tool IPCONFIG to get network information such as your IP address and to perform other tasks for troubleshooting network issues.

However, if you prefer a graphical user interface over command lines, you can download a GUI tool that will run on Windows XP and Windows 2000. The tool that's installed is Wntipcfg.exe.

The tool identifies your IP address, subnet mask, and default gateway for each of your network interfaces, including the interface for your network adapter, your dial-up networking interface, and your PPTP interface. It allows you to click a button to Release, Renew, Release all, or Renew all when configuring an IP

address

To download and install the tool:

1. Open the Windows 2000 Re-

1. Open the Windows 2000 Resource Kit tool download page Wntipcfg.exe: Windows NT IPConfig Utility

2. Click the download link in the box at the top right corner of the page.

3. In the File Download dialog box, select Save this program to disk.

4. Select a location on your computer to save the file, and then click

5. In Windows Explorer, go to the location where you saved the downloaded file, double-click the file to start the installation process, and then follow the instructions.

6. To provide quick access from the Run line, install the program to C:\Documents and Setting\yourusername or the equivalent. Or, create a shortcut to the program on your start menu or desktop.
