





Robert grabbed his camera and lenses and put them in his car and moved the John Deere Gator out of the garage to make room. By that time our Brevard Fire Department and First

Responders had arrived.

We have been blessed! Our **Emergency Preparedness action** plan worked. I would give us an A+ because we were calm and knew where the dog's leashes were. Everyone is safe! We do have a little damage but nothing major. The house doesn't have that Beautiful Clean smell but it was clean and I was dressed almost to shoes. My foot was soaking in Epson Salt but my shoes were right there. While I was waiting for the fire trucks to leave I called our insurance company and reported the incident.

It was a good thing I was dressed because by the time the Brevard Fire Department left a van pulled up the driveway. It was our local television station, WLOS. They wanted an interview. I had been at the station last week doing a segment on preparedness for their morning show.

When I looked at what time the strike happened I noticed it was my favorite number, 11:11. I know that this is God's way of saying that something good is going to come out of this.

I want you to have peace too. Are you prepared for a fire? Can you get out of the house quickly? Can your children hear the smoke alarm in the middle of the night? Do they know what to do when they hear it? Have you tested them? Do you have a place outside to meet up so that everyone can be accounted for? Have you tested your smoke alarms and carbon monoxide detectors? Have you checked your dryer for built up lint? Many home fires start in the dryer. Do you have fire extinguishers on every floor of your home and do you know where they are and how to use them? Can you turn the power off to your home? Do you have a phone that works when the power is off?

We are prepared! I have already replaced the fire extinguisher we used and put new one in Robert's shop. Please support your local volunteer fire fighters! They work

by Neil V Wyrick WHAT'SITLIKETOBEACHILD? WHAT'S IT LIKE TO BE A PARENT?

Too many parents forget what it was like when they were a child.

Children, of course, have no history of being a parent. It is still a role to be opened up to them in some distant future.

and you are going to act as if you are my age, a parent." When they get through laughing or maybe even looking a little scared at the idea...continue.

"It will be fun and it will help both of us understand each other better. First, to give me a better idea of how you are feeling when I fuss at you for not doing something; I am going to pretend to be you. And to give you better idea of how I am feeling when you drag your feet I want you to try to be me. I know your excuses. You know my responses. It's just that we both will be hearing the words from a different point of view."

"Now, I am not going to get mad at you so I do want you act and sound like I do when I ask you to do something. How I sound? What do I say?" And, yes, no fair getting your feelings hurt if your child really gets into it. "And you aren't supposed to get mad at me. Want to give it a try?"

Both of you may have a little trouble getting into the spirit of the game. You may want to work out your own way of explaining what it is you want to do. Your imagination may require some mental massaging but don't give up on the idea. Most problems arise because we really don't get in the other person's frame of
