FLAG FOOTBALL

Indiana Youth Flag Football is proud to announce the launch of the Fall 2012 Warren NFL Youth Flag Football league. This offering provides a NFL Youth Flag Football program to the Warren and surrounding communities with all games being played in a high school stadium setting.

Eight new leagues have been added in Indiana including leagues located in Noblesville, Pike Twp., Perry Twp., Columbus, Elkhart, Noblesville and Fort Wayne.

All participants will receive a reversible NFL Flag Football jersey, representing one of the NFL teams, and flags that are

theirs to keep at the completion of the season. "It is a huge thrill for players to find out which one of the NFL teams they will represent each season." All teams are formed by school and grade giving kids the opportunity to participate as a team with their classmates. Both boys and girls are invited to participate and registration is open to ages 4-14.

The season, which starts the weekend of September 22nd, 2012, consists of seven games, all located in the heart of Warren at a local playing field. There are no tryouts—everyone makes the team. Practices are conveniently scheduled an hour before each game resulting in a one day a week commitment to the league.

Each team is assigned a head and assistant coach, giving teams the ability to work with different types of coaching styles. Our games are played in a 5x5 format and provide young players a fun and exciting opportunity to engage in non-contact, continuous action while learning lessons in teamwork. All games are officiated by certified and trained officials.

Indiana Youth Flag Football, a division of Michigan Youth Flag Football, is part of the largest NFL Flag Football provider in the

country. This program provides young players a fun and exciting opportunity to engage in non-contact, continuous action while learning lessons in teamwork.

The program is designed to educate young people about football while emphasizing participation and sportsmanship. Participants learn skills and lessons that help them succeed both on and off the field.

ASSESSMENT FORMS

The Huntington County Assessor's Office will issue Form 11's, Notice of Assessment, for 2012 payable 2013 on July 6th, 2012. This is the taxpayer's formal notice of their new Reassessment assessed value as of March 1, 2012. The taxpayer has 45 days (on or before August 20th, 2012) to contest their assessed value. Many changes have occurred for the new assessments:

1. Reassessment: All parcels located in Huntington County were visited between the dates of July 1, 2010 and March 1, 2012. Any changes occurring to the property since the County's last inspection will be reflected in the new value. All structures present on the property were remeasured, checked for accurate descriptions or labels and verified for proper use.

Additionally, new land rates, new cost tables, and new depreciation schedules have been created and adopted by the DLGF for the March 1, 2012 assessment date. To view the new property record card, please visit the website: gis.huntington.in.us. To receive an appeal form, please visit the County Assessor page at: www.huntington.in.us. At this time, the amount of taxes that will be required for this assessment cannot be calculated, as tax rates have yet to be determined.

2. Mobile Homes: Any mobile/manufactured home that does NOT have a permanent foundation will now be assessed as personal property per IN code. Therefore, in 2012 payable 2013, the taxpayer will receive two tax bills: one for the personal property mobile home and one for the land and any other improvements/buildings on the property.

Any mobile/manufactured home that DOES have a permanent foundation will now be assessed as a one story over crawl/basement/etc.

3. Improvements on Leased Ground: An improvement on leased ground is no longer permitted by IN code. All improvements will be assessed to the parcel where it sits.

4. AG Land: Land will be assessed upon its use. Therefore, land will be assessed

as Agricultural when, and only when, the land is producing a crop. A garden does not suffice as crop land. Any land that is not farmed will be assessed as it is being used: residential excess acreage, commercial, industrial, etc. Additionally, the AG base rate has increased to \$1630 per acre. If the land is in a special program, such as CRP, wet land preserve, or forest reserve, that has not been recorded, please inform our office as soon as possible so that any necessary changes can be made.

5. Mailing Address: For any mailing address changes, please contact the Treasurer's office at 260-358-4862.

Last fall, IDEM approved revised rules that altered the environmental management

requirements of CFOs, and concentrated animal feeding operations, known as CAFOs. Indiana defines a CFO as "any animal feeding operation engaged in the confined feeding of at least 300 cattle, 500 horses, 600 swine or sheep, or 30,000 fowl, such as chickens, turkeys or other poultry."

All CAFOs are classified as CFOs, but CAFOs house more animals and have previously had more stringent regulations and permit application procedures. Under the new rules, CAFOs have the option to continue to have CAFO permits or assume general CFO permit status, said Purdue Extension nutrient management specialist Tamilee Nennich. Operations that would like to maintain their CAFO permits will need individualized permits approved by IDEM.

Under the new regulations (specific to CFO operators), manure application on frozen and snow-covered ground is no longer permitted, Nennich said. There are exceptions for emergency situations. Operators can apply for special permits that allow for winter application if a farm was previously permitted with less than 120 days of manure storage.

CFOs will also need to continue to monitor soil phosphorus concentrations and work to begin the very gradual process of reducing the phosphorus content of their fields.

Nennich said the potential risk of water pollution is one of the biggest concerns pertaining to high phosphorus levels in soils. While she believes the concern is justified, she said the new rules fail to account for the variance between fields. The risk of phosphorus water pollution is not the same for every farm.

"It's going to remove some acreage people have been using for manure application and increase the cost for manure removal and application," Nennich said.

Nennich said producers need to make sure they understand what the new rules mean for their individual operations. She encouraged producers to plan ahead for the winter and keep records to show compliance with the regulations.

There are about 1,500 CFOs in Indiana. More details about the
