MORRISON AWARDED

Evansville—Warren, IN, Clerk-Treasurer Marilyn Morrison has been named the 2004 recipient of the Indiana Association of Cities and Towns' Russell G. Lloyd Distinguished Service Award at the Indiana Association of Cities and Towns Annual Conference and Exhibition in Evansville, IN.

The Russell G. Lloyd Distinguished Service Award is given annually to an individual who has made outstanding contributions to local government and is named in honor of former Evansville Mayor and IACT President Russell G. Lloyd.

Morrison's involvement in the Indiana Association of Cities and Towns (IACT) has been extensive. She has served as a member of the Legislative, Executive, Finance and Budget and Nominating committees. She also serves on the Past President's Advisory Council.

Morrison was the first and only Clerk-Treasurer to serve as president of IACT from September 2001 to September 2002. Her presidency guided the transition of IACT's leadership, secured the Association's finances for future growth and development and advocated the institution of the Indiana Downtown® program.

The Indiana Association of Cities and Towns (IACT) is a coalition of municipal officials who seek to improve the quality of life in Indiana through effective government, and is a member of the National League of Cities. IACT is one of the oldest state municipal organizations in the country at 114-years, with more than 450 cities and towns as members. IACT advocates for municipalities as the official voice of municipal government in Indiana, and promotes good government through education, training and leadership.

GARFIELD PROJECT

Grant County has been through tough times lately. With the economic downturn we have had businesses leaving the county. The fact is that Grant County has the second worst unemployment percentage in the state.

Jim Davis, a Grant County native, creator of Garfield, the movie and the cartoon strip, has given Grant County a very unique opportunity.

He has granted the county the chance to place statues of Garfield in each community in the county. Each statue will be about five feet tall, made of high-density fiberglass, and each will have a personality that represents that community. They will be placed in highly visible locations and will be secure and easily accessible. Each statue will be user-friendly and provide photo opportunities.

The idea is to provide an educational opportunity for children, encouraging them to read and use their creative skills. It is also intended to enhance tourism, diversify the economy and create community pride.

After entering the company name, Web site address, and both phone numbers, the BBB was unable to locate a report on this company. If you receive a call of this nature, please hang up and report this call to the BBB immediately. Chances are, it's another twist to the stock scams taking place in northeast Indiana. If it's too good to be true, it probably is!
