BIKE ART

Individuals served by Pathfinder Community Supports and children served by Pathfinder Kids Kampus took old bicycles and turned them into works of art as part of the Bike Art Project sponsored by the AWS Foundation and associated with IPFW's Sculpture with Purpose project. Fourteen other agencies serving individuals with disabilities also participated in the project which was on display at the recent FAME Festival in Fort Wayne.

The creations made with recycled bicycles will also be attached to the public bike art racks being installed around Fort Wayne as part of IPFW's Sculpture with Purpose project on May 17th. The eco-friendly bike art will be attached to the sculptures to define the purpose as ready to use bicycle racks as well as celebrate the inclusion of artists of all ages and abilities. After seeing the bike rack which their creation would be attached to labeled "Cultural Sprouts" and looked like colorful corn stalks, the children at Pathfinder Kids Kampus immediately thought of popcorn. Their creation ended up being a bicycle turned popcorn cart. The individuals served by Pathfinder Community Supports looked at the rack labeled "The Watch-dog" and envisioned and created a 5 foot tall tree complete with leaves, birds and birdhouses. The bicycles for this project were donated by the Fort Wayne Police Department.

The bike art will also be on display at the disAbilities Expo on May 10th at the Memorial Coliseum in Fort Wayne.

TRASH BASH

Mother Nature has been relentless this winter and snow is finally beginning to melt and that means it's time to begin spring cleaning of our highways and byways. The Indiana Department of Transportation's

(INDOT's) annual Trash Bash takes place from April 5-27, 2014 and coincides with National Earth Day to aid in raising awareness of litter.

In 2013 more than 20,678 bags of trash were collected from alongside 3,400 miles of Indiana roadways by INDOT maintenance crews, Indiana Department of Correction offender crews and 1,633 Adopt-A-Highway volunteers. Also collected were 1,256 cubic yards of loose debris which included some strange items such as an electric meter, laptop, horse whip and cash.

"The Department of Corrections strives to rehabilitate offenders in many ways and cleaning up Hoosier highways is one program that allows them to give back to the community and turn doing time into doing good," said Indiana Department of Correction Commissioner Bruce Lemmon. "Partnering with INDOT in their Annual Trash Bash and helping brighten up our great state is one of our agency's favorite activities."

INDOT encourages all Hoosiers to keep Indiana's highways clean by following some simple tips:

- Don't litter: Set a good example for everyone, especially children.
- Be responsible: Carry a trash bag in your car instead of tossing litter out the window.
- Report it: Report areas where people have illegally dumped garbage to your local transportation, public works or conservation office.

Adopt it: To find out how your group can become involved in helping beautify an area near you by participating in Adopt-A-Highway, Sponsor-A-Highway or other highway beautification efforts please contact INDOT Customer Service for northeast Indiana at 1-866-227-3555.

As you travel along Indiana's roadways watch for crews as they are cleaning the roadside. Reduce your speed, use caution and consider worker safety when traveling through the area. For the latest news and information about INDOT, please visit www.in.gov/indot.

REGISTRATION DEADLINE

Indiana Secretary of State Connie Lawson is reminding Hoosiers that Monday, April 7 is the deadline to register to vote in the May 6 Primary Election. Hoosiers should visit IndianaVoters.com to verify, update, or start a voter registration.

"Hoosiers who fail to register will not be able to vote on May 6," said Secretary of State Connie Lawson. "The voter registration deadline is right around the corner. I encourage everyone who is not registered to register today to make your vote count."

Secretary Lawson also reminds young Hoosiers who will turn 18 before the General Election that they may register to vote and vote in the Primary Election.

Voters who choose to mail their registration must have a postmarked date of April 7 or before. Registrations postmarked after this date will not be accepted. Voter registration forms and submitting instructions are available on www.indianavoters.com.

Military families are encouraged to remind those serving overseas to register and request an absentee ballot. Active duty military members and their spouses should register to vote and apply for an absentee ballot by completing the Federal Post Card Application to ensure they

receive their absentee ballot on time. The application can be completed online at www.fvap.gov.

"Many military members are serving far away from home on Election Day," said Secretary Lawson. "We are calling on those here at home to remind their loved ones serving overseas to register to vote and to apply for an absentee ballot."

Hoosiers who are not sure if they are registered can confirm their registration online at www.indianavoters.com. Voters may also request an absentee ballot and verify their polling location on www.indianavoters.com. Voters may also visit their local county clerk's office or any branch of the Bureau of Motor Vehicles to register to vote.

## LIFEGUARD TESTING

Lifeguarding tests are now offered online for applicants seeking such positions at Indiana State Parks & Reservoirs facilities.

The test is for first-year applicants only. First-year applicants must pass the test as part of the job application. Candidates who have already worked at a state park or reservoir facility need not take the test again.

The test is 50 questions. Half of the test is about CPR and first aid, and half is about lifeguard training knowledge. The applicant must score at least 70 percent.

A link to the test and information for both first-year and returning candidates on how to

apply are available at [stateparks.IN.gov/lifeguardtest](http://stateparks.IN.gov/lifeguardtest).

Applicants must already be certified in lifeguarding and CPR for the professional rescuer before taking the test. If an applicant is in a certification class but has yet to finish, he or she may take the test but must complete certification before being hired.

The test serves as a hiring tool and is not a recertification of any type. Guards must recertify on

their own through their local Red Cross and YMCAs prior to the swim season.

The swim season generally runs from Memorial Day to Labor Day. Hiring will begin immediately and last until all positions are filled.

Lifeguard positions are available at Brown County, Clifty Falls, Versailles, Spring Mill, Harmonie, O'Bannon Woods, McCormick's Creek, Ouabache, Mounds, Indiana Dunes, Shakamak, Lieber, Turkey Run and Prophetstown state parks.

## DIG SAFELY

With April marking National Safe Digging Month and the start of many outdoor projects, NIPSCO urges residents and businesses to help protect the public from serious risk or injury by calling 811 two business days before starting any digging project to have underground utility lines marked.

In addition to the risk of serious injury, not calling 811 before beginning a digging project could also result in fines up to \$10,000 or more and the cost to repair damages. It's the law.

The highest safety risk to underground natural gas utilities across the county, and in Indiana, continues to be damage caused by

those who dig into a line without calling first for the underground lines to be marked.

In 2013, there were approximately 400 cases of system damage caused when no markings were requested across NIPSCO's service area. Nearly 60 percent of those were the result of contractors, while the remaining damages were caused by residents. The most common digging projects where damage occurred involved fences, landscaping and water and sewer projects. Planting shrubs and trees and installing decks and pools are also common digging projects.

"One simple toll-free call to 811 before digging can mean the difference between saving a life and causing serious injury or worse," said Doug Dale, executive director overseeing damage prevention and pipeline safety. "That's why it's important to have your underground utility lines marked regardless of the size of the project or who is doing the digging work."

Once a call is made, a professional utility line locator will visit the dig site to mark the approximate location of underground utility lines with paint or flags. After the site has been accurately marked, it is safe to begin digging carefully around the marked areas. It is important to not disturb or move the markings or flags prior to digging.

NIPSCO and Indiana 811 offer the following recommendations for a busy digging season:

**WHO:** From homeowner to business, everyone is required to call 811 before digging.

**WHAT:** One call to 811 gets your utility lines marked free of charge. Tell the operator where you're planning to dig and what type of work you'll be doing. Locating crews will arrive within two business days to mark all utility-owned underground lines, pipes and cables.

**WHEN:** Whether planting a tree or garden, installing a fence or building a deck, every digging project, no matter how large or small, requires a call to 811 two business days before you dig.

**WHERE:** In a yard or on a worksite, it's important to know what's below before you dig.

**WHY:** It's the law and it helps you and your neighbors avoid injuries, property damage and potential fines.

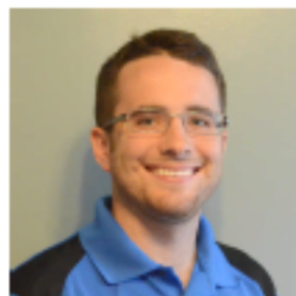
