Let cool slightly and slowly pour over the stiffly beaten egg whites, beating until it starts taking shape, add vanilla and nuts.

My mom always added black walnuts to hers, you can also add diced candied cherries, pecans or crushed peppermint, when the candy is very stiff drop by spoonful on wax paper. Store in air tight container.

Notes for December from Warren Town Clerk's office are as follows.

Alley Paving has been delayed until Spring due to weather. Notice will be given prior to the start of work.

Town Trash Pickup will be on the Friday following Christmas, December 26th and on Friday, January 2nd following New Years.

Bows are again being sold by the Warren Area Chamber of Commerce for \$2 each. The bows serve as the only decoration on the Town Christmas Tree at Wayne and Second Street except for the lights. White bows are purchased in memory of those deceased, red bows for those living, and yellow for those who are now serving or have served in the military. Names of the person(s) being honored are written on each bow before being placed on the tree. This year the bows are being provided by Gebhart's Floral Barn where they may be purchased as well as being available for purchase at Town Hall. Proceeds go toward supporting the downtown lighting project.

A vacancy will exist on Town Council as of January 1st due to the resignation of a current member. The appointment will be for a term of four years. ### 4H ENROLLMENT

Indiana 4-H enrollment is now open in Huntington County through January 15, 2015. 4-H is a premier source of enjoyable, educational programs to help young people reach their full potential. Plus, new for 2015, enrollment is easier than ever with the 4-H Online system, <https://in.4honline.com>.

Indiana 4-H is the state's largest youth development program for grades 3-12, reaching over 200,000 youth in all 92 counties. 4-H Youth Development Educators in each Purdue Extension county office coordinate local activities.

In Huntington County, approved adult volunteers teach young people specific skills related to a wide variety of subjects through hands-on, experiential learning. Youth also develop leadership and citizenship skills by participating in one of 34 or-

ganized 4-H Clubs. Subjects include: science, technology, engineering, and math (STEM); agriculture; citizenship; healthy living; art; consumer and family sciences; and more. In 2013, a Tufts University study showed that 4-H members also excel in positive youth development areas compared to peers, including:

- Four times more likely to contribute to their communities (grades 7-12)
- Two times more likely to make healthier choices (grade 7)
- Two times more likely to be civically active (grades 8-12)
- Two times more likely to participate in extracurricular STEM programs (grades 10-12)

Now, the new 4-H Online system makes it even more convenient to offer enrollment, event registration, calendars, and secure payment online.

Youth may be enrolled in Huntington County 4-H by January 15, 2015 online at <https://in.4honline.com> or by visiting the Huntington County Purdue Extension office, 354 N Jefferson St, Ste. 202 from 8 a.m. to 4:30 p.m. weekdays. The \$15 fee per child includes all Indiana 4-H program fees.

### 4-H SCHOLARSHIPS

State 4-H Scholarships dues January 15

Huntington County 4-H members looking for financial assistance with upcoming post-high school educational efforts are encouraged to apply for state 4-H scholarships. Available scholarships include:

- Indiana 4-H Foundation Senior Year Scholarship – 4-Hers who are currently high school seniors may apply for a scholarship of a minimum \$250. These funds can be used towards any post high school training or degree of study and does not have to be in Indiana.

- Indiana 4-H Club Scholarship – High school seniors planning to attend Purdue University, West Lafayette campus, and studying a degree program in the College of Agriculture or Health & Human Services may apply. This scholarship is based on financial need, along with scholastic ability and achievement in 4-H club work and covers a large portion of tuition fees.

- Indiana 4-H Youth Accomplishment Resume – 4-H members who are in the 10th grade or older may apply for a minimum \$1000 scholarship. Application is based upon a cover letter and résumé which outlines the skills and knowledge gained through the 4-H program at the local, area, and state level. These three scholarship opportunities each have an application deadline of January 15th. ### WATER IS IMPORTANT

As purchases of holiday decorations are in full swing, the Indiana State Fire Marshal is encouraging safety when selecting and maintaining Christmas trees.

Fire Marshal Jim Greeson wants Hoosiers to keep in mind these fire safety tips when picking out and maintaining a tree:

- When buying a live Christmas tree, choose the freshest tree possible. Harvest at a Christmas tree farm, or select a freshly cut tree that hasn't been on the sales lot long.

- Choose a tree with fresh, green needles that do not fall off when touched.

- If you choose an artificial tree, be sure it is identified by the manufacturer as fire retardant.

- Christmas Tree Maintenance
- Before placing the tree in the stand, cut 1-2" from the base of the trunk.

- Make sure the tree is at least three feet away from any heat source.

- Make sure the tree does not block an exit.

- Keep the tree stand filled with water at all times. Add water daily to the tree stand. Live Christmas trees dry out quickly once they're brought into a home.

Tree Lights and Decorations

- Make sure to examine all lights and ornaments when decorating a tree.

- Some lights are either for indoor or outdoor use only, while some may be used in either location. Make sure the lights are appropriate for the venue.

- Replace any string of lights that have worn, in addition to broken cords and broken bulbs.

- Periodically check the wires -- they should not be warm to the touch. If they do feel warm, replace them.

- Never decorate the tree with lit candles.

- Always be sure to turn the tree lights off before leaving home or going to bed.

### THE TRUTH ABOUT ELDERLY

#### MOTORISTS

The American Automobile Association says most seniors are safe drivers, themselves, and that they are in favor of measures to ensure that elderly drivers are fit for the road.

A new report issued by the AAA Foundation for Traffic Safety says that 80 percent of drivers over the age of 75 are in favor of medical screenings for drivers who are over 75 years of age. In fact, says the Association of Mature American Citizens, older drivers tend to be safer drivers and the triple-A's study proves that they are concerned about road safety.

In fact, says AMAC, the study

shows that "nearly 90 percent of older drivers (65 and older) reported no crashes in the last two years and that 90 percent of older drivers reported no moving violations."

"Even though public perception tends to unfairly characterize seniors as a menace on the road, these findings indicate that older Americans tend to support policies to keep themselves safer behind the wheel," says Peter Kissinger, President and CEO of the AAA Foundation.

### PUN AT YOUR OWN RISK

#### WHEN VISITING THE ORIENT

On this side of the Pacific Ocean we respond with groans when we hear a pun, but in China they don't think wordplay is all that funny, according to the Association of Mature American Citizens.

China's State Administration for Press, Publication, Radio, Film and Television, in fact, has issued a statement warning the local media that puns are against the law. "Radio and television authorities at all levels must tighten up their regulations and crack down on the irregular and inaccurate use of the Chinese language, especially the misuse of idioms," according to the statement.

"It could just be a small group of people, or even one person, who are conservative, humorous, priggish and arbitrarily purist, so that everyone has to fall in line," says David Moser, aca-

demic director for CET Chinese studies at Beijing Capital Normal University.

One AMAC investor-turned-punster recalled the time he considered putting his money into the shipping sector and tried to find suitable Chinese junk bonds.

### MAY WE HAVE A WORD?

It's a brave new world with a language all its own, says the Association of Mature American Citizens. The proof is in the Oxford Dictionary's pick for the 2014 Word of the Year-vape.

It's a verb, say the revered English lexicographers, and it means "to inhale and exhale the vapor produced by an electronic cigarette."

Vape beat out such new entries made this year as budtender. That is the new name for the person who serves you at a shop that sells marijuana. Then there's normcore, the somewhat contradictory term for the practice of wearing unfashionable clothes as a fashion statement.

And, in the same vein, the folks in Oxford added the word, slacktivism, a combination of slacker and activism. It refers to those who can't be bothered getting too involved in a social or political cause.

first time at 40 years old. I decided I was going to enter the world of competitive body building. I told myself, "if not now, when?" At a ripe old 40 years old, I took home 3<sup>rd</sup> place in the masters category and 3<sup>rd</sup> place in the heavy weight category. Since then, I have competed in a total of 11 shows.

I continued to train but began to notice that I was becoming more and more tired than usual. At first, I thought it was old age, but I was wrong. Little did I know that my world was about to turn upside down. In October of 2006 my world was rocked. I was diagnosed with stage 4 Hodgkin's Lymphoma. Not wanting to waste any time, I immediately started chemo. As it tends to do in small towns, word of my diagnosis traveled fast. The whole town was talking saying things like, "Haggerty's got cancer" and "he is full" and "he is going to die." After hearing the buzz around town, I wrote a letter to show them all that I was ready to fight. I made it clear by saying, "this is what I have, this is

what the doctors say, these are my odds, but I AM GOING TO BEAT IT!"

I trained to the best of my ability, which at times was never, but the training that I did really took a toll on me, but training was what I loved, and I wasn't going to let the cancer or the chemo take that away from me. The doctors said that because I was healthy and young, they were going to offer me a chemo regimen that was brand new. It was a German regimen, and they hammered me with it. After the first week of chemo, I was technically clinically cured. Two months later, I went in for another CT scan and the cancer was completely gone. Needless to say, this was a miracle. Throughout this whole time I was in complete prayer mode. I had been studying faith and prayer healing. The doctors wanted to keep the chemo going, but the chemo was literally killing me. Even though I wanted to fight with all I had, I told them I didn't know if I could make it through the last round. They decided that with all the results and numbers that we could stop

treatment. It was terrifying and a relief all at the same time. I didn't want to go through any more chemo, but I panicked because I was afraid that quitting chemo early would help the cancer come back. The chemo was my life line, my cure, and I was scared of what could happen if I stopped. In spite of all of my fears, in February 2007, the treatment stopped.

In 2008, I took the stage for the first time, after cancer. I didn't do so well, which is to be expected after all of the damage chemo does to the body, but it felt amazing because I was still alive, still fighting, and still competing. It was the most surreal feeling in the world. I did that show for my wife and kids. They had seen me go through everything and this was a way that I could "thank them." This was the most memorable show for me, and it made me realize that my passion for fitness is unreal. The pursuit of fitness helped me get through so many trials in my life, and I want to show others how important this actually is. Fitness and the gym aren't merely ways to lose weight and look better,

they're ways to make a person feel good, keep a person out of trouble, teach a person discipline, and most importantly, keep a person healthy. In our culture today, people work out mostly because they want to look a certain way, but it honestly doesn't matter what you look like, what truly matters is how you feel and how your health is.

Stacy and my dream was to give back to this community and see a gym here in Warren. We took our dream and ran with it. Warren Health and Fitness is our dream come true; it's a health club for everybody. It offers all kinds of equipment and lounge areas for whatever you need. A passion and drive to be physically fit literally saved my life, and I know that it can do the same for others. It is our hope and
