OCTOBER IS NATIONAL BREAST CANCER AWARENESS Month

INDIANAPOLIS—Organizations and individuals across the country are donning pink ribbons as they prepare to observe National Breast Cancer Awareness Month during October.

Although breast cancer issues are being tackled year-round, special emphasis is given to educating women and their families about this disease every October. Health officials say that a great deal of progress has been made in detecting and treating breast cancer, but there is still much work to be done in order to eradicate this disease.

This year in Indiana, it is estimated that 4,600 women will be diagnosed with breast cancer, and 900 Hoosier women will die from this disease.

To kick off Breast Cancer Awareness month, staff from the Indiana State Department of Health's Breast and Cervical Cancer Program (BCCP) will be participating in a special event on Wednesday evening, October 1 at the Indianapolis Artsgarden, during which this glass structure will be illuminated in pink lights. The BCCP will also take part in the American Cancer Society's Making Strides Against Breast Cancer walk on Saturday, October 11, in downtown Indianapolis.

According to Sue Percifield, R.N., director of the Breast and Cervical Cancer Program, all women over age 40 should get a screening mammogram and a clinical breast exam each year. Percifield says that practicing monthly breast self-exams is also a healthy habit for women of all ages. "Unfortunately, there are many women who do not take advantage of these early detection methods," said Percifield.

State health officials report that women of racial and ethnic minorities as well as women with low incomes and women living in rural areas are just a few of the groups that are under-screened for breast cancer.

"One reason that women may not access annual cancer screenings is that they do not have medical insurance or their insurance will not cover mammograms, and they simply cannot afford to pay for these important tests," said Percifield.

The Indiana State Department of Health's Breast and Cervical Cancer Program (BCCP) is partnering with medical providers around the state to help Indiana women who meet certain age and income requirements get access to free clinical breast exams, mammograms, and some breast diagnostic tests. The BCCP focuses primarily on women aged 50-64 for breast screenings
