Grissom Community Air Show promises two days of flying excitement July 26-27



# Kudos, Kicks & Karats

#### WARREN SHOPPING DISTRICT IN WWII

With the passage of time and the changing of our society, the size and character of Warren's shopping district has undergone a radical change since World War II. In fact, our young people might find it hard to believe how extensive these changes have been. So I've taken this opportunity to describe store-by-store just what Warren's shopping district had to offer fifty years ago.

How could a stranger to town now imagine that Warren, with a Population of just over 1,200, had three grocery stores downtown (plus one on the north side of town), two drug stores, two "five-and-dime" stores, and a very large department store? These stores were supplemented with a variety of other stores that provided all the necessary services and products for the population.

In reviewing "downtown", we start at the Church of Christ on the corner of Third and Wayne Streets, and head south on the East side of the street. Across from the church was a gas station that has survived till this day. Then, it was a convenient place for we teenagers to get a quick "smoke" before heading over to school. Next door was a large Ben Franklin "fiveand-dime" store which employed 6-8 people.

Ben Franklin was part of the large chain of stores that still exist today. And next door, heading toward the river, was the Breedlove Grocery, operated by the Breedlove family. The family lived upstairs above the store. (This store/living quarters arrangement is still used in towns overseas.)

Across the alley from Breedlove's was the Myers Department Store, where fabrics, dresses, clothes, etc. were sold on the left side of the store. On the right side of the store, they sold shoes and floor coverings. (Their shoe department had one of those X-Ray machines where you put your foot in to see how the shoe fits—these machines are outlawed now.) A sign identifying this site as Myers Department Store can still be seen on the wall next to the alley.

Next to Myers was McFarren's small "five-and-dime"—which was much older than the Ben Franklin Store. And next to McFarren's was

Warren's original and very small movie theater. During World War II, we used to pay 15¢ to see a Saturday afternoon cowboy show. And the included Movietone newsreel provided our only pictures of the war going on all over the world-remember, no TV available then!! And on the corner was the popular Tam's Drug store with its oldfashioned ice cream fountain and shiny stools. (The Drug Store also sold bottled liquors in a small section way at the rear of the store; so customers could come in the backdoor unnoticed to make their purchases!) And above the Drug Store were apartments for young married people.

Across the street on the southeast corner of Second and Wayne was the Warren Town Hall (even then!) where the administration of Warren was centered. The Town Marshal had his office there, along with those who took care of the tax records, etc. And in the rear of the building was the fire truck garage and Warren's one-cell jail.

Next to the Town Building was the second of Warren's three downtown groceries. It was a Kroger Grocery operated as part of the Kroger chain. Further down the street was the Warren Post Office. Now, we didn't have in-town mail delivery. (In fact, the houses didn't even have house numbers then.) We had to either go to a window to collect our mail; or, if we had a mail box with a combination door, we could pick up our mail day or night. Oh yes, this author used his bike to personally deliver any Special Delivery Letters—for 5¢ each!

Sharing the same entryway as the Post Office was the third downtown grocery store—the Sanitary Grocery, operated by Gene Turner and the Turner family. And next door was the second Drug store—Coleman's Drugs—operated by Kenneth Coleman. Can one imagine now that we had TWO drug stores? And both stayed in business well after the end of World War II. Coleman's was an older, more old-fashioned drug store with oiled, wooden floors, a small magazine section, and an old-time ice cream fountain.

We are now getting down to the lower end of the business district. Across the alley from Coleman's was Stucky's Hatchery, a Barber Shop,

#### LIVESTOCK REMINDER

4-H members are reminded that they need to have the appropriate health papers in order to show their 4-H animal at 4-H and Open Livestock Shows this summer.

Most animals exhibited at livestock shows are required by law to have a health certificate completed by a veterinarian. Most certificates are good for 90 days. Swine must also have a blood test which is sent to the state veterinarian's office for lab results. This process takes approximately 10 working days or 2 weeks.

It is suggested that a parents name also be on the certificate of inspection so that is can be linked with the young person on the form.

The swine blood test is for pseudorabies (PRV). All swine for livestock shows must be tested for pseudorabies (PRV) or have a current VQ status and have a current Certificate of Veterinary Inspection approved by the Board of Animal Health prior to the show. (Swine from VQ herds must also have an approved certificate.)



## A Day in the Life of a Virus

Since most of the viruses that give people trouble tend to be in the form of e-mail viruses, I'm going to give you the low down on how most of these puppies work with our computer buddy, "Jim".

Let's say Jim goes to work and checks his e-mail like he always does. He notices an e-mail from someone he knows with an attachment. The e-mail says something generic like "Hey, check out this attachment, it's really cool".

In all likelihood, there will be no signature (although there could be). So, old Jim clicks the little paperclip icon and runs the attachment. It probably ends in ".exe" or ".zip".

Maybe he gets a cute little display

on his screen (the Happy99 virus gave the user a fireworks display). Jim thinks "Hmm, that was cool" and gets back to work, completely unaware that he has been infected.

Now the virus goes to work. The first thing it will probably do is get into his address book and send itself to everyone in it. When these people get the e-mail virus, it looks like their friend Jim has just sent them a cool little file to check out. Old Jim doesn't have a clue that this has even transpired but now all his friends are opening up this little file and infecting their own computers (and sending it out to everyone in their address books). Do you see how these things can infect millions of computers in a hurry?

Another route the virus can take is to send a second e-mail with itself attached to anyone you are sending a message to. For instance, say you send Jim a message. Jim checks his e-mail and sees your message plus another message from the virus that you didn't even know you sent.

A quick way to check and see if you are infected with this type of "piggy back" virus is to send yourself an email. If you get a second e-mail with an attachment, you're infected (note - this only works for viruses that spread themselves as described above).

Another way these e-mail themselves is by choosing an address from your address book as the "from" person (The Klez virus does this). So, it looks like one of Jim's friends is sending out viruses form their computer, but it's really coming from his machine.

Jim's friend then gets lots of e-mail from people telling him that he's sending out viruses! Of course, he's not, but Jim is. (In addition, Jim may get an earful from this (now former) friend once he figures out what happened!)

OK, I now what you may be thinking. Maybe you have 500 people in your address book and it seems like you would notice that there was an excessive amount of e-mail going out when you send / receive.

Well, you may with some viruses, but the smarter ones have an "SMTP" engine built in. Simply put, they can send e-mail from your computer without using your e-mail software or server. This is done is the background and may seem like nothing more than a sluggish internet connection.

Sneaky, aren't they? That's how most e-mail viruses work.


