

#### **Crunchy Bean Salad**

2 ribs celery, 1 yellow pepper, 1 medium unpeeled apple, 1 small onion all diced fine. 1 can black beans, 1 can kidney beans drained and rinsed. Make a dressing of 3 tablespoon vinegar, 2 tablespoon olive oil, little salt and pepper. Mix together celery, apple, yellow pepper, beans and onion. Mix the oil and vinegar, salt and pepper add to the beans mixing well to coat. If desired add about half cup chopped cilantro as a garnish.

Wayne also read on the internet something I had never heard of to treat a mild burn, keep a small amount of all purpose flour in the refrigerator and apply this to the burn. Do not use this for a severe burn that will blister or become open flesh. We haven't had a need to try it but perhaps it might work.

that they should be kept on a leash at all times too. I know this may sound far-fetched, but they have some really good reasons for all of this. For instance: Your dog would have a better chance of being found if lost. Then too, if you dog has bitten another dog or even a child, she would have a better chance of survival than a dog without a rabies tag.

## **4-H S**CHOLARSHIPS

The Huntington County Extension Office currently has applications available for seven local 4-H scholarships. Huntington County 4-H members who are eligible may stop by the Purdue Extension – Huntington County Office to pick up an application or you may request the applications via email from <a href="mailto:highley@purdue.com">highley@purdue.com</a>, or by going online.

1) Janell Marie Saunders Memorial (\$1,000) – open to a current high school senior or Huntington County 4-H alumni who completed their final year of 4-H within the past two years. Applicants need to be pursuing post high school studies in the area of nursing or a health/medical related field.

2) Ray Vanderspool Memorial (\$1,000) — applicants must be a current high school senior. Selection criteria include 4-H member record, community involvement and academic record.

3) County 4-H Swine and 4-H Beef Scholarships (\$500 each) –applicants must be enrolled in the 4-H swine or the 4-H beef project for a minimum of 5 years, with 4-H record and school/community activities considered in the selection process.

4) Huntington County 4-H (2 scholarships @ \$500 each) — open to a current high school senior or Huntington County 4-H alumni who completed their final year of 4-H within the past two years. These scholarships will be presented during the 4-H Fair in July at Hier's Park.

5) County 4-H Goat Scholarships (2 scholarships @ \$500 each) –applicants must be current high school senior or Huntington County 4-H eligibility was within the past two years. 4-H records along with school/community activities considered. Must be in the goat project at least 5 years including the current year.

6) \$250 Horse & Pony scholarships applicant must be planning some post high school study or training (i.e. college, trade school, or short course). Does not have to be in Indiana. Applicants must be a current, active H & P member and been enrolled in the Horse & Pony project for at least 5 years, including current year.

# MY TOWN and Yours

About Civil War time, the north side of Third Street was part of the business district [at that time there was a big ravine that went through where Wayne Street is.] At one time, there was a general store at the corner, where the library now stands, who carried a large stock of goods. As the story goes he ordered a barrel of vinegar and in shipping a mistake was made. What the Warren merchant got was a barrel full of whiskey, which at that time was sold for small change.

He stored it in his backroom waiting to ship it back. A few weeks went by. When it came time to load it and ship it back, the barrel seemed to be nailed to the floor. A couple of men took hold and pushed, suddenly tipping the barrel over on its side and the men tumbled to the floor. That

barrel was empty. They found that someone had crawled under the building, which stood two or three feet off the ground, and had bored a hole, through the floor, into the barrel, to drain out the liquor. Then he had driven a wooden plug through the floor, into the barrel, and it was the plug that was holding it stationary.
