## PART D SEMINAR

The Warren Pharmacy will coordinate a Seminar that will focus on the new Medicare Part D Prescription Drug program. The seminar will be open to the public and will feature Twila Stech, a representative of the Senior Health Insurance Information Program (SHIIP). It will be held at the Knight-Bergman Center in Warren, on Thursday, 20 October 2005 at 6:30 PM.

Background: Beginning January 1, 2006, a new program will provide prescription drug coverage under Medicare. It will be a voluntary program, which provides Prescription Drug Insurance for all people who are eligible for Medicare. It will be administered through dozens of Insurance Companies and hundreds of different plans. Not everyone will need this cover-

age. Those who already have Prescription Drug coverage through their employer or retirement plan may not want, nor need, this coverage. People who have both Medicare & Medicaid will be automatically enrolled in a plan! Enrollment will not begin until November 15, 2005.

As with any Insurance plan, there will be Premiums, Deductibles and Copays. For now, the important thing to do is to become informed about the program and whether or not you should choose to enroll in a plan.

If you are a Medicare beneficiary with limited income and resources, you may be able to get extra help paying for prescription drugs under this program. You will need to apply now to Social Security to see if you qualify for help paying for your monthly premiums, deductibles and co-payments under this new prescription drug program. The Social Security office in Wilkes Barre, PA has mailed out millions of applications to Medicare recipients, which it believes might qualify for extra help. If you have received an application and think you might qualify for this assistance, you must fill out the 5 pages & 16 questions and send it in. This does not enroll you in a Medicare Part D program. It will only allow you to know if you qualify for help paying for your monthly premiums, deductibles and co-payments.

### HOW TO AVOID GETTING VERY SICK

#### TAKE A SHOT AT PREVENTING THE FLU

It's time for your flu shots! Each year we offer them to help you avoid influenza and up to a week of serious suffering. After the worst symptoms are gone, you could feel weak for days.

We're not alone in this effort. A re-cord number of companies nationwide are expected to set up shot shops this season. Influenza will cost American companies an estimated \$1 million in lost productivity this year. More em-ployers than ever offer free flu shots.

It's an attempt to reduce the number of people who will get the flu and stay home, or even worse, come to work and spread the virus to others.

The Centers for Disease Control and Prevention advises that the flu is a contagious respiratory illness caused by influenza viruses.

Symptoms include fever, headache, weakness, dry cough, sore throat, muscle aches, and runny or stuffy nose. In some cases, nausea, vomiting, and diarrhea are present, but children are more likely to have these symptoms.

## COUNCIL NOTES

The Warren Town Council met at 6:30 p.m. Monday evening, Oct. 12 in Assembly Hall. President David Scheib conducted the meeting which opened with all in attendance repeating the Pledge to the American Flag.

Minutes of the regular meeting of Sept. 12 were approved as submitted.

The Park Board met prior to the Council meeting. Kim Coolman reported they plan a walk through of Tower Park on Saturday, Oct. 22 at 10 a.m. In the event of rain it will be rescheduled.

Council approved Sarah Flaughter as a new member of the Park Board.

The next Park Board meeting will be March 13, 2006 at 6 p.m.

The Revitalization Committee presented their first complete quarterly report. The reported included: project description; Streetscape issues; a want list; a list of things to do; two public meetings, one with Council and one with Chamber of Commerce (noon); and future meetings of the group.

Determination of 2006 wages/salaries was discussed so that Ordinances can be completed.

IMMDA negotiations were also discussed as it relates to AEP supplying electrical power to the Town of Warren.

Council set Halloween Trick or Treat hours for 6 to 8 p.m. only on Oct. 31.



### GIVE HOPE

Local Red Cross chapters across the country have geared up to recruit and train a wave of new volunteers who are coming forward to help their Gulf Coast neighbors affected by Hurricanes Katrina and Rita. The American Red Cross anticipates 40,000 new volunteers will join its ranks by year-end.

A retired restaurant owner, Larry will be working as a Supervisor at a fixed feeding site. Larry will join thousands of other volunteers providing assistance to Hurricane victims. The Red Cross envisions the cleanup and rebuilding to be long

and hard and the organization intends to be there, represented by volunteers like the Larry Smith to help people cope with their loss and frustration.

Experienced Volunteer, Roger Parker has already been assigned to Pensacola for 3 weeks, came back for a week of rest and is now working at feeding site in Lake Charles, LA. He stated that they are currently serving about 21,000 meals daily to residents who still do not have electricity or running water. Roger plans to stay and help until at least Christmastime.

"For volunteers, the experience can help them realize a broader sense of purpose to their lives," said Karen Bennett. "Local Red Cross chapters can work with volunteers to provide rewarding experiences, whatever their schedule. We depend on volunteers, who constitute 97 percent of our total work force, to carry on our humanitarian work." "There is a power in the Red Cross symbol that draws people who are looking for help and comfort. It makes me proud to be wearing the Red Cross vest," concluded Jim Klosterman.
