### GED ON TV

Adults who dropped out of high school now have a second chance to earn a diploma. The GED ON TV program prepares adults to take and pass the GED tests and earn the Indiana GED High School Diploma. Students will watch 39 half-hour lessons

from home on their local public television station, brushing up on the reading, writing, social studies, science, and math they will need to pass the GED Tests. The television programs for this semester will start the week of February 12, 2006.

The \$45 enrollment fee provides the student with a pre-test, three workbooks, a Casio fx-260 solar calculator like the one they will be permitted to use on the first half of the GED test, newsletters, a toll-free telephone Helpline, the official GED Practice Test, and a Test Fee Voucher worth up to \$60 that will pay for the student's GED test at any local testing center in Indiana.

Fifteen percent of all high school credentials issued in Indiana are GED diplomas. Over 7,000 Hoosier adults have earned a GED diploma with the GED ON TV program. GED ON TV students say that they like being able to

## KUDOS, KICKS & KARATS

### HOME IMPROVEMENT PROJECTS CAN BE HAZARDOUS TO YOUR HEALTH

Though spring is a couple of months away, it's time to think about what home improvements you will make this year.

They can be a balancing act in more ways than one. First, you have to decide whether you can do a project yourself, whether you have to hire it done, and what you can afford to do.

If you don't feel comfortable doing any job, don't do it. If you are uncomfortable working on the roof because of its height, get a professional to do what needs to be done.

It's best to pass on any job that requires specialized tools. You can probably rent large equipment, but the question after that becomes whether you can operate it skillfully and safely.

Electrical work should be done by a professional. The dangers of shock and electrocution are too great to risk. And as a do-it-yourselfer, you could make dangerous building code violations. If a plumbing job requires more than changing a faucet, you are better off with a professional as well. Water damage is expensive to repair.

When you decide you are capable of doing a job and have the time to do it, keep this safety advice in mind.

- \* Keep the work area neat. Pick up tools and sharp objects. Keep extension cords untangled, and pull nails and screws out of discarded boards.

- \* Unplug electrical tools before adjusting them. Follow safety guidelines in the instruction manual.

- \* Wear sturdy clothes, boots, safety glasses, and gloves. Wear a dust mask when sanding wood or wallboard.

- \* Place a ladder on a flat, firm surface. Keep your weight centered on it.

- \* Varnishes, solvents, and adhesives may contain toxic vapors. Check the labels to see if you need a respirator.

- \* Keep a fire extinguisher in your workshop.

### UNEXPECTED NECESSITIES AFTER A DISASTER

A nurse who worked during Hurricane Katrina offered some practical suggestions for coping with a disaster, in an article in The New England Journal of Medicine.

First, be sure everyone who evacuates is wearing comfortable shoes. Check children, especially.

Keep a bottle of pain reliever with you. When there is no water for coffee and no Cokes are available, you might have caffeine-withdrawal headaches.


Have flashlights and plenty of "D" batteries. You need them even during the day while in shelters or hospitals.

Have extra underwear in a pack in your desk, locker, or backpack. Find ways to make sure your needs are known. Rescuers may not realize that your situation is desperate.

Have courage and remain calm if you are confronted by a fearful, and armed, person.

In shelters, create morale-boosting activities. Her hospital organized prayer services with a chaplain and gospel singers.

A caring team of professionals is required to make sure patients survive in a hospital, she wrote.

## CHAUTAUQUA

The Chautauqua Club met January 6, 2006 at 1:30 p.m. in the Calico Room at the United Methodist Memorial Home.

The meeting was called to order by Vice President, Jane Ruble who asked everyone to repeat the creed. Secretary's report was read. A new member, Lucille Beavans was welcomed into the club. Roll call was answered by 24 members telling about their dream trip. Treasurer's report was given.

Elaine Eckman gave a very interesting talk on the life of the world-renowned pianist, Ignace Jan Paderewski. He was a Polish pianist, composer and statesman. During WWI he abandoned his career as a musician to devote his energies to the cause of Polish freedom. At the close of the war, Poland again became an independent nation, largely because of the efforts of Paderewski.

Paderewski was born November 6, 1860 in Podolia, now a part of the Ukraine in Russia. His father was an administrator of large estates. His mother was a daughter of a university professor. He began piano lessons at the age of 6, when he was 12 he entered the Warsaw Conservatory and six years later he was appointed a professor there. He later became a concert pianist playing to enthusiastic audiences in Europe and America. American audiences heard him for the first time in 1891 in New York City. Within 90 days he gave 117 recitals. In 1891 he bought an estate in Switzerland overlooking Lake Geneva. He often lived there during his later years.

Paderewski's devotion to his native Poland is now a part of history. During WWI he gave concerts to raise relief funds and helped enlist men for the Polish army.

In 1922, Paderewski resumed his concert career. His first 60 concerts are said to have earned

him \$460,000. He had given away most of the money he had previously earned to help Poland.

He made his last American tour in 1939 at the age of 78. After suffering a mild heart attack he returned to Poland. A few months later, Germany invaded Poland. Once again he devoted himself to the cause. Late in 1940 he returned to the United States to make his home on a ranch in California.

Paderewski died on June 29, 1941 in New York City, he is buried in Warsaw, Poland.

Are you among the many people who have experienced the death of a loved one? At some point someone may have said to you, "It just takes time." Grieving involves more than just the passing of time. Moving successfully through the grieving process also involves work.

Susan J. Zonnebelt-Smeenge, and Robert C. De Vries are the authors of a book entitled, "Getting to the Other Side of Grief: Overcoming the Loss of a Spouse." In this book, they offer suggestions that can help you take charge of your grief and move toward healing. The first tip is to tackle your grief by attending a grief workshop, or a grief support group. Journaling your feelings, emotions, and reactions, will give you time to sort through thoughts that are associated with your present state of mind. Getting rid of the deceased person's belongings can be extremely painful, but it can be beneficial in helping you move toward healing. Taking on this task immediately following the funeral is not advisable. Wait for a few weeks

then move the things into a storage area, and you can sort through them at a later time. This will prevent you from making hasty decisions with regard to the items you may want to keep, and those that are not so important to save.

Humans are creatures of habit. Normally, we sit in the same pew at church, the same chair at the dinner table, etc. Work toward creating new "normals" in your life. This process will require a great deal of effort on your part. Perhaps you can change your routine, participate in some new activities, or develop an interest in a hobby that is suited to you as an individual. Family and friends can provide you with a great support network, but when it comes to making changes in your life, it all begins with you.
