This year's Veteran's Day celebration consists of two separate events. The first is a free Veterans' Dinner to be held at American Legion Post 7, 54 W. Market Street, Huntington, on Saturday, November 6th, from noon to 3:00 p.m. This is a free dinner and all veterans are welcome, but please, veterans only.

The second event, the annual Veterans' Day program, will be held at 6:30 p.m. Thursday night, November 11, at the First Church of the Nazarene, 1555 Flaxmill Road, Huntington. ### LOCAL COUPLE RETIRES AFTER 40 YEARS IN FUEL BUSINESS

Ron Boxell (Big Ron) started with Mac's Oil Company on June 1, 1964. At the time of Ron's hire, Mac's Oil Co. was owned by Harry and Ruby McElhaney, and their Mobil Station was located on the corner of Third and Wayne Street, the current location of Accent Interiors. Ron drove the

fuel delivery truck and Bonnie worked with him on the week-ends. During this time, the bulk plant was located on the corner of Grover and Monroe Street, the current location of the Bill Mann residence.

In the fall of 1967, the bulk tanks were moved to their new location at 461 E. First Street, where Big Ron and Bonnie currently live. At this time, the bulk truck was kept at the McElhaney's home on Wayne Street, next to the Mobile Station, the current location of the Richard Brown residence.

Harry McElhaney passed away in 1971. On August 1, 1977, Ruby McElhaney sold the business to C&C Oil of Huntington, at which time a storage shed was built at the 461 E. First Street location, the residence of Ron and Bonnie Boxell. Once C&C Oil bought Mac's Oil, Ron ran the fuel route, and Bonnie ran the office out of their residence. By this time, Little Ron was growing up, so whenever anyone would call and ask for Ron, they would be asked if they wanted to speak with Big Ron or Little Ron. Even with the change in ownership, the Company was still know as Mac's Oil, in honor of it's founder, Harry (Mac) McElhaney.

When Ron and Bonnie look back through the years, they recall some of the great challenges with the fuel business. One of the most challenging was during the Blizzard of 1977/1978. During this time, there were snow plows stationed in the Warren area, and when Ron and Bonnie would receive a call for an emergency fill, they would get a snow plow escort to the location in need. This was a very challenging winter, one that will probably never be forgotten.

Things went well for several years, then in April of 1982, Big Ron had to have quadruple heart bypass surgery. Big Ron's surgery went well, but due to a few setbacks and due to this being an uncommon surgery at the time, Ron was unable to return to work until October of 1982. During this time, Big Ron and Bonnie were blessed with great family and friends that worked to keep the fuel tanks filled while Big Ron recovered. A great number of people helped out, but Ronnie (Little Ron), the oldest son of Ron and Bonnie, Dave Surfus (Bonnie's brother), and Danny Spahr, provided the greatest manhours and support, as they drove the bulk truck and delivered the fuel. The business could have never survived without the assistance of these individuals!

C&C Oil maintained ownership of Mac's Oil Company until 1998, when the service stations were sold. When the stations sold, the ownership of Mac's Oil was transferred to Ken Brumbaugh, and Alecto Inc., but doing business as Mac's Oil Company.

The program is open to all students who will have graduated from an accredited Indiana high school by the end of June 2005 and who have been accepted to a full-time baccalaureate course of study beginning in the fall of 2005 at an accredited Indiana public university or private college.

The program is also open to non-traditional applicants - those who have graduated from high school prior to June 2005, are not currently enrolled in a post-secondary education institution and who have not earned more than 30 credit hours toward a four-year degree.


