## THE SPECIAL CONSENSUS

This group will be playing August 14th at 2 pm in the Applegate Chapel of the United Methodist Memorial Home as another program in the Fine Art Series.

*"A bluegrass band hip enough to play to the snottiest audiences, loaded with high octane, punch and vigor and fueled with emotion and passion." --- Midwest Record Recap*

The Special Consensus is a four member acoustic bluegrass band that began performing together in 1975. The first band album was released in 1979 when the band began touring on a national basis, and the second was released in 1983. In 1984, The Special Consensus initiated the Traditional American Music (TAM) Program in schools across the country and began appearing on cable television and National Public Radio shows. The band has since appeared on The Nashville Network's Fire on the Mountain show, toured for three seasons as 4/5 of the cast in the musical Cotton Patch Gospel (music and lyrics by Harry Chapin), and released nine additional recordings. Songs from the 1998 "Our Little Town" release appeared on the National Bluegrass Survey chart in Bluegrass Unlimited and on the Gospel Truths chart in Bluegrass Now. A video production of the TAM Program, sponsored by the Northern Indiana Bluegrass Association, was honored by being archived at the International Bluegrass Music Museum in Owensboro, Kentucky. In 2000, Pinecastle Records released the first band performance video, filmed for Iowa Public Television's "Old Time Country Music" show, and The Special Consensus "25th Anniversary" recording to mark this milestone year for the band. This twenty song recording, which includes eight selections from previous now out of print band recordings, received a Highlight Review in Bluegrass Unlimited. International tours have brought The Special Consensus to the British Isles, Canada, Europe, Ireland and South America. In 1993, the band performed the first of many concerts with symphony orchestra, complete with orchestral arrangements of songs from the band repertoire. The Special Consensus is included on the touring rosters of the Illinois Arts Council (Artstour program), the North Dakota Council on the Arts, and the Heartland Arts Fund and continues to participate in the Arts Midwest Performing Arts Touring Program.

The Special Consensus repertoire features original compositions by band members and professional songwriters (such as "Our Little Town", "Green Rolling Hills" and "Margarita Breakdown"). The repertoire also includes traditional bluegrass standards (songs by Bill Monroe, Flatt and Scruggs, Jim and Jesse McReynolds, etc.) and songs by artists from other musical genres (such as "I'm No Stranger To The Rain" as recorded by Keith Whitley and "Blue Skies" by Irving Berlin). As a result of this musical diversity, The Special Consensus has performed at the most traditional bluegrass festivals and has also been the band to bridge the gap between traditional and progressive bands at more diverse festivals and fairs.

## MY FAVORITE YEAR

What a magnificent performance. I hate to admit it, but I had a tear in my eye at the end. I won't give away the show but suffice it to say that the Pulse Opera House cast has done it again. Everyone on the stage, and those behind the scenes, did a wonderful job pulling this production together.

At the beginning of the show, Cynthia Smyth-Wartzok, the director, asked who had ever seen the show before. As no one had, she informed us that we were in for a real treat. She was right.

Ten or 15 years ago this production was made into a movie with one of the lead characters played by Peter O'Toole. It was reported that August 2 was Mr. O'Toole's birthday and the show that evening was for Peter. (He would have been proud of the way the actors and actresses performed.)

The show has several scenes and one intermission, and keeps you entertained throughout. The music is wonderful and the acting superb. The scenes with everyone on stage were wonderfully choreographed. (How do they get that many people on that small of a stage and not make it look crowded?)

The seven year old sitting next to me told me her favorite scene was when "that lady tied that guy to the pole. It was funny." (You'll have to go see it, to see what she was talking about.) The nine-year old on the other side liked "Rookie - he was cool".

There is a little bit of everything in this show, swashbuckler's, slow dancing, comedy, drama, lots of singing and more. It's a definite "Must See."

Congratulations to the cast and crew for another "Well Done" performance.

### ATKINS HAS A POINT ON DIET, WEIGHT LOSS

According to the Journal of the American Medical Association, there is really nothing special about the high-protein, low-carbohydrate diet promoted by Dr. Robert Atkins. It works, they say, because people eat less in general and eat fewer snacks.

The Atkins people say that severely limiting carbohydrates results in metabolic changes. With the higher metabolic rate, dieters lose weight faster than they would on a traditional diet. Further, they say carbohydrates cause increases in insulin levels that lead to hunger and weight gain.

Their program encourages dieters to eat all the meat, bacon, cheese, butter, and other high-fat foods that they want. Particularly in the early stages of the program, participants are advised not to eat fruits, vegetables, and breads including whole grain varieties.

The surprising news is that after following the diet for more than six months, Atkins dieters not only lose more weight than people on other diets, but they appear to be healthier as well. They have better blood pressure and cholesterol readings than those on a conventional diet.

All diets are about finding the most reliable way to restrict calories, say doctors at Harvard Medical School. The Atkins diet does this by reducing carbohydrate consumption. It's effective because so many nutritionally poor carbs are marketed today.

The doctors say a moderate amount of fat in the diet may aid weight loss because it makes food more satisfying and filling. People eat less at meals and eat fewer snacks.

The Harvard doctors say their version of the Atkins diet would exchange steak and bacon for fish and fresh vegetables sauteed in olive oil and whole-grain bread on the side.

Whichever plan dieters decide to follow, one thing is now clear. Protein is OK for dieters, and some fat probably is too.

## WALK FOR CHILDREN

Ambassadors for Children volunteer and Ambassador Travel Director Adam Corya will make a journey from Washington DC to Monu-

ment Circle in Indianapolis - but not in the air ... ON FOOT! Sleeping in a tent and the occasional budget hotel, Corya will take US Highway 50 across Virginia, the edge of Maryland, bear-infested West Virginia and Ohio. He will then walk on Highway 52 into downtown Indianapolis to arrive on September 19th.

Walk to Benefit Indianapolis Child and Children Around the World. The AFC Walk for Children will raise funds for Ambassadors for Children, a non-profit charitable organization that offers global volunteerism opportunities to individuals and families through the Ambassador Travel Club. Half of the funds raised will be used locally to help Kyra, a five-year-old Indianapolis girl who was severely injured in a car accident in January of this year and whose family faces mounting medical expenses. The remaining proceeds will go to fund upcoming AFC missions.

Inspired when stuck in Chicago on a rainy Sunday night with no flights to Indy available, Corya rented a car to drive home. A short time later, in the warm, dry, rental car, Corya pondered, "What if I had no shelter from the elements. It was then I decided to walk for the children."

Kyra's Story.

Kyra was involved in a motor vehicle accident sustaining injuries to her spinal cord and head, as well as her abdomen, and was hospitalized locally before being transferred to St. Vincent's Pediatric Rehab Center for several months of intensive rehabilitation. Kyra's cognitive skills have significantly improved and she is able to take all of her meals orally, although the spinal cord injuries have left her a paraplegic. With the strength of her family and her own courage, Kyra continues to improve.

"I commend Adam Corya and Ambassadors for Children for their compassionate, servant-hearted approach to helping children around the world," said U.S. Congressman Mike Pence. "Adam's walk from Washington, DC to Indianapolis is an example to us all of how we need to continuously put the interests of others before our own."



## AREA NEWS CONTINUED

### COUNCIL NOTES

President Harold Jones conducted the July 28 meeting of the Warren Town Council. The meeting was held in the Town Hall Annex and opened at 6:30 p.m. with all in attendance repeating the Pledge to the American Flag.

Minutes of the regular meeting of July 17 were approved as submitted.

A Public Hearing was held concerning the closure of a portion of Hendricks Street. There were no public comments so Ordinance 2003-1 was introduced to vacate a portion of Hendricks Street.

In a report on the Wastewater Project update, a Progress meeting was set for 9:30 a.m. July 29.

Change Order No.6 concerned contract B and the Wastewater Plant, in the amounts of \$5,012 and \$3,510 were approved by Council.

Council also approved change order No.2, Contract A-1 and A-2, in the amount of \$18,361.31 decrease project cost.

Paper work continues for the Centennial Tower Project as legal documents have been sent.

Execution of USDA-RD Grant has been awarded in the amount of \$17,920 for a Fire Department vehicle. Council signed Grant papers with Rural Development. The total cost of the truck is \$51,200. The remaining cost will be split between the Town and Township.

Council agreed to pay an invoice to General Plastics in the amount of \$650.00 as part of the Warren area Chamber and Town Christmas lighting project. Sale of memorial bows by the Chamber at Christmas time will be used to cover the remaining \$2614.00.

Fire Extinguisher quotes had been received from Thompson Fire. It was decided to compile a complete list of extinguishers needed before a decision is made.

Council approved a request to close Nancy Street between First and Third Streets on Aug. 16. At that time a Back to School blowout sponsored by National City will be held.

It was announced John Spidal Jr. will represent Butler Fairman Seufert as contact person for the Streetscape project. He will be meeting with Council soon.

Council allowed a request for

\$334.97 due to an underground leak over a two month period and filling a pool.

A second request granted was due to a water leak outside of the sewer system as it was in a yard and verified by a local contractor.

Another request for sewer credit was denied as there was no evidence that the water did not enter the sewer system.

A Copier Maintenance Contract with ABM was approved.

Indiana Downtown Roundtable was announced for Aug. 6 at 5 p.m. in Warsaw. Approval was granted for four people to attend.

Council agreed to a request from United Methodist Memorial Home for mosquito spraying. Cost will be a minimum \$50 per spraying event and based on number of gallons used.

A Loss Control Seminar with IPEP was announced.

Further inventory of certification of Road Miles is expected.

There is a need to apply for Land Application and Permit Application. Council agreed to purchase more mosquito spray.

Darrel Bice reported from the Utility/Street Departments. He said there have been problems at the lift stations, with only one pump in operation at both sites. He was asked to get quotes for new pumps.

Status of the McAllister Maintenance was uncertain at this time.

Bice asked permission for four employees to take tests for Water Licensing at a cost of \$30 per test. Tests are to be taken by Nov. 14. Decision delayed pending further information.

Fire Chief Tim Ford reported the truck being purchased by the Fire Department costs more than originally thought. Council asked that the cost remain as close to the \$51,000 originally estimated as possible by making adjustment to add on equipment.

There will be an IACT Conference in September.

Council meetings will be held Aug. 11 and 25.
