FALL TAX INFO

November 10th is fast approaching. In order to accommodate taxpayers, the Treasurer's Office will be open, Saturday, November 5th from 8 a.m. until noon. Other regular hours are Monday thru Friday, 8 a.m. to 4:30 p.m. You may also pay at all local banks. If mailing your payment, the postmark must be Nov. 10th to be considered on time payment.

If you wish to pay by credit card, those payments are not taken at the office, however, you may call 1-800-272-9829. It is automated and you will need a Jurisdiction Code 2421, enter each parcel number that you have and the amount you are paying. At the end of the call you will be given a Confirmation Number that registers your call. Be sure to write that down, in case there would ever be any questions later. There is additional fees charged by the credit card company for processing that run about 3%.

Our office will close November 11th for Veteran's Day and will be closed to the public for several days to process on time payments and to close our Accounting Books for 2005. There is a flat 10% penalty for all late payments.

Feel this remarkable effort should be published, so will send the facts and leave it up to your discretion as to how it should be presented. When the USS Salamonie men came to Warren and I met John, they were so impressed to learn the Real Elegant Dames (my Red Hatters) were sending boxes to Iraq, they adopted us and offered to pay our postage. He also provided a list of names, something I was unable to find here, having gone to the Armory, Tom Applegate, etc. etc. After publishing this in their paper, checks poured in from about every state in the union from members of their association. I found the following churches willing to adopt some of the men: Asbury Church adopted 17, the S.O.S. group at the Methodist Church took 25; the New Beginnings Worship Ctr. Church of Huntington (as represented by our Lily Saner) took 20 names. John told me "our boys" were coming home and the shut-off date for mailing was today. So a grand total of 238 boxes have gladdened the hearts over there (that includes 2 names I gave to a friend in Las Vegas). Of that figure, 140 were sent by Warrens' Red Hatters. The frosting on the cake was the final postage on all the boxes was carried by the gallant men of the USS Salamonie Association. I feel so blessed to have been a part of this outpouring of love and appreciation to our troops. God bless America...

Without the support of local community leaders this program would not be possible.


BOOKS STILL AVAILABLE

YOUTH NEEDED

Youth needed for unique program to support National Guard and Army reserve youth and families

The global war on terrorism has changed the face of military service for those in the US Army Reserve and National Guard. Mobilization and deployment are at all-time high levels. One of the issues facing military youth and families is the lack of community awareness of the unique stressors and challenges they face during times of conflict and war.

This lack of understanding by the general public can make military youth feel isolated and misunderstood.

Speak Out for Military Kids (SOMK) is an educational program designed to raise the awareness of issues facing military families. The purpose of SOMK is to create a type of speaker's bureau involving students in grades 7-12 who can share the message of military families with groups in local communities such as schools, service organizations, 4-H groups and others. Team members will prepare spoken, written and electronic messages to be shared with individuals and groups. Through this program, youth are trained to help present messages for communities to better understand the struggles and challenges faced by families with a loved one in military service. SOMK participants will include a mix of youth with and without military backgrounds.

A statewide training for youth interested in SOMK program will be held Friday, December 2 through Saturday, December 3 at the Muscatatuck Urban Training Center in North Vernon, Indiana. There is no cost for youth to participate in the training, other than transportation to and from the training site. SOMK is spon-

sored and chaperoned by the Indiana Operation: Military Kids (OMK) Team, the 4-H Youth Development Program of Purdue Extension Service and the Indiana National Guard Family Programs Office.

Youth interested in learning more about this training may contact the local Purdue Extension - Huntington County Office at 260-358-4826. The office has copies of additional information about the Speak Out for Military Kids program and training session.

CLUB VOLUNTEERS NEEDED

There is also a need for individuals to share their talents with youth by assisting with project work and serving as a resource as 4-H members gain knowledge and skills through their project work.


