#### OCTOBER IS LIVER AWARENESS MONTH LIVER DISEASE IS A LITTLE-KNOWN RISK OF OBESITY

Experts say that people watching their weight should also be watching their liver.

Most people know that losing weight lowers the risk of heart disease and type 2 diabetes. The risk of a lesser-known, but highly important obesity-related disorder, can also be lowered through weight loss.

It is known as nonalcoholic fatty liver disease (NAFLD). A surprising 25 percent of American adults have it. It is the most common liver problem in the U.S.

The disorder is marked by elevated liver enzymes and fatty deposits in the liver in the absence of excessive alcohol consumption. About 15 to 20 percent of these people ultimately develop inflammation and scarring of the liver. Advanced scarring (cirrhosis) is irreversible, according to Johns Hopkins Medical Centers.

A body mass index greater than 30 is strongly associated with NAFLD. Overweight people who tend to store fat around the abdomen, rather than around the hips, are at greater risk. Type 2 diabetes also increases the risk of NAFLD.

A diagnosis of NAFLD is generally easy. Doctors check the blood during routine blood work for elevated liver enzymes, which may be the first indication.

The American Gastroenterological Association (AGA) recommends gradual weight loss of one to two pounds per week through calorie restriction and increased exercise. A loss of about 10 percent of body weight has proved beneficial in lowering elevated liver enzymes and fatty deposits.

of Warren, Indiana, that on the 25th day of October, 2005, in the Council meeting room in the Town's Assembly Hall located at 131 Wayne Street in Warren, Indiana; starting at 6:40 p.m. there will be a public hearing on the matter of whether to adopt, certain proposed changes in the rates and charges of the Town's water

Increases in the presently existing and effective rates are being proposed to begin to address a situation which the Town Council believes exists, namely that the existing rates and charges are too low and are insufficient for the Town to properly operate and maintain it's water works utility.

At a duly called and held Town Council meeting on October 11, 2004, Ordinance No. 2004 was introduced and is presently under consideration. That Ordinance, exclusive of the whereas clauses, recitals of adoption, and proposed signature block, reads as follows:

"Now, therefore, be it ordained by the Town Council of the Town of Warren, Indiana, in meeting duly assembled, that the presently effective schedule of this Town's waterworks' rates and charges to its water customers as set out in § 52.50 of the Warren Code of Ordinances ("Code") should be, and that Code § is hereby, deleted and replaced by the following:

"§ 52.50 Service Rates and Charges

Rates and charges for the use of and service rendered by the waterworks system of the Town, based upon water availability and/or the receipt of water supplied by that waterworks shall be as follows:

(A) Metered rates.

Metered Rates Per Monthly Billing Period & Per 1,000 Gallons

First 3,333 \$4.68, Next 10,000 \$3.91, Next 10,000 \$2.75, Over 23,333 \$1.94.

(B) Minimum charge. Each user shall pay a minimum charge in accordance with the following applicable size of meter installed for which the user will be entitled to the appropriate quantity of water computed in accordance with the above schedule of rates.

Size of Meter and Minimum Monthly Rate: 5/8 to 3/4-inch \$15.56; 1-inch \$23.35; 2-inch \$77.81; 3-inch \$181.55; 4-inch \$559.92.

- (C) Hydrants Each municipal/private hydrant \$418.29 per annum
- (D) Sprinkler systems Connection Size - Per Annum

2-inch \$85.80; 3-inch \$157.30; 4-inch \$286.00; 6inch \$643.50; 8-inch \$1,144.00

(E) The rates and charges fixed above shall apply to individual customers; they shall not be construed to permit multiple customers being served through one meter, except as expressly authorized in advance in writing by the Town Council."

Be it further ordained that all ordinances, parts of ordinances, and Code provisions in conflict herewith are repealed; provided, however, that the existing schedule of water rates and changes as set out in that § 52.50 shall remain in full force and effect until the first monthly billing period commencing following the adoption of this Ordinance."

At that public hearing which will address considerations related to the proposed adoption of that Ordinance, all persons whose interests are affected thereby are urged to attend and state their objections, if any.

Minutes of the regular meeting of Sept. 13 were approved as submitted.

Council adopted Ordinance 2004-14.

Town employees had been busy getting the grounds ready at the Scout Cabin for the annual Scout Camporee planned for the weekend. Many activities were scheduled to be held at the Salamonie School as well.







#### **Tooth Wear What Causes It?**

Funded primarily by the federal government, the Family Caregiver Program was established on a nationwide basis by the Older Americans Act Amendments of 2000 to give family caregivers access to the resources and services that make their jobs a little easier. It is, essentially, a clearinghouse that connects people caring for family members older than 60 with information and community assistance, like peer support, adult day care, and home health assistance.

The program also offers a respite care fund to provide temporary relief for family caregivers who must take a break to tend to their own medical needs or family issues. Finally, it offers supplemental services, on a limited basis, to complement the care provided by caregivers. A supplemental service might be legal assistance in drawing up essential documents, setting up family counseling, purchasing a shower chair, or paying for an emergency response system.

The Family Caregiver legislation was enacted largely as a result of the Census of 2000, which showed just how rapidly the American population is aging and what its needs are. Family caregivers, traditionally, have been the mainstay in long-term care for older Americans. Research indicates that only five percent of noninstitutionalized people needing assistance rely exclusively on paid services. The rest depend on family and friends to some degree.

The experts on services for the elderly with the Family Caregiver Program are in tune with the needs of family caregivers. Whether the need is big or small, they can provide a wealth of assistance and support to make life just a little easier for family caregivers in northeastern Indiana.
