FIREWOOD RULES

As camping season approaches, visitors to DNR properties should prepare for the new DNR firewood rule that takes effect Saturday (March 17).

The Indiana Natural Resources Commission approved a similar firewood policy last year but adopted it as a permanent rule in January.

The new rule helps protect forests from the 140 known pests and pathogens that currently affect forests. The pests and pathogens are transported from place to place primarily through the movement of firewood.

Under the rule, in-state visitors to state parks, reservoirs, state forests and state fish & wildlife areas can bring firewood from home as long as the bark has been removed. The reason for bark removal is insect larvae live in the sapwood under the bark. Visitors from outside Indiana

cannot bring firewood from out of state because of federal emerald ash borer quarantines.

Guests may also bring firewood into DNR properties, if it is:

- Kiln-dried scrap lumber.
- Purchased outside the property and bears either a USDA compliance stamp or a state compliance stamp. <<http://www.in.gov/dnr/entomolo/6413.htm#usda>>
- Purchased from the property campstore or on-site firewood vendor and has a state compliance stamp.

Regardless of where visitors get their firewood, they should burn it all at the campsite before they leave.

In short, the firewood rule means: "Buy it with a stamp, bring it debarked, burn it all."

The rule gives DNR staff the ability to confiscate firewood that does not comply, and gives Indiana Conservation Officers the authority to write a warning or citation for violations, with potential fines up to \$500 plus court costs.

WARM WINTER - MORE PESTS?

The warmer weather has certainly brightened moods. Folks are spending time outdoors. A common response to the favorable weather is, "Well, this is too good to be true for mid-March and we'll pay for it somehow!"

So, will there be an increase in insect and other pest populations due to the warmer winter and spring weather?

One example of a pest that is

appearing in homes now that temperatures have warmed up is the Asian Lady Beetle. There are many reports of these bugs being a nuisance. Some have said they've been pinched by the bugs while working on an outside project or even while sleeping at night. Smashing these critters between your fingers also causes a terrible odor.

The Asian Lady Beetles can multiply in great numbers. However, the warmer than normal 2011-2012 winter weather does not necessarily mean that populations now are higher than in a normal weather year.

As Tim Gibb, a Purdue Extension entomologist, says (Purdue Extension Publication E-214-W) about Asian Lady Beetles: "Clusters of several hundred to thousands in living rooms, bedrooms, or kitchens are not uncommon. It almost appears that there are more beetles at this time of year that there were in the fall. Rest

assured, however, that the beetles have not increased in number over the winter months. Beetles have merely concentrated and shifted indoors."

Other entomologists discussed that social insects (termites and ants) are swarming earlier than normal (warm, sunny days after a rain—usually). When this occurs, it is possible that April and May swarms of these insects may be fewer in number.

Rick Foster, Purdue Extension entomologist, recently summarized the current situation with insect populations in a discussion with county Extension educators. As Foster noted:

Some insects such as flea beetles are directly impacted by cold winter weather. Mild winters such as the one we just experienced will result in greater survival and higher populations of insects.

Many insect species are very well adapted to winter weather and will survive just fine no

matter how cold it is.

Most insects have an amazing ability to reproduce in large numbers and, if spring and summer weather is conducive, will be able to develop to serious population levels no matter how many survived the winter.

Some of our pests overwinter indoors and others overwinter in the South, so our winter weather has little effect on their populations.

The entry fee is \$20 per child and there will be no candy/fundraiser activity.

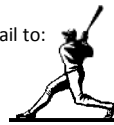

She was preceded in death by two brothers: Winfred "Tuffy" Davis and Hayes Davis.

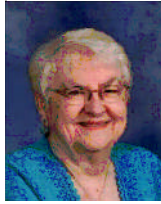

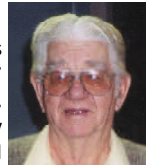

MOVE OVER APPLES: FOR SOME PATIENTS, AN ASPIRIN-A-DAY MAY KEEP THE DOCTOR AWAY

(ARA) - The statistics are staggering: As the leading cause of death in the United States, cardiovascular (or heart) disease accounts for more than 2,200 deaths per day, or one every 39 seconds. Furthermore, the American Heart Association (AHA) and Centers for Disease Control and Prevention currently estimate that every year about 785,000 Americans will have their first heart attack, and another 470,000 will have a recurrent attack.

Adults should know how they can avoid becoming a statistic of heart disease. For many, knowing the leading risk factors and maintaining a heart-healthy lifestyle will go a long way. And for a number of patients, talking to their doctors about low-dose daily aspirin therapy may be the "heart-smart" thing to do.

"You should never start aspirin therapy on your own," says cardiologist Prerana Manohar. "If you feel that a daily low-dose aspirin regimen may make sense for you, be sure to talk with your doctor about its benefits and risks."

Q: My friend says she gets Extra Help paying for her Medicare prescription costs. I have not been able to afford all of my prescriptions lately and wonder if I qualify too.

A: If you meet certain income and resource limits, you may qualify for Extra Help from Medicare to pay the costs of

Medicare Part D drug coverage. Some people with limited income and resources are eligible for the "Extra Help" program to pay for the costs associated with a Part D prescription drug plan. These include monthly premiums, annual deductibles, and prescription co-payments.

You may qualify if you have up to \$16,755 in yearly income (\$22,695 for a married couple) and up to \$13,070 in resources (\$26,120 for a married couple). If you are denied because you have too many assets or only receive partial help, you could qualify for drug plan premium assistance from the State Pharmaceutical Assistance Program, Hoosier Rx.

Drug costs in 2012 for most people who qualify will be no more than \$2.60 for each generic/\$6.50 for each brand-name covered drug. Other people pay only a portion of their Medicare drug plan premiums and deductibles based on their income level. You would also qualify for help paying your Part B premium, but you would need to apply for the Medicare Savings Program.

THREE TIPS FOR EXTREME HOME ENERGY SAVINGS

(ARA) - Homeowners expect to get a bill from their utility company each month, but opening one for a particularly expensive month can be a real shocker. Consider these home improvement solutions to take a huge bite out of your energy bill:

Tip 1: Assess the roof
A radiant barrier, such as Enerflex, reduces heat transfer between your roof and the attic floor where insulation is typically installed. Enerflex can reflect up to 96 percent of the radiant heat energy from the sun back through your roof, making your attic space, and therefore home, cooler.

Tip 2: Look for leaks
There are various ways to check for window and door leaks, from holding a candle flame near the crack and gauging how much the flame moves to sliding a piece of paper through the opening to see if it catches or tears. If you find a leak, the easiest solution is to add weather-stripping around doors and to caulk windows.

Tip 3: Swap the bulbs
Consider this: homes that use Energy Star-qualified light bulbs use about 75 percent less energy than traditional incandescent bulbs and they last at least six times longer.

Have you had a colonoscopy?

If you're age 50 or over and haven't had a colonoscopy, you probably have your reasons. But none of those reasons can outweigh the simple fact that regular colon cancer screenings can save your life. A colonoscopy is virtually painless and is done in less time than your favorite TV show. In truth, the only thing to fear about a colonoscopy is not getting one early enough.

Talk with your primary care doctor about your risks. If you're 50 or older and haven't had a colonoscopy or haven't had one for at least 10 years, schedule one. It is one of the easiest, most important things you can do to protect your health.

The American Cancer Society recommends both men and women get a sigmoidoscopy or colonoscopy every 10 years beginning at age 50. You should discuss with your doctor about your health and family history so that you can choose the best screening option for you.
