## COMMITTEE MINUTES

The "Our Town" Committee meeting held May 14, 2002 commenced with a brief presentation by Joann Green of Claire Bennett Associates and Nelsen Steele of Butler Fairman Seufert to showcase landscape architecture projects completed for other communities in Indiana.

Warren has applied for a Transportation Enhancement Grant (T-21) to improve the appearance of our downtown area and Mr. Steele reported that a decision should be made by Fall 2002, however, he expects the decision might come earlier this year. Key elements of the landscape project could include new asphalt, and sidewalks (possibility of poured concrete stamped brick). Street lighting (period lighting in downtown area and to civic center), benches, and signage were also key elements that were discussed.

Ms. Green said that CBA is presently working in Terre Haute and Cumberland, Indiana. Ossian and Aurora are evaluating development proposals. Ms. Green stressed the importance of enhancing Warren's architecture as a dominant feature.

Both Ms. Green and Mr. Steele said that the "Our Town" committee's work with Hyett/Palma and our grant proposal preparedness should be helpful in terms of approval. They both recommended that Warren citizens call their legislators to support the improvements the committee is trying to initiate via the grant.

The finance committee had nothing to report at this time. The programs committee will work with the local Kiwanis to discuss a monthly Sunday lunch program sponsored by local non-profit organizations (including the "Our Town" Committee). The committee motioned and seconded that we support this endeavor. There were no reports from the PR Committee or the Auditing Committee

"Through the course of our Nation's history, more than 41 million Americans have served the cause of freedom, and more than a million have died in its name.

"On this noble American holiday, honor the men and women who gave their lives in service to our nation. We honor those generations and individuals who fought for liberty and in defiance of tyranny that this unique experiment in self-government might long endure."

"At a bridge at Concord, in the muddy trenches of Europe, the rugged mountains of Korea, the dense forests of Asia, or across the burning sands of the Persian Gulf, America's heroes have advanced democracy around the globe and defended the liberties we hold dear."

"We honor the final sacrifice of our service men and women by dedicating our own lives to peace and the defense of freedom. For these ideals they fought, and for these ideals we continue to strive."

## MEMORIAL DAY HONORS

## MEMORIAL PROGRAM

The Huntington County Memorial Day Program will be conducted Monday night, May 27<sup>th</sup>. The program, which begins at 600p.m., will be held at the First Church of the Nazarene, 1555 Flaxmill Road, Huntington.

This annual ceremony, sponsored by the Huntington County Veteran's Council and supported by funds appropriated by both Huntington County and the City of Huntington, honors all veterans who have passed away, but will focus on those who passed away in the year 2001.

The program opens with an invocation followed by the Pledge of Allegiance and the National Anthem. This year, survivors of the 136 Huntington County' veterans who passed away in the year 2001 will be presented with special personalized certificates. Most families will also receive

Presidential Memorial Certificates signed by the President of the United States.

## WARREN COUNCIL

The May 13 meeting of the Warren Town Council was held in the Town Hall Annex. At 6:30 p.m. president Harold Jones called the meeting to order with all repeating the Pledge to the American Flag.

Minutes of the regular April 28 meeting and a May 2 Executive session were approved as submitted.

Jeff McCoy, representing Troop 122 of Boy Scouts told Council of plans being made for the local Troop to host a Fall Jamboree. This would be held in October at the Boy Scout Cabin grounds. Attendance could include more than 100 Scouts.

Scouts and Cub Scouts have expressed their appreciation to Council for their help in providing upkeep of the Scout Cabin.

Prior to the Council meeting, the Park Board met. David Scheib reported he would meet on Wednesday morning with one of

the summer girls to work at Tower Park.

Council voted in favor of replacing bleachers on the South end with 28 ft. aluminum bleachers as previously purchased.

Ron Neff reported on televising of the wastewater project. Problems were found in several areas.

A wastewater meeting was held May 13 in the Annex. The next meeting is set for June 24 at which time bids are expected to be out.

## ANXIETY DISORDER

What mental health problem can affect people of all ages, including children? Anxiety disorders are the most common type of mental health disorder in children, affecting as many as 10 percent of young people.

Similarly, about 4 million adults

have an anxiety disorder during a year's time.

During one of America's most recognized health observances, Mental Health Month, the Mental Health Association in Indiana, Inc., and its 60 local chapters will be working with other groups to increase awareness and understanding of mental illness.

## Know the Facts

Anxiety strikes people in childhood and adolescence but can also begin in adulthood. Anxiety affects women more often than men. Research suggests that anxiety may run in families. In addition, anxiety often exists with depression.

"Anxiety disorders are more than just nerves. They are characterized by feelings of fear, panic and discomfort that arise with no clear cause, in situations that are not usually stressful or dangerous," said Stephen C. McCaffrey, President and CEO of the Mental Health Association in Indiana.

All children experience some anxiety, this normal and expected. For example, when left alone at preschool for the first time, many children will show distress; a young child with his or her own room may develop a fear of the dark. McCaffrey says anxiety becomes a problem when it interrupts a child's normal activities like attending school and making friends.

Anxiety Disorders Most Common

In Children

Generalized Anxiety Disorder affects children when the child has recurring fears and worries that they find difficult to control. They worry about everything from school to sports and may be restless, irritable, tense or tired with trouble sleeping or concentrating.

Children with Separation Anxiety Disorder have intense anxiety about being away from home or caregivers to the point that social or school functioning is affected. When they are apart, the child may worry about the parents; when they are together, the child may "cling" to the parents. Nightmares and physical symptoms such as stomachaches and headaches are common.

Social Phobia usually emerges in the mid-teens, and typically does not affect young children. Those affected with this disorder have a constant fear of social or performance situations and are continuously afraid of being embarrassed in these situations. Fear, coupled with physical symptoms like sweating, blushing, heart palpitations, and shortness of breath are hallmarks of the disorder. McCaffrey notes that typically, adolescents cope by avoiding the feared situations like dating, but may show confidence in school and work situations.

Other anxiety disorders that may

"Anxiety disorders are treatable," McCaffrey said. "When early identification, diagnosis and treatment occur, children and families can reach their full potential. A comprehensive treatment plan, developed in collaboration by the child (when possible), parents, and mental health professional, may include psychotherapy, behavioral therapy and/or medication."

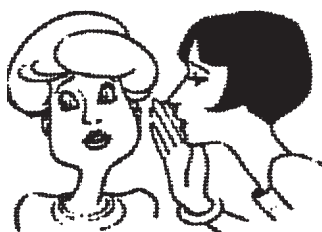

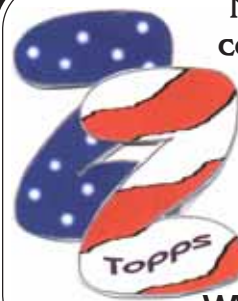
